

COMMERCIAL BINGO ENDORSEMENT APPLICATION INSTRUCTIONS

Effective October 1, 2025, ABCA can begin processing and issuing Commercial Bingo endorsements to on-premises alcohol retailer license holders. This new endorsement will allow on-premises retailer license holders to offer commercial Bingo, including paper formats, or electronic representations.

Of Note

Board Orders and Settlement Agreement terms apply and may affect eligibility.

Valid Period and Fees

The cost of a Commercial Bingo endorsement is **\$300.** Licensed Retailers will still be required to obtain a license from the Office of Lottery and Gaming to offer commercial Bingo.
