If a medical cannabis business has more than one facility or licensed premises, the license-holder must pay the transfer to new location fee for each facility or premises that will be relocated.  ** Facility Capacity or Physical Plant Change fees apply any time a license-holder seeks to change or modify the medical cannabis business' cultivation or manufacturing capacity and move to a different cultivation production management tier or management capacity.  *** Transfer of Ownership Change fees apply any time an eligible license-holder seeks to transfer 50% or more of ownership interest in the license-holder to another person or entity</p>
