## STIPULATED LICENSE APPLICATION

## OVERVIEW

Allows eligible alcohol establishments to start business operations during the public comment period prior to the ABC Board approving or issuing a permanent license.

## ELIGIBILITY

On-premises retailers, manufacturers, and wholesalers are eligible.
Applicants must be at least 21 years of age. Board Orders and Settlement Agreements apply and may affect eligibility. Additional eligiblity conditions are detailed in DC Official Code Title 25: Alcoholic Beverage Regulation Administration and DC Municipal Regulations Title 23: Alcoholic Beverages.

If approved, the individual listed on the license is the only person that is permitted to pick up the license unless a written request is submitted in advance.

## FEES AND VALID PERIOD

Fees and valid periods vary. View the current schedule at abra.dc.gov/page/alcohol-fees.
A stipulated license expires when either a permanent license is issued or a protestant is granted standing at a Roll Call Hearing.

Accepted methods of payment include check, cashier's check, money order, or credit card. Checks must be addressed to the "DC Treasurer". An online payment link may be requested by emailing abc@dc.gov.

## INSTRUCTIONS

Complete and submit the Stipulated License Application with all required documentation. Enter " $\mathrm{N} / \mathrm{A}$ " if questions are not applicable. Enter "Attached" in fields requesting a document.
