



## STREATERY ENDORSEMENT APPLICATION

### OVERVIEW

Allows eligible alcohol establishments to sell, serve, and permit the consumption of beer, wine, and spirits on new or expanded temporary ground floor or street level outdoor public or private space not listed on its existing alcohol license in 2022 and 2023 between 6:00 a.m. and 12:00 a.m. daily.

### ELIGIBILITY

On-premises retailers, manufacturers with on-site sales and consumption privileges, and food retailers with commercial street frontage at the Walter E. Washington Convention Center are eligible.

Applicants must be at least 21 years of age. Board Orders and Settlement Agreements apply and may affect eligibility. Additional eligibility conditions are detailed in *DC Official Code Title 25: Alcoholic Beverage Regulation Administration* and *DC Municipal Regulations Title 23: Alcoholic Beverages*.

All applications are subject to a 45-day public comment period and approval by the Alcoholic Beverage Control (ABC) Board. Applications that are not protested are issued an endorsement within approximately 12 weeks if approved.

If approved, the individual listed on the license is the only person that is permitted to pick up the license unless a written request is submitted in advance.

### FEES AND VALID PERIOD

Accepted methods of payment include check, cashier's check, money order, or credit card. Checks must be addressed to the "DC Treasurer". An online payment link may be requested by emailing [abc@dc.gov](mailto:abc@dc.gov).

Complete and submit the *Streatery Endorsement Application* with all required documentation. Enter "N/A" if questions are not applicable. Enter "Attached" in fields requesting a document.
