agenda, I'm sorry, legal agenda is the Review of an Offer in Compromise in Lieu of a Hearing, dated January 5th, 2021, for Case Number 20-CC-00060, Barrel House Liquors, License Number 023984. And this again is an offer in compromise that's provided for the Board's review and acceptance. And the offer in compromise is as follows. For Charge Number 1, sale to minor, Statutory Authority, D.C. Official Code Section 25781, the fine is a \$3,000 fine to be paid within 90 days, or the license shall be suspended indefinitely until the fine has been paid.

Term 2 of the offer in compromise is that the license shall be suspended for ten days with four days to be served from January 25, 2021, through January 28th, 2021, and six days to be stayed for one year provided that there are no further violations in that time. In addition,

Respondent shall serve five day suspension from January 10th, 2021, through January 14th, 2021, which were activated from Case Number 19-CC-00128. Term Number 3, all employees who serve alcoholic beverages in the licensed establishment must complete an alcohol training program within three months from the date of the OIC which is today.

Charge Number 3, failure to take reasonable steps necessary to ascertain legal drinking age, Statutory Authority, D.C. Official Code Section 25783. This charge is dismissed. I therefore make a motion that the offer in compromise be accepted. Is there a second?
