CHAIRPERSON ANDERSON: And so since we're going to conclude our calendar, we will now do our legal agenda.

All right. The first matter on our legal agenda, it's Review of an Offer in Compromise in Lieu of a Hearing, dated January 4th, 2021, for Case No. 20-CMP-00074, The Cloakroom, License Number 087875. And the offer in compromise is as follows. Charge 1, operated outside of approved hours, Statutory Authority, D.C. Official Code Section 25723(b). The fine is a written warning.

For Charge 2, allowing employees or agents to engage in sexual acts or sexual conduct, Statutory Authority, D.C. Official Code Section 25823(a)(4). The fine is a \$2,000 fine to be paid within 90 days or license shall be suspended indefinitely until the fine has been paid. I make a motion that the offer in compromise be accepted. Is there a second?

21 in Lieu of a Gearing dated January 4th, 2021, for
22 Case Number 19-CC-00134 and 19-CC-00151 which is
23 the Towne Wine and Liquor, License Number 093813.

24 This case was actually on our calendar
25 today. Both parties appeared earlier today on a

1 calendar, and this matter was disposed on our
2 calendar. And there was an offer in compromise
3 that was accepted by the Board. So I'm not going
4 to do a formal vote on this agenda item on our
5 legal agenda, because it was already disposed of
6 in our calendar for today.

7 All right, the next case on our
8 agenda, I'm sorry, legal agenda is the Review of
9 an Offer in Compromise in Lieu of a Hearing,
10 dated January 5th, 2021, for Case Number
11 20-CC-00060, Barrel House Liquors, License Number
12 023984. And this again is an offer in compromise
13 that's provided for the Board's review and
14 acceptance. And the offer in compromise is as
15 follows. For Charge Number 1, sale to minor,
16 Statutory Authority, D.C. Official Code Section
17 25781, the fine is a \$3,000 fine to be paid
18 within 90 days, or the license shall be suspended
19 indefinitely until the fine has been paid.

20 Term 2 of the offer in compromise is
21 that the license shall be suspended for ten days
22 with four days to be served from January 25,
23 2021, through January 28th, 2021, and six days to
24 be stayed for one year provided that there are no
25 further violations in that time. In addition,

1 Respondent shall serve five day suspension from
2 January 10th, 2021, through January 14th, 2021,
3 which were activated from Case Number 19-CC-
4 00128. Term Number 3, all employees who serve
5 alcoholic beverages in the licensed establishment
6 must complete an alcohol training program within
7 three months from the date of the OIC which is
8 today.

9 Charge Number 3, failure to take
10 reasonable steps necessary to ascertain legal
11 drinking age, Statutory Authority, D.C. Official
12 Code Section 25783. This charge is dismissed. I
13 therefore make a motion that the offer in
14 compromise be accepted. Is there a second?
