1 P-R-O-C-E-E-D-I-N-G-S 2 2:14 p.m. 3 CHAIRPERSON ANDERSON: All right. The next case on our calendar is Case Number 19-251-4 5 00156, Le Diplomate, License Number 88243. Ms. Andrews, can you please elevate 6 7 the rights of the licensee for Le Diplomate? I 8 believe that is Mr. Steven Starr. I'm not sure 9 if he is being represented. 10 MS. ANDREWS: Sure, one second. Ms. 11 McLeod, your rights have been elevated. 12 CHAIRPERSON ANDERSON: All right. Ι 13 would like the parties to introduce themselves 14 for the record starting with the government. 15 MS. KRUPKE: Jessica Krupke on behalf 16 of the government. 17 CHAIRPERSON ANDERSON: Good afternoon, 18 Ms. Krupke. Ms. McLeod, if you have a camera can 19 you please turn it on, if not can you please 20 identify yourself for the record, please? 21 MS. MCLEOD: Sure. I do not have a 22 camera available. This is Melissa McLeod on 23 behalf of Le Diplomate Restaurant. 24 CHAIRPERSON ANDERSON: And can you tell me, Ms. McLeod, I can't see you and I don't 25

	know who you are
2	(Simultaneous speaking.)
3	MS. MCLEOD: Here I am, yes.
4	CHAIRPERSON ANDERSON: I am just
5	That's fine, but are you an attorney, are you
6	(Simultaneous speaking.)
7	MS. MCLEOD: Yes. I am the Vice
8	President and General Counsel for the restaurant.
9	CHAIRPERSON ANDERSON: I am not
10	familiar with you. That's the only reason I need
11	for everyone to let me know who they are so at
12	least I know who the person is and who they
13	represent.
14	MS. MCLEOD: Understood.
15	CHAIRPERSON ANDERSON: So thank you
16	for making that clear for me, please. All right.
17	Ms. Krupke, are there any preliminary matters in
18	this case?
19	MS. KRUPKE: Yes. We do have an offer
20	and compromise for the Board's consideration
21	today.
22	CHAIRPERSON ANDERSON: Okay.
23	MS. KRUPKE: So there are a total of
24	two charges. The first is that the establishment
25	provided live entertainment without the correct

endorsement in violation of D.C. Code 25-113(a)(d)(1). It's a primary tier violation and a first primary tier violation.

The offer and compromise is \$1000 payable within 90 days or the license shall be suspended indefinitely until the fine is paid.

And for Charge 2, which is that the establishment made a substantial change in operation by failing to obtain approval to provide for or expand the entertainment area in violation of D.C. Code 25-762.

This is a secondary tier violation and it's the first secondary tier violation. This charge would be dismissed as already encompassed under Charge 1.

CHAIRPERSON ANDERSON: All right.

Thank you, Ms. Krupke. Ms. McLeod, it is my understanding that there is an offer and compromise and the offer and compromise for Charge 1 is the fine of \$1000 payable within 90 days.

If the fine is not paid within 90 days the license will be suspended until the fine has been paid. Charge 2 is dismissed. Is this your understanding of the offer and compromise?

1	MS. MCLEOD: Yes, it is.
2	CHAIRPERSON ANDERSON: Is your client
3	aware that by accepting an offer and compromise
4	that they are giving up their right to a hearing?
5	MS. MCLEOD: Yes.
6	CHAIRPERSON ANDERSON: Is your client
7	also aware that by accepting an offer and
8	compromise that they are giving up their right to
9	appeal this matter?
10	MS. MCLEOD: Yes.
11	CHAIRPERSON ANDERSON: All right.
12	With this said I make a motion that the offer and
13	compromise of a fine of \$1000 payable within 90
14	days for Charge 1, if the fine is not paid within
15	90 days the license will be suspended until the
16	fine has been paid, and that Charge 2 will be
17	dismissed. Is there a second?
18	MEMBER CROCKETT: Ms. Crockett
19	seconds.
20	CHAIRPERSON ANDERSON: Ms. Crockett
21	has seconded the motion. We will now have a roll
22	call vote on the motion that has been properly
23	seconded by Ms. Crockett. Mr. Short?
24	MEMBER SHORT: Mr. Short. I agree.
25	CHAIRPERSON ANDERSON: Mr. Cato?

1	MEMBER CATO: Bobby Cato. I agree.
2	CHAIRPERSON ANDERSON: Ms. Wahabzadah?
3	MEMBER WAHABZADAH: Rema Wahabzadah.
4	I agree.
5	CHAIRPERSON ANDERSON: Ms. Crockett?
6	MEMBER CROCKETT: Rafi Crockett. I
7	agree.
8	CHAIRPERSON ANDERSON: Ms. Hansen?
