3 CHAIRPERSON ANDERSON: The next case in
4 our calendar is Case No. 24 CMP00045, High
5 Spirits, license number 127084. Mr. Orellano, can
6 you please elevate the rights of the licensee in
7 this case?

8 MR. ORELLANO: This appears to be all,
9 Chairman.

10 CHAIRPERSON ANDERSON: All right, thank
11 you. This matter then is scheduled for a Show
12 Cause hearing on February 12th at 10:30 a.m.

13 Ms. Hogan, the parties are required to
14 exchange documents and witnesses seven days prior
15 to the hearing. Failure by either side to
16 exchange documents or witnesses seven days prior
17 to the hearing. The board is empowered to prevent
18 that side from relying on documents and witnesses
19 that have not been disclosed.
