3 CHAIRPERSON ANDERSON: We are now at  
4 the end of our morning calendar.

5 And since we're at the end of our  
6 morning calendar, let's now address our legal  
7 agenda.

8 All right, the first matter on our  
9 legal agenda, it's a review of an Offer in  
10 Compromise in Lieu of a Hearing Date of January  
11 9, 2024 for Case Number 23-CMP-00073, Hiwot

19 The term is a \$4,000 fine to be paid  
20 within 30 days or the license shall be suspended  
21 indefinitely until the fine has been paid.

22 Charge Number Two, no ABC manager on  
23 duty, the section violation statutory authority  
24 D.C. Code Section 25701.

25 The term is a fine of \$2,000 to paid

1 within 30 days or the license should be shall  
2 be suspended indefinitely until the fine has been  
3 paid.
