CHAIRPERSON ANDERSON: All right. So the next case, the case at hand now that we have is Case No. 22-PRO-00054, Il Canale, License No. 83707. Good afternoon, Mr. Orellana. Can you please elevate the rights of the licensees, the attorney and the Protestant in this case?

MR. ORELLANA: Sure. John Uhar, your access has been elevated. Stephen O'Brien, your access has been elevated. Investigator Mikea
Nelson, your access has been elevated, and I have a Manalle Mahmoud.

CHAIRPERSON ANDERSON: Yes. She's with Mr. O'Brien's office.

MR. ORELLANA: Okay, perfect. That is all we have.

CHAIRPERSON ANDERSON: All right, thank you. Mr. Uhar, okay thank you. So let me have the parties identify themselves by the -- I would like the parties to spell and state their names for the record, starting with the licensee and its representative. Mr. O'Brien, I cannot hear you sir.

MR. O'BRIEN: How about now?

1 CHAIRPERSON ANDERSON: I can hear, but 2 I think you need to turn your volume up a little 3 bit more sir. All right. MR. O'BRIEN: How about now, Mr. 4 5 Chair? CHAIRPERSON ANDERSON: That's perfect, 6 7 thank you. Go ahead sir. 8 MR. O'BRIEN: Mr. Chair, a 9 housekeeping matter. I believe that the case number for this afternoon starts with 19 as 10 11 opposed to 22. 12 CHAIRPERSON ANDERSON: I appreciate 13 that, and I see the calendar. I have a statement 14 to make, and so therefore when I read -- I think, 15 veah. I believe that this case is going to be 16 19-PRO-00033. I think that's it, yeah. 17 you're correct, so but I have an opening 18 statement to make, and so I have the correct 19 case. 20 So we'll, I'll make sure that the 21 calendar is, the calendar is correct. So this 2.2 case is 19-PRO-00033. Okay, thanks. Thank you 23 sir, go ahead. 2.4 MR. O'BRIEN: Okay. Stephen O'Brien, 25 counsel for the licensee. S-T-E-P-H-E-N, O

apostrophe, B-R-I-E-N. I'm accompanied by my colleague, Manalle Mahmoud, M-A-N-A-L-L-E, M-A-H-M-O-U-D. Also present on in my office and on the screen are the principals of the licensee, Giuseppe Farruggio, spelled G-I-U-E -- I'm sorry, let me start again, G-I-U-S-E-P-P-E, last name Farruggio, F-A-R-R-U-G-G-I-O and Alessandro Farruggio, A-L-E-S-S-A-N-D-R-O.

Mr. Farruggio, could you move close to the table so that you're on the screen there?

Thank you.

CHAIRPERSON ANDERSON: Thank you, Mr. O'Brien. Mr. Uhar, can you please spell and state your name for the record and your relationship to this case?

MR. UHAR: My name is John Uhar, U-H-A-R. I am both an abutting neighbor, which would put me here under a protest, but I'm also a complainant, whose complaints have not been answered by ABRA.

CHAIRPERSON ANDERSON: So you're -you are -- this is a protest hearing and you're
the protestant in this case. Thank you. Ms.
Nelson, can you please identify yourself for the
record please? I can't hear you Ms. Nelson.

INVESTIGATOR NELSON: There. ABCA Investigator Mikea Nelson.

CHAIRPERSON ANDERSON: Good afternoon, ma'am. Okay. All right. So I stand corrected. The Board calls Case No. 19-PRO-00033, related to the renewal application filed by Il Canale, ABRA License No. 083707, located at 1063 to 1065 31st Street, N.W., Washington, D.C.

This case is not a full protest hearing, as noted in Board Order No. 2023-441. This case will solely address the remand order issued by the D.C. Court of Appeals on August 15th, 2023 in John G. Uhar v. D.C. Alcoholic Beverage Control Board, 20 AA-02 DC 23.

According to the Court's order, the present case is limited to further proceedings with respect to Mr. Uhar's claim that Il Canale's owner lacked good character because Il Canale made fraudulent misrepresentations in administrative proceedings. In particular, today's hearing will be limited to following as explained in Board Order No. 2023-598:

(1) Allegation 1. The allegation in the PIF alleging that the submission of a sidewalk cafe plan to DCRA was fraudulent. Uhar,

this came from Uhar Protestant Information Format 1, showing 12 seats at the bar where six are permitted, again in violation of DCMR 25-762.

Allegation 2. The allegation in Uhar Complaint No. 1, that the testimony of Mr. Farruggio, F-A-R-R-U-G-G-I-O, Mr. Farruggio on May 8th, 2016 in lines 7 through 19 of the transcript constituted fraud.

3, Allegation 3. The allegation in Complaint No. 3 is that the Applicant used the alleged use of a counterfeit occupancy permit since February 15th, 2015 in violation of D.C. Code Section 25-401 and 25-835.

Allegation 4. The allegation in Complaint No. 4, the allegation of using four counterfeit fence permits on the rear door of 1065 31st Street and the window on the front of 1065 31st Street on a date and time that has not been clearly identified in the complaint, in violation of Section 25-401 and 25-835, on the conditions that the date of the offenses be disclosed to the Applicant prior to the hearing.

If this occurs, I need -- I need the parties to let us know if this is not occurred.

If this is not correct, then we'll -- this

allegation will be dismissed under the D.C. APA. The Board further reminds the parties that unless otherwise stated, allegations of fraud will be generally viewed through the Bennett test, which generally requires a finding of fraud to be based on (1) a false representation, (2) in reference to a material fact, (3) made with the knowledge of its falsity, (4) with the intent to deceive an (5) action is taken in reliance upon the representation.

With these instructions of mine, the Board will proceed as follows. The Board will hear preliminary matters. The Board will then open the hearing for an opening statement by the Protestant on the issues outlined above, and then the Applicant, as this case picks up with the Protestant's case-in-chief based on the remand, the Board will then hear the Protestant's case-in-chief on the issues outlined above.

The Board will then permit rebuttal evidence by the Applicant and the Protestant, unless rebuttal is waived by the Applicant. The Board will then hear closing arguments from the Protestant and the Applicant.

The Board is further aware of the new

Investigator as a witness, because the report provides background information and appears to contain nothing relevant to the specific issues as set forth in the Court's order. The parties may call the Investigator as a witness, as long as it is shown that the Investigator has personal knowledge and relevant testimony to provide related to the specific allegations at issue.

And so before we have opening statements, do the parties have any preliminary matters they need to bring to the attention? So we can start with you, Mr. O'Brien?

MR. O'BRIEN: No, sir.

CHAIRPERSON ANDERSON: Thank you. Mr. Uhar, do you have any preliminary matters you need to bring to the attention of the Board?

MR. UHAR: Yes. Again, 48 hour notice was not posted and the case is currently and the Board order is currently under a Court of Appeal decision. So I have no understanding. These are complaints that should be investigated, not protest.

CHAIRPERSON ANDERSON: We're here on a protest hearing sir because you protested --

this is a 2019 case that it was a renewal of this license in 2019. You protested it. The Board issued a determination. The Board issued a determination to renew the license.

You disagreed with the decision of the Board, and then you went to the Court of Appeals. The Court of Appeals affirmed the majority of the Board's determination and remand this case specific on one allegation. And so we're here on the remand that you requested by the agency.

So if you're saying that you are -this is not a protest anymore and if you want to
drop your protest, then we can conclude this
case, renew the license because you have -you're not moving forward with your protest, and
if you want to file a complaint with our
Enforcement Office, then so be it.

But again, this is from 2019. So as I said, you're the one who's driving this case sir. We're here because of your protest. So this is a protest hearing that you filed and we're trying to complete.

MR. UHAR: The last time you had the hearing, there were five Board members, and I asked you all to look at the evidence, and now

there were only two after that, and then Mr. Grant came in. So I was wondering has anybody yet read the evidence? Have you read the complaints? The last time you said you didn't need to read them. I want to know what has happened since then.

CHAIRPERSON ANDERSON: The Board doesn't deal with complaints sir. Complaints are filed with Enforcement. Enforcement looks at the complaints, and if Enforcement -- if the Enforcement branch determines that there is a violation, then a case-in-chief will be brought to the Attorney General's office, and they will determine if we need to have a show cause hearing.

But the Board does not respond to complaints. The Enforcement Office of the agency deals with that. Whether or not, sir, there were three, four or five, the regulations require that if we have three members, we have a quorum and we do have a quorum today. We have had Board members whose terms have expired, and so because their terms have expired they're no longer here.

But the regulations require that we have -- that a quorum is three and we have a

1 quorum today. We're making a determination based 2 on the remand, per your request. So as a -- yes, 3 sir. Actually, DCMR whatever the 4 MR. UHAR: 5 clause is states that there shall be seven members on the Liquor Board, and usually there's 6 7 an attorney, and I just want to know 8 legislatively how you got from a seven member board to a three member board, and has there ever 9 been a time when three Board members were asked 10 11 to read evidence and then didn't show up? 12 CHAIRPERSON ANDERSON: Mr. Uhar, the 13 regulations require, it clearly states that three 14 Board members, to have a quorum to have a 15 meeting, we need to have three Board members, and 16 we have three Board members here sir. And so we 17 have a quorum, and we are ready to move forward 18 with the protest hearing based on the specific 19 issue that was remanded by the Court of Appeals. 20 And so --21 MR. UHAR: I have a question --2.2 CHAIRPERSON ANDERSON: You have a 23 what, sir? I can't hear you sir. I cannot hear 2.4 -- I can't hear you sir. 25 MR. UHAR: Can you hear me now?

CHAIRPERSON ANDERSON: Yes, sir, I can hear you.

MR. UHAR: Okay. Now I lost my thought. The Board, show me the legislation that says you go from a seven member board to a three member board and I'm fine. But let's keep going because we're here, and I don't want to waste any more money of the government's time or my time or your time. So let's, let us proceed.

CHAIRPERSON ANDERSON: Fine. So we're moving forward with the remand to continue the protest hearing from 2019, and based on the -- based on the unique facts where the Court of Appeals remanded us from us to move -- us to move on that issue. And so where we are today, if the parties wish to make an opening statement at this juncture, they can do that.

There's no requirement, and then we'll have you continue your case, present your case, because the Applicant has already presented their case and you need them to provide evidence to the Board on the remand issues, as was specified in my opening statement.

So Mr. O'Brien, do you wish to make an opening statement? Anything you wish to do, sir?

MR. O'BRIEN: Very very brief, Mr. Chair. The Board, you Mr. Chair, just have elicited the standard that governs here. The sole, narrow purpose of this proceeding is to allow Mr. Uhar to present evidence of fraudulent misstatements on the part of the licensee's principals or its agents, to gain -- to get permits of approval from other agencies of the District of Columbia government.

The Board has recognized the standards required to prove fraud, and mere mistake or inadvertence, whether on the part of the licensee or on the part of another government agency does not, without more, constitute fraud. There must have been an intent to deceive, and material reliance on a misstatement.

The licensee denies without qualification any fraudulent conduct on its part.

Thank you.

CHAIRPERSON ANDERSON: Thank you. Mr. Uhar, do you wish to make an opening statement before you start your presentation sir?

MR. UHAR: Yes, I do. First of all, the D.C. ABCA Board seems to show favoritism in looking backwards and narrowly defining a remand

for what has been continuing criminal or fraudulent misstatements since the date Canale opened, and before that when Mr. Farruggio opened Canale. So we have an original sin in that there's a claim of title directly --

CHAIRPERSON ANDERSON: Mr. Uhar, I can't hear you sir. You are -- I've lost you.

MR. UHAR: Somebody keeps calling me, and I don't know how to mute this. But what I was saying was -- I'm going to turn off the ringer. Anyway the remand. Continuing criminal activities have occurred since the protest, most recently in Protest No. 4, and it's unusual that complaints are not responded to. They're formed into protests, and then the protestor denied on legal technicalities.

I should not be in this venue and I'm under appeal, but as I said, I have my evidence and I'm ready to proceed based on the original -- the original intention of Mr. Farruggio originally, he said he didn't have, you know, he had no connection. Anyway --

CHAIRPERSON ANDERSON: All right. Do you wish to call any witnesses, sir, or are you going to be the only witness?

8	hostile witness. I listed Meredith Moldenauer
9	(phonetic), attorney for his false summer outdoor
10	cafe. I got Mr. Moore, who can attest to the
11	fact that there was never anything on the second
12	floor, and I had Richard Livingstone, who was
13	with the Executive Office of the Mayor, who
14	declared by fiat that Mr. Farruggio could have an
15	outdoor summer cafe without US CFA approval.
16	CHAIRPERSON ANDERSON: So you're
17	saying that the witness you called was Mr.
18	Farruggio?
19	MR. UHAR: Yes, Mr. Farruggio.
20	CHAIRPERSON ANDERSON: Mr. O'Brien, I
21	thought when I looked at the PIF, was a PIF done
22	and was Mr. Farruggio listed as a witness sir?
23	MR. O'BRIEN: Yes.
24	CHAIRPERSON ANDERSON: All right. So
25	we call Mr. Farruggio. Where is Mr. Farruggio?

1	All right, sir. I'm not hearing you, so I think
2	you need to get closer to the, to the speaker
3	sir.
4	MR. FARRUGGIO: My name is Giuseppe
5	Farruggio, and I'm the
6	CHAIRPERSON ANDERSON: Can you spell
7	your name for the record please again sir?
8	MR. FARRUGGIO: G-I-U-S-E-P-P-E, F-A-
9	R-R-U-double G-I-O.
10	CHAIRPERSON ANDERSON: Can you raise
11	your right hand sir?
12	WHEREUPON,
13	GIUSEPPE FARRUGGIO
14	was called as a witness and, after having been
15	first duly sworn, was examined and testified as
16	follows:
17	CHAIRPERSON ANDERSON: Mr. Uhar, your
18	witness sir.
19	DIRECT EXAMINATION
20	MR. UHAR: Good morning, Mr.
21	Farruggio. In Exhibit 1 of the PIF, we will see
22	that it is
23	CHAIRPERSON ANDERSON: Hold on, hold
24	on. Hold on one minute please. Mr. Uhar, I need
25	you to be stationary.

1 MR. UHAR: Okay, I'm stationary now. 2 I was getting the PIF. 3 CHAIRPERSON ANDERSON: All right, thank you. All right, thank you. 4 5 MR. UHAR: Okay. In Exhibit 1 of the PIF, is an 1,852-page folder for Il Canale and 6 7 Fratelli La Bufala, and you maintain that you got 8 your permit directly from the Alamo Grill of 9 Georgetown; is that correct? 10 MR. O'BRIEN: Objection, Mr. Chair. 11 If he confronts the witness with a document, he has to exhibit the document and let the witness 12 13 look at it. 14 MR. UHAR: It is page one in Exhibit 15 2. . It's a letter from Candace Fitch, Esquire. 16 MR. O'BRIEN: Give us a chance to 17 locate that among 1,852 pages. 18 MR. UHAR: Oh no, no, you don't have 19 to look at that. It's in my -- it's in my PIF. 20 It's Exhibit 2, page one. Exhibit 1 is the 1,852 21 pages that contains a lot of redundancies that ABCA needs to clean up rather than telling me I'm 2.2 23 giving them a garbage dump. MR. O'BRIEN: A letter from Candace 2.4 25 Fitch. Is -- you are referring to an April 8th,

1 2009 letter? 2 MR. UHAR: That's correct. 3 MR. O'BRIEN: Okay. I'm showing a 4 copy of it to Mr. Farruggio. 5 MR. UHAR: Mr. Farruggio, you contend that you received your permit directly from --6 7 that there was no FLB DC, LLC, yet you were 8 involved. How could you not know? 9 THE WITNESS: Is my name in here? Ι don't see my name. What is this? I don't --10 11 CHAIRPERSON ANDERSON: Mr. Farruggio, 12 you can't look at Mr. O'Brien. You need to 13 respond to the questioning. If you can't answer the question, you state I can't answer the 14 15 question. 16 So I need you to answer the questions 17 to the best of your ability sir. If you can 18 answer the question, answer it. If you cannot, 19 state you cannot sir. 20 THE WITNESS: Can you repeat the 21 question, John? I don't -- can you repeat the 2.2 question please? 23 MR. UHAR: Yes. You claim that you received your rights directly from the Alamo 2.4

Grill of Georgetown to GF, Inc. Where the truth

is you had an earlier operation with partners called FLB DC. All of your documents that you have stated since to the ABCA Board since Day 1 have claimed -- you mention no reference of your previous operation, which I believe the license was returned.

So you didn't get -- you didn't get your license directly, and you made fraudulent misstatements ever since, knowing that you couldn't have gotten it because you got it six months earlier from FLB DC.

MR. O'BRIEN: Objection, relevance. This does not address anyone, or items that the Board has identified are at the table, so to speak, here today.

MR. UHAR: Well then I'd like to call Mikea Nelson as a witness.

CHAIRPERSON ANDERSON: Hold on. Hold on here. I'm confused. So that's why I'm trying to find the relevance of the question you're asking sir. So I'm just trying to get some clarification myself to make a ruling on his, on his motion.

MR. UHAR: Well if you had read it -- CHAIRPERSON ANDERSON: Mr. Uhar, I

need you to respect this forum, sir. I do not want you to make allegations about whether or not I had read something sir. I need you -- you are questioning a witness.

MR. UHAR: Okay.

CHAIRPERSON ANDERSON: It is your responsibility to ask cogent questions to the witness, sir, and whether or not -- whether or not I've read something or not, it's irrelevant sir. You're asking the questions, and you need to ask questions that the witness you're questioning can answer, okay?

So why is this, Mr. O'Brien has stated that he doesn't think that this is relevant. So why is this relevant? So I will make a ruling to say whether or not he needs to answer the question, or whether or not I am going to not allow you to answer the question, to ask the question sir.

MR. UHAR: Okay. Well if you look at my Exhibit 4, you will see that there's a whole chain of title that goes back and only says that Il Canale got its license from the Alamo Grill of Georgetown. So the first question would be this April 8th, 2009 letter that went to FLB DC, LLC.

23	CHAIRPERSON ANDERSON: All right. So
24	what about what are you asking, sir? I mean
25	what all right. So let's see. You're saying

a settlement agreement. So okay. Do you have a question that you're asking sir?

MR. UHAR: Yes, I do. Yes, I do. I just want everybody to get the paper. So on the settlement agreement on page -- well, let's go. The first settlement agreement was made and you'll see that they all claim -- well that one didn't even claim title through that.

Let's go through -- oh, actually it's all the way at the end, and it says whereas
Advisory Commission to -- it's from E. David
Harrison, 5/31/2009.

CHAIRPERSON ANDERSON: What page? Can you direct, direct, show your witness sir to a specific page? I have the document in front of me and I don't know where you are. So can you please direct us, direct the witness to where in the settlement agreement you're -- is there numbers?

MR. UHAR: Yeah actually, to tell you the truth. Start at the back. Let's start at the back. We'll start at the back going forward, okay? And we have the last page is whereas Advisory Neighborhood Commission 2E entered into an agreement with Alamo Grill of Georgetown, Inc.

1 on October 30, 2000, and whereas the license was 2 transferred from Alamo and GF, Inc. t/a Il Canale on January 28, 2010. 3 So that's -- he claims, he claims 4 5 rights that actually went to FLB DC that were extinguished when FLB DC went under. And he --6 7 since he was a silent partner, he had to know. 8 So these are all fraudulent documents. 9 time they were -- every time they recite whereas the license transferred to Alamo to GF, Inc. t/a 10 11 Il Canale on January 28th. 12 Wherever that exists in that 1,872 13 pages is fraudulent. 14 CHAIRPERSON ANDERSON: Are you asking 15 a question sir or are you making a statement? 16 MR. UHAR: I'm making a statement, because this -- this evidence speaks for itself. 17 18 This is not --19 CHAIRPERSON ANDERSON: Mr. Uhar, you 20 are -- you are questioning the witness, sir. You 21 cannot make statements and question the witness. 2.2 MR. UHAR: Okay --23 CHAIRPERSON ANDERSON: In doing your 2.4 closing -- I'm sorry. In doing your closing, you 25 can make those statements. But currently, you're

asking questions of the witness, so you have a document. You ask questions of the witness. The witness will answer and then we move on.

At the end of the case when you're doing your closing, then you can -- the statement you just stated, you can make those statements when you're doing your closing, sir. But not while you're cross -- not while you're questioning the witness, sir.

MR. UHAR: Thank you. I'm sorry.

There's a second amendment to the settlement
agreement that Mr. Farruggio signed on 3/5/2014.

Mr. Farruggio, it says in the second paragraph
whereas the license was transferred from Alamo to
GF, Inc., trading as Il Canale on January 28th,
2010. Do you testify that this is a true
statement?

MR. O'BRIEN: Objection Mr. Chair, relevance. It talks about misstatements as the four discrete issues that are identified in the Board's letter and that were identified at the beginning. I get what Mr. Uhar is doing, starting back in 2019. He's attempting to take every single misstatement of fact that Mr. Farruggio may or may not have engaged in, and

throwing it up on the wall here to see if it sticks.

I've got a continuing objection to any discussion other than such misstatements as Mr. Farruggio may have made with respect to the four issues that are before the Board today.

CHAIRPERSON ANDERSON: Mr. Uhar, I did state what this case was about. It's four allegations. The first allegation, the allegation in the PIF alleging that the submission of -- dealing with a sidewalk cafe, the testimony of Mr. Fargama on May 8th, 2016, the allegation in the complaint that the Applicant used the -- the alleged use of a counterfeit occupancy permit since 2/15/2015, and the allegation in complaint number four, the allegation of using four counterfeit permits on the radar.

I can give you some leeway, sir. So I'm going to overrule this objection, but I need you to come back to the case-in-chief. This hearing will be focused on the remand and the allegations that were listed in the record. I'll give you some leeway, but we're -- but not in the sense that you're going to back to 2000 to say

If the witness can answer the question, I'm going to allow him to answer it. However, I need you to come back, sir, to the purpose of this hearing, okay? So I'm going to overrule the objection. If the witness can answer the question, then he can -- please move, go ahead.

MR. O'BRIEN: We ask the question to be restated.

CHAIRPERSON ANDERSON: Mr. Uhar, it's been asked that you restate the question sir.

BY MR. UHAR:

Q Yes, yes. Mr. Farruggio, when you signed the second amendment to the settlement agreement, stating that the license was transferred from Alamo to GF, Inc. trading as Il Canale on January 28th, 2010, is this a true statement?

A Yes.

Q It is? When you just saw that Exhibit 1 said it went through -- he said yes. I don't know. Tell me what to do.

CHAIRPERSON ANDERSON: Mister -- the witness answered the question. You asked him a question, he has answered it sir. If you have a follow-up question, you ask a follow-up question. If not, let's move on.

A Oh, back to this one again? This 2009 went through, from Alamo to FLB. I was not handling this stuff. I was a silent partner. I had the partner that had majority and there was a secretary of the company was handling all this stuff. I was a silent partner. I was just an investor.

Q Why wouldn't you state that on your ABCA license?

Wasn't part of the license, so the old -everything got transferred from Mr. David
Harrison. He handled everything at that time.
We hire him and he handled all the transfer, and he told me, you know, this is what we're doing and I signed it, you know. I don't know whether

1 CHAIRPERSON ANDERSON: I think it's Complaint No. 1 or Exhibit No. 1, or is it the 2 3 same? 4 No, they were all -- it was MR. UHAR: 5 just the Complaint No. 1. You hurried me. 6 never mind. Complaint No. 1. 7 CHAIRPERSON ANDERSON: I don't know what's Complaint No. 1, so I can't -- I'm trying 8 9 to follow along. But I don't know what Complaint No. 1 is. 10 11 MR. UHAR: All right. It's exhibit --12 I think, I believe it's Exhibit 5. 13 CHAIRPERSON ANDERSON: All right, go 14 ahead. Is there a question? Is there a question 15 presented sir? 16 MR. UHAR: Yes, because you want to 17 know -- okay. Mr. Farruggio, on May 23, 2016, 18 you state that Mr. Uhar, Mr. Uhar assumed that 19 I'm applying my license now for the whole 20 building, and my license right now is for the 21 bottom floor and 1063 and 1065 bottom floor, and 2.2 you know we're dragging this thing. I think that 23 we're wasting time. But later, on 2019, you get an 2.4 25 occupancy permit for the 2nd floor. How did you

1	get that?
2	MR. O'BRIEN: Mr. Chair, I want to
3	show Mr. Uhar is reading from a page of a
4	transcript of a hearing. I want to show the page
5	to Mr. Farruggio.
6	CHAIRPERSON ANDERSON: That's fine,
7	sir.
8	THE WITNESS: Yeah.
9	MR. O'BRIEN: Okay.
10	THE WITNESS: Yeah, that's
11	BY MR. UHAR:
12	Q Mr. Farruggio, was that a true
13	statement at the time?
14	A Yes.
15	Q Okay. Then we go to Exhibit 2. Well,
16	the next page. On 11/6/2019 when this was under
17	complaint, you were able to expand onto the 2nd
18	floor. How is that possible?
19	MR. O'BRIEN: Mr. Chair, I don't
20	understand the question either.
21	MR. UHAR: Okay. Go to the last page
22	on that exhibit. Go to the last page.
23	(Off mic comments.)
24	CHAIRPERSON ANDERSON: I'm sorry. He
25	said go to the last page so

1	MR. UHAR: No, no, no. No, no,
2	no. Actually, go to it will say No. 3. It
3	will say Exhibit 3, and it's Mr. Farruggio's
4	permit issued for the first floor of 1065. But
5	then on 11/6/2019, he gets he gets the second
6	floor while it's under protest, and I just want
7	to know how that happens.
8	MR. O'BRIEN: Mr. Chair, I still don't
9	understand the question how it happens.
10	CHAIRPERSON ANDERSON: Mr. Uhar, can
11	you rephrase? Can you rephrase your question
12	sir? Mr. Uhar?
13	MR. UHAR: Yes.
14	CHAIRPERSON ANDERSON: You know,
15	because you're not
16	MR. UHAR: Let's move on. Okay. We
17	can move on.
18	CHAIRPERSON ANDERSON: Okay. Go
19	ahead, sir.
20	MR. UHAR: So what's the next one?
21	What's the next one you want to know, because on
22	your edited version?
23	CHAIRPERSON ANDERSON: Mr. Uhar,
24	you're asking the witness questions sir, so it's
25	your

1 MR. UHAR: Yeah but Exhibit 3. 2 CHAIRPERSON ANDERSON: Is there a 3 pending question for the witness sir. MR. UHAR: Yes. Let's move on to ABRA 4 5 -- let's move on to Exhibit 3. I call it ABRA Complaint No. 4. It's a letter, it's a complaint 6 7 sent to Mr. Moosally that was never acted --8 (Off mic comments.) 9 MR. UHAR: Okay. We're going to get to -- on that, we're going to move to exhibit --10 11 we'll start with exhibit -- we'll start through Exhibits 3, 4, 5, 6, 7, 8 and 9, 11. Let's just 12 13 start with Exhibit No. 3, and that's stop work 14 order on an illegal shed. 15 CHAIRPERSON ANDERSON: Hold on sir. 16 Are you talking about Exhibit 3 in your PIF? 17 MR. UHAR: No, no. Exhibit 3 in 18 Complaint No. 4, which should be PIF Exhibit No. 19 9. It's ABRA Complaint No. 4. 20 CHAIRPERSON ANDERSON: So you need to 21 direct the witness to the specific -- in order to 2.2 clarify the record, you need to tell us exactly 23 where you are, what document that is in the record so we'll have a clear record of what we're 2.4

referencing.

1	MR. UHAR: Okay, sure. I'm
2	referencing ABRA Complaint No. 4, and I'm going
3	to start with Exhibit you know it as PIF No.
4	9, because I think I added 5. We're going to go
5	over these. We'll start with Exhibit 1.
6	MR. O'BRIEN: I'm sorry, Exhibit 1?
7	MR. UHAR: On PIF number yeah, on
8	the 4. Protest. It's the Complaint No. 4.
9	Yeah, Exhibit 1.
10	MR. O'BRIEN: Okay. If I may, Mr.
11	Chair, just to try to move it along, is this a
12	photograph?
13	MR. UHAR: Yes, sir.
14	MR. O'BRIEN: With the notation
15	construction over public alley written on it?
16	MR. UHAR: Yes.
17	MR. O'BRIEN: Okay.
18	MR. UHAR: All right.
19	MR. O'BRIEN: We know what Mr. Uhar is
20	referring to, Mr. Chair.
21	CHAIRPERSON ANDERSON: All right,
22	fine. Is there a question?
23	BY MR. UHAR:
24	Q Yes. Exhibit 1, Mr. Farruggio, you
25	constructed this. This is a picture of you

1	constructing over the public alley?
2	A No. I never construction of anything
3	at the public alley. I did it in the lot, on the
4	square.
5	Q Now the square's on the other
6	A I'm aware of the alley is not my
7	property.
8	Q So you say that you didn't build this?
9	A In the alley, no. I built it on the
10	lot.
11	Q Okay. Let's move on to No. 2. Let's
12	move on to No. 2. This is these are your guys
13	on the public alley in the back, true or not?
14	A They're not in the public alley. They
15	are on top of my property that I lease.
16	Q No.
17	A There's a platform right next to the
18	air conditioner.
19	CHAIRPERSON ANDERSON: Mr. Uhar, you
20	asked him a question. He responds. You can't
21	say yes or no. You just have to move on to
22	another question.
23	MR. UHAR: Okay. Exhibit 3. Mr.
24	Farruggio, you still contend that you didn't
25	build over the alley?

1	THE WITNESS: Yes. I never built over
2	the alley
3	BY MR. UHAR:
4	Q Mr. Farruggio, if you look on the
5	right, you'll see a stop work order. Do you
6	acknowledge receiving a stop work order?
7	A Yes, I acknowledge receiving many stop
8	orders because you called for it.
9	MR. O'BRIEN: Mr. Chair.
10	CHAIRPERSON ANDERSON: Yes, sir.
11	MR. O'BRIEN: Can we get a proffer as
12	to the relevance of this to any of the four
13	issues before the Board today?
14	CHAIRPERSON ANDERSON: Mr. Uhar, are
15	you able to do that sir?
16	MR. UHAR: Yes. This is fraudulent,
17	illegal activity over a public alley that for a
18	summer garden, absolutely. So let's move on.
19	Exhibit 4. Mr. Farruggio?
20	CHAIRPERSON ANDERSON: All right.
21	What's Exhibit 4?
22	MR. UHAR: Mr. Farruggio?
23	(Simultaneous speaking.)
24	MR. O'BRIEN: It's another photograph,
25	Mr. Chair.

1 CHAIRPERSON ANDERSON: Mister, what 2 exhibit are -- on the PIF are we? Where are we 3 on the PIF? What exhibit on the PIF? BY MR. UHAR: 4 5 0 We're No. 9, which is Complaint No. 4, and we're on Exhibit 4, which is the picture of 6 7 the shed that's removed. I was just going to ask 8 Mr. Farruggio if he was made to clean that up by D.C. 9 10 What's the question again? Α 11 Did D.C. make you clean up this shed? 12 Did D.C. make you return the lot to how it was? 13 Α The lot, there used to be a 14 refrigerator there, Mr. Uhar. 15 0 Please answer --16 We never built on that, and after that 17 we took it down the refrigerator. I put a fan 18 around to use it for storage, and then I was told 19 that I needed to get a permit because I was 20 substituting the same space. I then got a 21 permit, and then I was asked to take it down and 2.2 I took it down. 23 MR. UHAR: Okay. Exhibit 5. Mr. 2.4 Farruggio, Mr. Farruggio? 25 THE WITNESS: Yes, sir?

1		BY MR. UHAR:
2	Q	Okay, Exhibit 5. Is this a new fence
3	you had cons	structed on 332, 3/30/22?
4	A	Yes.
5	Q	Did you get a permit for that?

	Q Okay, number Exhibit No. 6. This
2	shows you blocking gates and fire exits for me at
3	3075 and 3073 Canal. You caused this, this
4	you caused this blocking of the gate; correct?
5	A I put a fan when I had the permit,
6	John. I didn't block anybody. I had the right
7	to put the I had the permit and I had the
8	built the fans with the permit that I had
9	approved to.
10	Q Okay. Let's go to the next one. This
11	your interior lot and storage yard, with a tent
12	without occupancy. You never got occupancy
13	permits for this interior lot storage yard, did
14	you?
15	A No, no. I put the tent just to cover
16	my son's equipment that I don't want to get
17	damaged.
18	(Simultaneous speaking.)
19	Q And you're occupying it without a
20	certificate of occupancy?
21	A Was there a question about certificate
22	of occupancy?
23	Q You don't have a certificate of
24	occupancy for this do you?
25	A For what?

1	Q For this lot?
2	A I don't know what's the question. I
3	don't know if it's
4	Q Do you
5	A I leased the property. I leased the
6	property. It has 5,000 square foot in this
7	square. I didn't, and there was a walk-in
8	refrigerator there, and I just used it. I do not
9	know that I had to get an occupancy for that.
10	Q Did you recent take did you
11	recently take the fence down?
12	A Yes.
13	Q And why was that?
14	A Because I thought, you know, I wanted
15	to make you happy and do whatever I thought it
16	was supposed to be, you know, to if that would
17	bother you because I had the permit. But anyway,
18	you know, that's why I took it down. I don't
19	want to continue arguing with you.
20	Q Did you recently you know, that lot
21	is now under a tree easement that was from
22	well, that's not connected to this. Move on.
23	Exhibit 8. This is a picture of your new fence
24	and those are permits that you had on the back,
25	Mr. Farruggio?

1	A Yes. That was the permit for the
2	fence, yes.
3	Q Okay. Now if we go and we look in a
4	little closer, Exhibit 9, these are the two
5	permits; correct Mr. Farruggio?
6	A I'm just verifying, John. Hold on.
7	I can't read it that much, but looks like yes.
8	Looks like, but I can't read it very well in
9	here. But I have the good copy here. That's the
10	copy, yes.
11	Q Exhibit 10. These look like the
12	permits that you posted on your property?
13	A Yeah.
14	Q Okay. Exhibit 11. Do you see it's
15	hard to see, but that is Lot 64?
16	A Yeah.
17	Q And if you look at Exhibit 12, that
18	Lot 64 is actually your original location, which
19	was the Alamo Grill of Georgetown; is that
20	correct Mr. Farruggio?
21	A I have to get clear here. Lot 842?
22	This is what we're talking about, 842?
23	Q That's your outdoor summer garden.
24	That was going to be your outdoor summer garden.
25	A That's not my summer garden. This is

1 -- you're talking about the same square? 2 Yes, Mr. Farruggio. The fence permit is clearly for Lot 64; correct? 3 4 Α Yes. 5 But you built across Lot 842; correct? Well, the permit was for the 6 Α 7 whole behind 1065 and behind 1063. 8 No, it wasn't. 9 Α I leased both properties, and then when I would apply for a permit, we used the lot 10 11 of the addresses that I, you know, my architect. 12 I didn't apply personally. I had architect, a 13 professional, to give me the permit. He bring -and we built a fence. 14 15 Mr. Farruggio, the fence that you built on Lot 0842. Lot 0842 in this exhibit says 16 existing -- well no. Okay. So Lot 64 is what 17 18 you have the permit for, and you built across -you blocked Lot 0842 -- you fenced in Lot 0842 by 19 20 blocking the access to the alley to 3073 and 21 3075; is that correct? 2.2 Α No. 23 Why not? Q Because both the permit was behind 2.4 Α 25 both buildings, and was for both buildings.

1 Mr. Farruggio, the permit clearly 0 2 states --CHAIRPERSON ANDERSON: 3 Mr. Uhar, give 4 him an opportunity to answer the question sir, 5 please. BY MR. UHAR: 6 7 Q Yeah. 8 In my knowledge, they both are part of Α 9 my lease, and my architect, you know, went in both address. They're both leased, and he 10 11 applied for permit for me to wrap up the property that I'm paying rent for, so I could use it for 12 13 my need. And he got me the permit and, you know, 14 with the Department of Consumer Affairs, and then 15 I was told that it was not right. And I'm still after today, I think I 16 did the right thing, but you know, you're saying 17 18 it's not and it created a lot of chaos. 19 think I'm legally with the permit. I still 20 believe I did it right. 21 Okay, I'm sorry for interrupting. Continue. 2.2 23 I'm done. Α 2.4 Okay. If we go to -- so you say that 0

the fence permit was not for Lot 64; is that

1	correct?
2	A Nope.
3	MR. O'BRIEN: Objection, that's not
4	what he said.
5	BY MR. UHAR:
6	Q Okay. Then let me restate the
7	question. You built the fence on Lot 64;
8	correct?
9	A Yes. I have the two permits for it,
10	yes.
11	Q So you built the property on Lot 64,
12	thank you.
13	A Yes.
14	Q Okay. Now if we look to Exhibit 13,
15	this is Lot 1198-0842. You'll see that there's
16	no building or occupancy permits, but you occupy
17	in violation of D.C. Municipal regulations;
18	correct?
19	MR. O'BRIEN: Mr. Chair.
20	CHAIRPERSON ANDERSON: What's the
21	nature of the objection sir?
22	MR. O'BRIEN: The problem here is that
23	the Board has not seen these exhibits as they're
24	discussed, and in this exhibit, I think there's a
25	predicate that Mr. Uhar has to ask, whether Mr.

1 Farruggio has ever seen this document before. 2 will represent to the Board it's not a document 3 signed by Mr. Farruggio or generated. It's a DCRA printout. 4 5 CHAIRPERSON ANDERSON: Okav. It's the legal --6 MR. UHAR: 7 CHAIRPERSON ANDERSON: All right. So 8 why don't we start at the beginning? 9 don't you ask the witness if he knows what this document is, if he recognizes this document? 10 The 11 witness can -- so I --12 MR. UHAR: No, no, no. I have a 13 better way. I know how to ask it. 14 MR. O'BRIEN: Thank you. 15 CHAIRPERSON ANDERSON: Well, all 16 Let me, let me say this to you, Mr. Uhar. 17 Normally, normally what occurs, you have 18 exhibits. You call the exhibit that you're 19 relying on. 20 The attorney looks at it to make sure 21 that we're all looking at the same exhibit, and 2.2 then you show the exhibit to the witness and then 23 you ask the witness if the witness recognizes 2.4 this document, so that witness can testify. If

the witness says that I don't recognize this

1 document, then he can't testify. 2 So what I need you to do moving 3 forward sir is that when we have you state what witness, what document you are -- you're relying 4 5 upon. Mr. O'Brien will show the witness the document, and then you can ask a question of the 6 7 document once the witness has had an opportunity 8 to review the document, sir. Okay? 9 MR. UHAR: Yes, thank you. Okay. Exhibit 13. Mr. O'Brien, 1198-0842. 10 11 MR. O'BRIEN: The witness has the document in front of him. 12 BY MR. UHAR: 13 Mr. Farruggio, you're occupying 14 Okay. 0 15 Lot 11 -- Lot 0842 and 1198 without an occupancy 16 permit; correct? 17 I have a permit to build the Α No. 18 fence on that property. I don't know what this 19 document is really. 20 It's just a record of building and 0 21 occupancy permits, and it says you don't have a 2.2 building permit or an occupancy permit. But you 23 say you do; correct? 2.4 Α Yes. 25 That's your testimony. You testified 0

that --

2.4

A Lot 64 and 1198, 1198, Lot 64. I have two permits one, you know.

Q Mr. Farruggio, I'm asking about Lot 0842. It's your testimony here today that you have, you had a building permit for the fence and an occupancy permit for your continuing operations; yes?

A Yes.

MR. UHAR: Okay. We go now to Exhibit 15, which is the permit for the fence from the DC Scout website. Do you see that, Mr. O'Brien?

MR. O'BRIEN: I've seen what you've labeled, Mr. Uhar, as Exhibit 15 to the witness.

I suggest that predicate question is has the witness ever seen this document.

MR. UHAR: No. Have you ever seen this -- well he -- it was in the exhibit before.

CHAIRPERSON ANDERSON: All right. But Mr. Uhar, you're asking the witness about a document, and I think you're asking whether or not he is aware of it, has he seen it. So you need to start -- you need to start there first sir, okay?

BY MR. UHAR:

1 Okay. Mr. Farruggio, have you ever 0 2 seen this document? 3 Α No. 4 Okay. It says it removes existing 0 5 wood stockade fence and install new pressuretreated stockade fence. Was there any existing -6 7 8 MR. O'BRIEN: Objection. 9 CHAIRPERSON ANDERSON: What's the nature of the objection sir? 10 11 MR. O'BRIEN: It's -- the witness says he's never seen this document before. 12 I can 13 represent to the Board it purports to be a DCRA 14 printout. 15 MR. UHAR: Yes, it is. He hasn't seen it 16 MR. O'BRIEN: 17 before. He can't comment on it. 18 CHAIRPERSON ANDERSON: Hold on, hold 19 on. Let me -- what's the question? Let him ask 20 the question first, Mr. O'Brien, because maybe --21 let me see what the question is. I know that he 2.2 was about to say something and you object. 23 let me hear the question, then you can raise your 2.4 objection at that time, sir. Go ahead, Mr. Uhar. 25 BY MR. UHAR:

1 Mr. Farruggio, if you look at this 2 document, you'll see that it says Ben and Mel, for Lot 64 in Square 1198, to remove the existing 3 wood stockade fence and install a new pressure-4 5 treated stockade fence. Did you remove the existing wood 6 7 stockade fence and install a new pressure-treated stockade fence on Lot 64 in Square 1198? 8 9 Α Yes. 10 That is, that is -- so you're saying 0 11 that you put -- you replaced the fence that was 12 behind me, and is part of the -- Mister -- the 13 old Alamo Grill? You replaced that fence, 14 because that's Lot 0064. You said you replaced 15 that fence? 16 No, I didn't say that. I said I put 17 around a fence whatever I had the permit for. 18 don't know what you're talking about, the way you 19 describe it. I don't picture what side you're 20 talking about. 21 The fence permits for Lot 64 and 2.2 Square 1198? 23 Α Yes. And I'm asking you did you remove the 2.4 0 25 existing wood stockade fence and install the new

1	pressure-treated stockade fence on the old Alamo		
2	Grill space 1063 1063 31st Street, a/k/a 1198-		
3	064? Did you build the fence there?		
4	A Yes, I have to build it. I didn't		
5	build it. I had the fence company that built the		
6	fence and following the permits.		
7	Q And you did this? You replaced the		
8	fence between us from the old Alamo Grill?		
9	That's what your that's what your permit's for		
10	and that's what you, that's what you		
11	A I replaced the fence. I replaced the		
12	fence that was behind the Alamo Grill, but it was		
13	not next to your property. It was, you know,		
14	between Alamo Grill and which is 1063, and Mr.		
15	Moore's building, which is 1065. The fence that		
16	I removed was between these two properties, which		
17	I'm leasing it, not on your property. I didn't		
18	touch any fence that had adjacent, that touches		
19	your property.		
20	Q But you should have? That was the		
21	only fence you were permitted for, Mr. Farruggio.		
22	You did not have a permit for 0842?		
23	MR. O'BRIEN: That's not, that's not		
24	a question. That's argument, Mr. Chair.		
25	MR. UHAR: Okay.		

1	CHAIRPERSON ANDERSON: Mr. Uhar,
2	please ask a question. All right.
3	MR. UHAR: I'll move on. Exhibit 16.
4	(Pause.)
5	CHAIRPERSON ANDERSON: What's your
6	question sir?
7	MR. UHAR: Well, I wanted to see if
8	Mr. Farruggio had seen this.
9	CHAIRPERSON ANDERSON: This is Chapter
10	3 of Administrative Enforcement. So I mean what
11	is it you're asking him about, about this, these
12	I don't know what regulations these are. I
13	guess they're the zoning regulations. So what
14	about it that you're asking him sir?
15	MR. UHAR: I'm asking him about zoning
16	requirements.
17	CHAIRPERSON ANDERSON: I'm sorry, sir.
18	MR. UHAR: Yeah. Mr. Farruggio works
19	with Mr. Farruggio, you say you worked with
20	attorneys and other people to assist you in all
21	this. How is it that you can occupy 0842 without
22	a building or certificate of occupancy?
23	MR. O'BRIEN: Are we asking about
24	Exhibit 15 now?
25	MR. UHAR: 16.

1 16. MR. O'BRIEN: 2 I really don't know what THE WITNESS: -- I don't know what this is, building permit. 3 4 MR. O'BRIEN: Okay. Mr. Chair, do you 5 see that Exhibit 16? CHAIRPERSON ANDERSON: 6 I am -- I am 7 looking at the Exhibit 16. Exhibit 16 is Chapter 8 3, Administrative Enforcement. So I don't know 9 what -- I don't know what's being asked, if that's -- we're looking at the same document. 10 So 11 what's being asked sir? 12 MR. UHAR: Mr. Farruggio, did you get 13 a permit to put the tent over Lot 0842? Did you 14 get a building permit for Lot 0842 for your 15 fenced-in compound? 16 CHAIRPERSON ANDERSON: Mr. Uhar, all 17 Exhibit 16 is, at least what I'm looking right. 18 at, is Chapter 3, Administrative Enforcement. 19 Are you asking the witness whether or not he's 20 familiar with these regulations? We need to 21 start there first because unless I'm looking at 2.2 the wrong document --23 BY MR. UHAR: 2.4 0 Yes, no. No, I hear you, and his 25 attorney, his attorney, Mr. Farruggio claims that

1	his attorneys take care of everything. Well, his
2	attorneys should know that you can't do a
3	building permit or you can't have a certificate -
4	- if you don't have a building permit or a
5	certificate of occupancy, you can't occupy a
6	property. So knowing this, how does he occupy
7	Lot 0842?
8	A Is that a question to me?
9	Q Yes.
10	MR. O'BRIEN: He was explaining to
11	somebody, he was explaining. Mr. Chair?
12	CHAIRPERSON ANDERSON: Yes, sir.
13	MR. O'BRIEN: His occupancy or not of
14	0842 is not one of the four issues before the
15	Board today.
16	CHAIRPERSON ANDERSON: I'm looking at
17	Allegation 4 and maybe, maybe I'm confused. But
18	I'm looking at Allegation 4. So I'm thinking
19	that the allegation of using for counterfeit
20	fence permits to the rear door of 1065, is that
21	what we're talking about? If that's not what
22	we're talking about, then
23	MR. UHAR: We're talking let's move
24	on to that then.
25	CHAIRPERSON ANDERSON: All right No

hold on. So therefore then if that's not what we're talking about, then I'm going to sustain the objection to move on, because I heard we've been talking about fences, and so because I know that was one of the allegations. That's one of the reasons I've allowed this to occur, because I thought that this conversation was dealing with the fence and using illegal permits.

MR. UHAR: And it is. It was.

CHAIRPERSON ANDERSON: But if that's not what it is -- I'm sorry sir. Go ahead, sir.

MR. UHAR: Well that's what it is.

That was the D.C. Code, and Mr. Farruggio said

that he works through his attorneys. But maybe

he doesn't listen to them and he builds not where

they, where he gets his permits for. And so he

claims -- well, that's it. That's pretty much

it. So that's why I was asking about the

occupancy permit, and that's why I was asking

about the building permits.

CHAIRPERSON ANDERSON: All right. Do
we have another question that you want to ask?

MR. UHAR: No. You said you wanted to
move on. What was the one that you talked about,
Exhibit 4 with the fraudulent permits? Let's

1 move on to that one. 2 CHAIRPERSON ANDERSON: That's one of 3 the allegations that we were supposed to address 4 in this --5 (Simultaneous speaking.) MR. UHAR: Yeah, let's -- and I'd like 6 7 to move on. 8 CHAIRPERSON ANDERSON: Yes. 9 MR. UHAR: What is that? That is --10 what do you know it as sir? 11 CHAIRPERSON ANDERSON: I believe that based on -- based on the remand, this is one of 12 13 the issues that needs to be addressed here, 14 Allegation 4. The allegation in Complaint 4, the 15 allegation of using four counterfeit fence 16 permits on the rear door of 1065 31st Street and the window on the front of 1065 31st Street on a 17 18 date and time that hasn't been clearly identified 19 in the complaint, which is -- it says I'm not 20 applying for anything new. I'm applying for the 21 license as it stands. 2.2 MR. UHAR: Yeah, yes. That's the one. 23 CHAIRPERSON ANDERSON: So what is it 2.4 that you want to ask about that sir? 25 Well, first I have to find MR. UHAR:

1	it. So I'm going to go online for a second.
2	(Pause.)
3	MR. UHAR: Where is it?
4	(Pause.)
5	MR. UHAR: That's 4, I'm sorry. If
6	you'll wait a second, I'll pull it up on I
7	have it right here. So Exhibit 4.
8	(Pause.)
9	MR. UHAR: Okay. That's Complaint No.
10	4, right Chairman?
11	CHAIRPERSON ANDERSON: Yeah. That's
12	the yeah. The allegation Complaint No. 4,
13	yes, sir.
14	MR. UHAR: Yes, and okay. So no,
15	that's not it. Well hold on, let me see the
16	page. That looks like a lot of what we just went
17	over. Yeah, that was all what we just went over.
18	Those are the fences and the permits and yeah.
19	We've already that's what we've been
20	discussing
21	CHAIRPERSON ANDERSON: All right.
22	MR. UHAR: Yeah, yeah. So what was
23	the next one that you wanted to consider?
24	CHAIRPERSON ANDERSON: I gave you the
25	four allegations sir that should that I

1 believe they were in the board order. 2 four allegations that needs to be addressed is the allegation in the PIF, alleging that the 3 submission of a sidewalk cafe plan to DCRA was 4 5 fraudulent. The allegation in your Complaint No. 6 7 1 that the testimony of Mr. Fargama on May 8th, 8 2016 in line 7 was -- in the transcript was 9 fraudulent. Allegation No. 3, the allegation in Complaint No. 3 that the Applicant used -- the 10 11 alleged use of a counterfeit occupancy permit since February 15th, 2015 in violation of DC Code 12 13 Section 25-401 and 25-835, and we have already 14 addressed Allegation No. 4. 15 MR. UHAR: All right. Let's go to 16 Allegation No. 3, because we didn't get number 17 Let's go to Complaint No. 3. one. 18 (Pause.) 19 MR. UHAR: Okay. Have you ever seen 20 this document? 21 CHAIRPERSON ANDERSON: Now where --2.2 what document are we're at? 23 MR. UHAR: We're going to go through 2.4 everything in exhibit number -- ABCA Complaint 25 No. 3, because this is about the false, this is

1 about the false occupancy permits. 2 MR. O'BRIEN: We'll have to find these 3 exhibits here. I have ABRA Complaint No. 3 in 4 front of me, which is a statement by Mr. Uhar. 5 Is he referring to that piece of paper or to the exhibits mentioned in it? 6 7 MR. UHAR: I'm starting with the whole 8 thing, yes. That's the exhibit. 9 CHAIRPERSON ANDERSON: So I'm sorry. Which exhibit is that, so I can follow along 10 11 myself? From the PIF, what exhibit is that so I 12 can follow along? It's exhibit -- if it's --13 MR. UHAR: 14 what is it 3? Then it must be 8, right? 15 Exhibit 8 in your PIF, ABRA Complaint No. 3. 16 CHAIRPERSON ANDERSON: That's not No. 17 8, because No. 8 is ABRA Complaint No. 4. 18 MR. UHAR: Yeah. No it's --19 CHAIRPERSON ANDERSON: It's not number 20 -- it's not, let me see. I just want to make 21 sure that we're all on the same page. 2.2 MR. UHAR: Yeah. It says ABRA 23 Complaint No. 3. It's to Mr. Moosally. It would 2.4 have been right before 4. 25 CHAIRPERSON ANDERSON: Okay. Well go

21	were pretty	involved. Do you remember this? Do
22	you remember	this letter?
23	A	No.
24	Q	No.
25	А	As I say, I was an investor and I did

	not dear with any or this stuff. They dear with
2	it, you know.
3	Q Okay. But do you see here that it
4	says awning and signs for Fratelli La Bufala,
5	existing permit?
6	A It says existing permit. I see that.
7	Q But do you see note is made that a
8	sidewalk cafe with tables, chairs and umbrellas
9	was installed on public space without review of
10	permit. Do you see that?
11	MR. O'BRIEN: Objection. He stated
12	he's not familiar with the document, Mr. Chair.
13	He's being asked to agree to contents of a
14	document which he did not prepare and he's never
15	seen before.
16	MR. UHAR: He was a member of Fratelli
17	La Bufala as well as Il Canale. He's connected
18	and he doesn't, he's misleading and been
19	fraudulent since Day 1 on this. This is what
20	this is all about.
21	CHAIRPERSON ANDERSON: But all right.
22	Mr. Uhar
23	MR. UHAR: Okay. Let's move to
24	Exhibit No. 4.
25	CHAIRPERSON ANDERSON: All right.

1 MR. UHAR: Okay. 2 (Pause.) 3 MR. O'BRIEN: The witness has the document in front of him. 4 5 BY MR. UHAR: 6 Okay. Have you ever seen this 7 document, Mr. Farruggio? 8 Α Yes. If, I don't see an answer at 4:28 to say that there was no permit from 2015. I don't see that.

So I communicated with her over the weekend, and then in your testimony, you said that you would allow her to testify or to be a witness if called, provided she had actual knowledge of, you know, investigative issues. I would say not just limited to what's there, because if you find other things while you're investigating one, it's pretty much incumbent upon you, in the best interest of ABCA, to investigate so --

10	if that's relevant to what's what's the nature
11	of the email? What's the email?
12	BY MR. UHAR:
13	Q Mikea, what's the email?
14	A I'm sorry Mr. Chair. Are you asking
15	me or are you asking Mr. Uhar what is the nature
16	of this email?
17	CHAIRPERSON ANDERSON: You have the
18	email in front of you. What's the question that
19	he asked you?
20	THE WITNESS: This email states hello
21	Mikea, attached is proof of ABCA requested of
22	continuing Tier 1 violations at two locations for
23	many years and Mr. Farruggio's own 4/7/2015
24	email. Unless Mr. Farruggio plans approved by
25	the USCFA, D.C. ABCA and D.C. DOB approved plans

1	for outdoor sidewalk cafes after 4/7/2015.
2	These operations must be closed down
3	immediately. They can't validly be insured, so
4	I'm copying coping, excuse me, the D.C. Office
5	of Risk Management. The same is true with the
6	summer garden at 1063 31st. No valid occupancy
7	permit for operating that way since it opened.
8	It has never been a problem until somebody gets
9	hurt. D.C. government supported by its taxpayers
10	should not have to pay. Signed John Uhar.
11	CHAIRPERSON ANDERSON: So all right.
12	So what's the question, Mr. Uhar?
13	MR. UHAR: Mikea, could you read the
14	email?
15	CHAIRPERSON ANDERSON: She just did,
16	sir.
17	MR. UHAR: I'm sorry.
18	CHAIRPERSON ANDERSON: She just did.
19	So what's the question you're asking?
20	(Simultaneous speaking.)
21	MR. UHAR: There is the attachment.
22	CHAIRPERSON ANDERSON: I'm sorry?
23	MR. UHAR: There is an attachment.
24	That's just my words. Mr. Farruggio, I sent her
25	a copy of an email Mr. Farruggio sent. Can you
l	

read that Mikea?

CHAIRPERSON ANDERSON: Where are we going with this? Where are we going? Where are we going? I mean I don't --

MR. UHAR: Talk to Mikea. She's the investigator.

CHAIRPERSON ANDERSON: I know sir.

But I'm asking you, I said to you that -- I said to you that she needs to testify that she has specific knowledge about the proceedings today.

MR. UHAR: And she does?

CHAIRPERSON ANDERSON: How does she have specific knowledge that if you sent her an email, that's what it -- you sent her an email, you're talking about allegations. So what specific knowledge would she have? I don't know. I'm trying to find -- you can tell me what --

MR. UHAR: Yeah, what I have. What I sent Mikea was an email from Mr. Farruggio on 4/7/2015 to Jose Martinez of the U.S. Commission on Fine Arts, asking Mr. Martinez to put his U.S. CFA application on hold, and that was April 7th, 2015. And all the permits that are in ABCA and everybody else's position are from before that time, so they were fraudulent.

1	CHAIRPERSON ANDERSON: You're making
2	a you're making a statement, sir. You're
3	making a statement that something was fraudulent.
4	There's a difference. You're making a conclusory
5	statement.
6	MR. UHAR: He pulled his permit. Show
7	me the new permit. That's what I'm asking you.
8	You have investigators. This is a complaint.
9	Why do I have to do your work?
10	CHAIRPERSON ANDERSON: But that's not
11	the purpose of a protest hearing sir.
12	MR. UHAR: This is a complaint here.
13	I mean you're joining them and you know the
14	difference.
15	CHAIRPERSON ANDERSON: You know, we're
16	in an administrative hearing and this is hearsay.
17	You don't know that. We can't prove that.
18	MR. UHAR: This is also, this is also
19	under a Court of Appeals. Why are we doing this
20	now?
21	CHAIRPERSON ANDERSON: We have a Court
22	of the matter was remanded, sir, for you to
23	provide us proof. I mean all you're just
24	throwing stuff on the wall and you're hoping
25	MR. UHAR: Your order, your order is
ı,	

under -- your order under Court of Appeal. Why are we doing this sir? The Court of Appeals agrees with me. Why do we have to go through this all over again?

CHAIRPERSON ANDERSON: Mr. Uhar, the Court of Appeals remanded this case to address four allegations, and that's what we're trying to do.

MR. UHAR: But Mister --

CHAIRPERSON ANDERSON: If you, if you appealed something else sir, the Court of Appeal has not addressed it, and so therefore we need to move on. We need to move on with this hearing, and I don't, I don't see how you -- I don't see how you can state that this witness had direct knowledge. Yes, sir.

MR. UHAR: She has the email. I thought you were asking me a question.

CHAIRPERSON ANDERSON: That's not her having direct knowledge, sir. Anyone, you're providing her an email. I don't see the email. The email is not in the record, and she's not the one who composed the email.

MR. UHAR: It's also in the other complaints that you haven't answered.

Because you provided her an email, so that's direct knowledge 6 7 sir? 8 BY MR. UHAR: 9 Why don't we ask Inspector Nelson, and 0 we'll -- I'll defer to her. So Inspector Nelson, 10 11 what do you think this represents? 12 Mr. Uhar, I am not sure. My protest 13 investigation was submitted on Wednesday, January 14 3rd, 2024. There has been no investigation since 15 that report has been submitted on Wednesday, 16 January 3rd. So I have not and cannot speak to the validity of this email or any of the 17 18 information in it. 19 Inspector Mikea, why did you ask to 20 talk to me and then tell me that you were 21 submitting it on the 3rd? 3	email to her I mean we're talking about an
4	email to her. That's not even in the record.
5	MR. UHAR: It is in the record.
6	CHAIRPERSON ANDERSON: But it's not
7	it's not in the record. Sir, it's not in our
8	case report. It's not in our case report. Is it
9	in the case report Ms. Nelson?
10	MR. UHAR: Yes, it is. Yes.
11	CHAIRPERSON ANDERSON: I did not ask
12	you a question, Mr. Uhar. I'm asking the
13	witness, is this document in your case report
14	ma'am?
15	THE WITNESS: This document is listed
16	under Complaint, ABCA Complaint No. 2 from Mr.
17	Uhar. I can give you the exact
18	CHAIRPERSON ANDERSON: So it's in your
19	case report; is that correct?
20	THE WITNESS: I believe so, Mr. Chair.
21	CHAIRPERSON ANDERSON: If it's in your
22	case report, we can move on with it. Therefore,
23	it's in the record. I just want to all right.
24	I just want to make sure it is in it's in the
25	case report. If it's in the case report, then

1	it's in the record.
2	MR. O'BRIEN: Mr. Chair?
3	CHAIRPERSON ANDERSON: Yes, Mr.
4	O'Brien.
5	MR. O'BRIEN: I object to Mr. Uhar
6	reading his own words to the witness and saying
7	then to the witness isn't that proof of fraud.
8	MR. UHAR: I take it back. I take it
9	back.
10	CHAIRPERSON ANDERSON: I agree with
11	your statement, Mr. O'Brien. I mean it's a
12	conclusory statement that's been made by the
13	witness, and that doesn't prove anything. So as
14	I state, these are it's a conclusory
15	statement. It's not this is not factual, and
16	so that's the that is something that I believe
17	can be addressed in closing.
18	But it's someone making a statement,
19	a conclusory statement, that's not law, that's
20	not fact.
21	MR. UHAR: True, and I apologize. Can
22	Mikea read from that for you?
23	CHAIRPERSON ANDERSON: If it's in the
24	record, yes she can.
25	THE WITNESS: Are we speaking of the

1	highlighted portion in the email, Mr. Uhar?
2	BY MR. UHAR:
3	Q Yes. Yes, Ms. Nelson.
4	A Okay. It does not complete the entire
5	statement of comments that was made. It states
6	that after our review, DCRA is withdrawing your
7	application and you will need to file a new

13	DCRA's website. Useful guidance regarding
14	permitting may be found here.
15	Q Thank you.
16	A Yes, sir.
17	Q So that shows that there's a reason to
18	investigate, and I guess there's no
19	investigation.
20	A Is there a question I'm supposed to
21	answer, Mr. Chair?
22	Q Yes. Did you this has been this
23	complaint has been presented to ABCA before;
24	correct?
25	CHAIRPERSON ANDERSON: Is this a

1 question you can answer, Ms. Nelson? If you 2 can't answer, you can't answer. 3 THE WITNESS: No, sir. I cannot speak to what has been submitted to ABRA before my 4 5 protest hearing. BY MR. UHAR: 6 7 Okay. Did you notice, as an impartial 8 observer, in those five -- in those five 9 complaints, did it seem reasonable to you that the scope was limited to backward-looking, when 10 11 you were presented with current violations as 12 well? 13 I'm sorry Mr. Uhar. I don't quite 14 understand the question. 15 CHAIRPERSON ANDERSON: Mr. Uhar, Mr. 16 This is a protest hearing from 2019, okay. We can only address issues from 2019 going 17 18 backwards. It is not appropriate for us to be talking about issues or complaints in 2019 about 19 20 issues that occurred in the future. 21 MR. UHAR: Okay. But Mr. Chairman 2.2 Anderson, if these are ongoing violations, why 23 couldn't they have been --2.4 (Simultaneous speaking.) 25 CHAIRPERSON ANDERSON: Mr. Uhar, Mr.

Uhar. Mr. Uhar, it could not have existed in 2019. So therefore we cannot --

(Simultaneous speaking.)

CHAIRPERSON ANDERSON: The violations, whatever violations -- if a violation occurred in 2020, 2021, '22, we're going back to 2000 -- we are going back to 2019 to renew the license. I don't see how we can -- I don't see how we can talk about something that happened in 2022-2023, to say that because something happened in 2022-2023, we cannot renew a license in 2019, sir.

You'll have opportunities. I think that -- I think the 2021 renewal is on hold, and then I think in 2024-2025, we're going to have another renewal, where if you want to protest, you'll have those opportunities. But we're talking about incidents that occurred prior to 2019 sir, and that's where --

MR. UHAR: And these are sir, because he's been operating without a certificate of occupancy for the summer garden since 2009, and they picked it up in 2020, and you need to investigate and enforce. Whether you want to or not is fine.

CHAIRPERSON ANDERSON: Do you have

19	most of the claims of fraudulent misstatements
20	have to do with other D.C. government agencies,
21	and I'm not qualified to determine the validity
22	of what another agency submits.
23	Q But you can't you didn't determine
24	that Mr. Farruggio lied to anybody did you?
25	A No, sir.

1	MR. O'BRIEN: Okay, thank you.
2	CHAIRPERSON ANDERSON: Any other
3	questions, Mr. O'Brien?
4	MR. O'BRIEN: No, sir.
5	CHAIRPERSON ANDERSON: Ms. Nelson, I
6	just have I just have one question for you
7	ma'am. You were asked some questions regarding
8	emails.
9	Did you compose the email or any of
10	the documents, or did you have did you compose
11	the email or were you, did you have a part in
12	composing any of the documents that were
13	referenced in the email?
14	THE WITNESS: No, sir.
15	CHAIRPERSON ANDERSON: All right. I
16	don't have any other questions for you. Any
17	other questions by any Board members?
18	Mr. O'Brien, do you have any questions
19	of the witness based on the question that was
20	asked by me?
21	MR. O'BRIEN: No, sir.
22	CHAIRPERSON ANDERSON: Mr. Uhar, do
23	you have any questions, any redirect based on the
24	any brief redirect sir?
25	MR. UHAR: Yes.

1 CHAIRPERSON ANDERSON: Brief, not --2 I don't need you to ask new areas that you 3 didn't cover before sir, okay. REDIRECT EXAMINATION 4 5 BY MR. UHAR: So Inspector Nelson, you saw no 6 7 evidence, not even a reasonable amount of 8 evidence to continue investigations beyond what 9 the scope of the work was based upon what you saw? 10 11 Α I'm sorry? If you were -- if you knowing the 12 13 mandate of ABCA, and what you saw in this 14 investigation, you saw no reason to continue 15 investigating given your five years' experience? 16 There's always a reason to continue 17 investigating. I'm not sure how to answer that 18 question. Well for example, you don't think that 19 20 that outdoor sidewalk cafe that's picked up as a 21 violation in 2020 needs to be investigated? 2.2 Α I'm sorry, was it picked up as a 23 violation by ABCA? 2.4 0 Right. 25 Α Or ABRA at the time, or who was that

1	picked up by?
2	Q Well, it was presented to you. It was
3	picked up by DOB by the Department of
4	Buildings. I mean how does this differ from say
5	Charcoal Town?
6	A I'm not familiar with Charcoal Town.
7	MR. O'BRIEN: Objection, objection Mr.
8	Chair. This is far beyond any reasonable
9	redirect.
10	CHAIRPERSON ANDERSON: Sustained.
11	MR. UHAR: Okay, okay. So it's your
12	testimony here that you saw no evidence that you
13	should refer evidence of misstatements to other
14	agencies? You saw nothing that warranted
15	interdisciplinary coordination to try to stop
16	what could be costing, you know? You saw nothing
17	that was worth investigating? Nothing in this
18	case seemed abnormal to you; correct?
19	THE WITNESS: I believe you're asking
20	if
21	MR. O'BRIEN: Objection.
22	THE WITNESS: I'm sorry.
23	CHAIRPERSON ANDERSON: I'm sorry.
24	What's the nature of the objection sir?
25	MR. O'BRIEN: Yes. The question that

1 I -- the ultimate question I asked Investigator 2 Nelson was whether apart from allegations of Mr. 3 Uhar, whether she independently determined that Mr. Farruggio lied to anyone? Her answer was no. 4 5 Now what Mr. Uhar is -- and that's the scope of the cross-examination. 6 7 Mr. Uhar's gone far beyond it, and 8 basically hectoring Investigator Nelson to say 9 she should go out and pound the pavement more, based on his allegations. 10 11 CHAIRPERSON ANDERSON: Mr. Uhar, as I 12 stated, this is not a -- this is not an 13 opportunity to ask questions that weren't asked 14 before. So you'll have -- I'll provide you with 15 a brief opportunity to ask, to redirect questions 16 of the witness sir. So do you have any other 17 questions that you need to ask? 18 MR. UHAR: Yes. Inspector Nelson, you 19 see no reason to investigate any of these other 20 complaints, and you see no evidence of any crimes 21 presented in prima facie evidence, presented in 2.2 documents and blacklines and stuff from the 23 public record. You see nothing?

24	ability, and let's move on.
25	THE WITNESS: Yes, sir. I cannot give

1 my opinion at all as an ABCA investigator. 2 only speak to the facts of my investigation. BY MR. UHAR: 3 And the facts didn't point towards 4 0 5 further investigation? Maryland and I've been an industrial real estate broker since I graduated from the University of Chicago with a degree in History. I've been selling warehouses and industrial properties since 1982, and I started my own company in 1986.

I am well aware with the land records and I thought that I had presented prima facie evidence of misdemeanors, and I found through my records numerous instances of fraudulent misstatements that I presented in a series of complaints that were never answered, in violation of DCMR.

Now I'm sitting here again with a protest and all I can say is all the evidence I've presented is true and faithful, and the only reason I'm doing it, I don't hate Mr. Farruggio, but nobody is above the law. And he's been abusive to me and my neighbor, Louise Sagalin (phonetic), whose trees and garden he destroyed in violation of the Tree Protection Agency, and he worked with other people to move that tree easement onto 0824, where Mr. Farruggio now keeps

his umbrellas.

The violations also include, that I presented, are the fact that despite many protests, there has never been any bona fide evidence presented by Mr. Farruggio or his attorneys regarding the getting of an occupancy permit on public space.

I believe that this all connects in with the Executive Office of the Mayor, who had Richard Livingstone give permission to run outdoor sidewalk cafes, which are now permitted. The fact, the bigger fact is what was happening before and after these, he got these permits, he was operating illegally from 2009 to 2015. Or was he operating legally from 2009 to 2018? 2015 to 2018?

You look at the land records. You go to D.C. Scout. You'll see that he's mixed 1063 with 1065. He talks about the moving things around, and if you look at the records, you will see that it's fraud based on the original sin of his being connected with Fratelli La Bufala, which he, who he knew and he's lied about and he lied about his occupancy permits for outside, and he never had a sidewalk cafe. So you know,

1 that's all I can say. 2 CHAIRPERSON ANDERSON: All right. 3 Let's, all right. So you're done sir? MR. UHAR: Yes. 4 5 CHAIRPERSON ANDERSON: Mr. O'Brien, do you have any questions of Mr. Uhar? 6 7 CROSS EXAMINATION BY MR. O'BRIEN: 8 9 Yes, I do. Mr. Uhar, you have used 0 the word repeatedly counterfeit in the context of 10 11 permits. What do you mean by counterfeit? You know, I think of counterfeit as 12 13 fraudulent. I'm not an attorney. It's just a 14 lie. For example, you know, Meredith Moldenauer 15 says that there's a 15 foot setback when she's 16 trying to get his outdoor sidewalk cafe over a 17 public alley, but there's no, you know, there's 18 no backyard. There's no, there's no -- you don't 19 have it. I mean and the fact of the matter is, 20 21 when you're talking about land records, of which 2.2 I know a little bit, I know enough to know it's 23 either 29 feet where it's 71 feet of permits either for 1063 or it's for 1065. You have two 2.4

properties, two owners, two permits. If I'm a

1 free market here, the government that governs 2 best is a government that governs least, and the 3 best way to govern least is to have strict enforcement. 4 Mr. Farruggio, through his people, 5 have just ruined the land records for those three 6 7 properties. 8 I'm going to ask you again, 0 Okay. 9 what is the meaning in your mind of the word counterfeit? 10 11 Made to deceive. 12 Are you suggesting --13 Something fraudulent passed off as Α 14 real. That's what counterfeit is, something 15 fraudulent. 16 Okay, all right. Are you, are you 17 questioning or suggesting that Mr. Farruggio 18 himself printed out permits that don't 19 legitimately come from the government agencies 20 they purport to come from, that he might have a 21 printing press in his basement? 2.2 Well you know, you can't hide behind 23 your attorneys, and you can't hide behind your 2.4 architects. You know, you can only have one

captain of the ship and, you know, this -- I

don't know. Is he above the law? You tell me.

Q Your allegations regarding the fence permits, I want to sum up the allegation, and I invite you to correct me if I'm wrong. The allegation is that the fence permit is on -- it recites Lot 64, when the fence was actually erected on Lot 842.

A Correct.

O Is that an accurate statement?

A Yes, correct. But he also blocked another ABCA licensee, Bluefin Tuna and I, who share a common access, through the alley by a settlement agreement originally executed the Alamo Grill of Georgetown.

So we've been using the alley. We move our stuff back and forth through the alley. My bicycles are trash, and on the 22nd of March, Mister -- or the 30th of March, Mr. Farruggio erected a fence that blockaded us for over a year until April 12th, when Mr. Farruggio last talked.

Q All right. Let me ask again. Is your allegation that the fence permits are counterfeit? Does that allegation arise from the circumstance that the permits say Lot 64, but the fence was erected on Lot 842?

1	A Correct.
2	Q Okay. Now there are two permits, are
3	there not?
4	A No. He just he just filed he
5	filed two copies on 842. I don't know why. He
6	had four, it appeared to me that they had four of
7	the same permits, two on the front, two on the
8	back, because he likes to mix 1063 with 1065. If
9	you look at the Scout records, they're
10	commingled.
11	Q Okay. I have, I have in front of me
12	two permits.
13	A Okay.
14	Q Both dated, both dated October 29th ,
15	2021
16	(Simultaneous speaking.)
17	Q Say again?
18	A How would I know?
19	Q Well, I assume the permits you're
20	saying they're counterfeit.
21	A Oh yeah, okay. Yeah, go with them.
22	Yeah, okay.
23	Q All right. One permit ends in the
24	number 49, and the other permit ends in the
25	number 50. Do you have those?

1	A No, but you can read them to me.
2	They're here somewhere. I've got a pretty good
3	memory.
4	Q Okay. Are you suggesting that the
5	permit, the stated permit dated 10/29/21, which
6	ends in the number 050, and authorizes the
7	erection of the fence on Lot 64, you're alleging
8	that it is counterfeit because it doesn't recite
9	Lot 842?
10	A Yes, and also because it didn't no
11	fence was replaced there. There was, there was a
12	new fence that was erected across Lot 0842, and
13	the public access for ABCA licensee Bluefin Tuna,
14	Bluefin Sushi and us at 3075, yes.
15	Q So you're saying that the fraud
16	perpetrated by Mr. Farruggio is getting a permit
17	for Lot 64, when he erected the fence on Lot 842?
18	That's the fraud?
19	A Yes, yes.
20	Q Okay. I'm going to show you can we
21	elevate a document, Mr. Chair?
22	CHAIRPERSON ANDERSON: Mr. Orellana,
23	can you please allow Mister who is who
24	needs to elevate it? You or Ms. Mahmoud?
25	MS. MAHMOUD: I do Mr. Chair, and I

1	believe that I'm permitted to.
2	CHAIRPERSON ANDERSON: Okay, fine. Go
3	ahead, if you have that right. Okay, go ahead.
4	BY MR. O'BRIEN:
5	Q Okay. We'll show you what is D.C.
6	government stamped application for the fence
7	permit, and I'm going to ask you to note that in
8	the red, on the upper red, there's numbers, the
9	number and date typed in, and the permit number
10	is 050. Do you see that? This is the
11	application for the permit. It's 050. Do you
12	see that, Mr. Uhar?
13	A Yeah, I do see that.
14	Q Now do you see at the very top of the
15	document the application is for Square 1198, Lot
16	842?
17	A Yes, sir.
18	Q Do you see that?
19	A Yes, sir.
20	Q So you see the application was filed
21	for 842, but it came out of DCRA as Lot 64.
22	A That's incorrect sir, because if you
23	if you were to check the CFA things, Mr.
24	Farruggio went into to try to get a permit to put
25	some containers, and he tried to get a permit to

1	fence, and he needs USCFA approval. That fence
2	permit is probably part of the ongoing fraud that
3	I've found in the various agencies in D.C. So no
4	
5	Q You just testified in response to my
6	question that the fraud was Mr. Farruggio
7	applying for Lot 64, when in fact he erected the
8	fence on 842, but you've now seen that he applied
9	for 842 with this same permit number?
10	A But he doesn't have
11	Q 050. Now I ask you
12	A Okay.
13	Q I ask you how do you maintain now that
14	you've seen this, that there was any fraudulent
15	conduct on Mr. Farruggio's part in respect to
16	application for this supposedly counterfeit
17	permit?
18	A Okay. Two easy answers. One, it has
19	not USCFA approval, which he needs to put a fence
20	on the premises. Two, it wasn't the replacement
21	of the fence, which the permit states. It's a
22	replacement. It's not a new fence. That permit
23	is not for a new fence.
24	Q All right. I'll change the subject.
25	Can we call up the plat again?

1	A And one more thing. The proof is in
2	the pudding. If Mr. Farruggio had a permit, he
3	would have kept it up. He pulled it down because
4	he knows he doesn't have a permit, and other
5	thing is in my exhibits that were presented to
6	everyone, was a stop work order that was up for
7	over 100, over 365 days and that's a Tier 1
8	violation every day.
9	Q All right. Now on the screen is your
LO	Exhibit 8, which was discussed before, which is a
1	plat from the surveyor.
L2	A Uh-huh.
L3	Q Now you pointed out that Lot 64 is
L4	only 28.58 in width, but then you referred back
L5	to his 2015 public space permit, which shows 71
L6	feet.
L7	A That's correct, but it's only for one
8	lot.
L9	Q Right. Lot 64, Lot 64
20	A Is 29 feet.
21	Q Right, and that's 1063; correct?
22	A Yeah, and that's the only one
23	that's the only one the permit's for. It's not -
24	- the permit that he had
25	(Simultaneous speaking.)

1	Q For Lot 08
2	A No, he doesn't have that. Look, it's
3	Lot 64 on that permit. It's not Lot 64 it's
4	not Lot 64 and 0819. It's Lot 64.
5	Q But it says 71 feet; correct, the
6	permit in 2015?
7	A But that's, and that's the fraud, sir.
8	That's the fraud. It's one lot. One permit for
9	one lot. You know that.
10	Q Now can you answer my next question?
11	A Sure.
12	Q It shows Lot 819 at 42.20 feet.
13	A Sure.
14	Q Have you added up the two numbers, or
15	do you want me to do the arithmetic
16	A No, I get it. The fact of the matter
17	is you get one permit for one lot. He doesn't
18	get two permits for two different owners on one
19	lot. He had to get a new permit for 1065. That
20	would have gotten him to 71. But David Harrison,
21	and what date was that again sir? What date is
22	that permit?
23	Q The fence permit or which permit? Oh,
24	this public space permit?
25	A Yeah, yeah.

1	Q With no street address at all on it.
2	A Yeah, I pointed that out.
3	Q Yeah, is January 28th, 2015.
4	A Okay. So what
5	Q I'm going to invite your attention now
6	I'm going to invite your attention now to what
7	we just put up on the screen, which is a permit
8	dated July 9th, 2018. Do you see that?
9	A Yes.
10	Q And do you see it has the same
11	description in italics of 70 feet?
12	A Yep. That's another example of fraud.
13	Q And can you see that the address for
14	the permit is 1063 and 1065?
15	A Yes, but that's that's counterfeit,
16	because if you look up top, it says Lot 64 and
17	Square 1198, and it refers to a Permit No. PA-
18	10160729 that both go back to 1063 31st Street,
19	but was extinguished when, when Fratelli La
20	Bufala kicked out and, you know, the permit
21	lapsed. You had to go all new, so continue.
22	Q Will you concede that this permit
23	actually came from Department of Transportation,
24	that it wasn't printed up by Mr. Farruggio in his
25	basement? Will you concede that it actually came

1	out of Department of Transportation?
2	A Sure, and it probably had but it's
3	still fraudulent.
4	Q Okay. Where is it fraudulent?
5	A Because it's Lot 65 in 1198.
6	(Simultaneous speaking.)
7	Q It has the same street, the correct
8	street address and the correct measurement?
9	A No. No, it isn't. It isn't, sir. It
10	isn't, and if you would have let me if I could
11	have gone back to Courtney Williams and some of
12	the stuff with Mikea, you'd see. That is not
13	that is a fraudulent permit. That is a
14	counterfeit permit intended to deceive. So
15	continue.
16	Q Yes, all right. The street address is
17	correct, 63 and 65.
18	A Sir, you get one
19	(Simultaneous speaking.)
20	Q Please answer my question. Please let
21	me finish my question, Mr. Uhar.
22	CHAIRPERSON ANDERSON: All right, hold
23	on, hold on. We have a court reporter trying to
24	capture the testimony, so I need you to ask a
25	question Mr. O'Brien. Mr. Uhar, you need to

1 listen and then you respond please. I can't have 2 you two talking over each other. 3 MR. UHAR: Sorry. MR. O'BRIEN: All right. I need to 4 5 call the permit back up. (Off mic comments.) 6 7 BY MR. O'BRIEN: 8 We're told it's lagging on the -- oh 0 9 there it is, okay. Mr. Uhar, please let me 10 finish my question, okay? 11 Α Okay. 12 All right. The permit says 1063 and 13 The italics say 71 feet, which you agree 14 is both, both lots. But your objection to it is 15 that it only says Lot 64; is that correct? 16 Yes, sir, and that is because each lot 17 gets its own occupancy permits when you have 18 different property owners, and Mr. Corricidi 19 (phonetic) owns Lot 1063, and as I pointed out 20 before, it's for Lot -- it's for Lot 064 in 21 Square 1198 and it is -- and that was added 2.2 later. 23 If you look at the D.C. Scout records, 2.4 you will see where Mr. Farruggio and his 25 accomplices have consistently been commingling

1	both addresses to obfuscate, confuse and
2	fraudulently engage in activities that do not
3	benefit the city, the taxpayers and the people
4	that play by the rules.
5	Q All right. Still talking about this
6	permit, whose mistake is it?
7	A It's not a mistake. It's a willful,
8	fraudulent act by Mr. Farruggio and his
9	assistants, that's permeating all these different
10	agencies.
11	Q But I understood you to say if the
12	permit also said Lot 819, you would not have an
13	issue. So the fraud
14	A Sir, sir, sir.
15	Q Please listen, Mr. Uhar.
16	A That's not what I was saying.
17	Q The fraud I hear from you is that it
18	doesn't say Lot 64 and Lot 819? Is that the
19	fraud?
20	A Mr. O'Brien, you can have he would
21	have, he would have to have two permits for each
22	owner. He would have the 1063, which is the one
23	that he had, and then he joined 1065
24	fraudulently. That is what I think because
25	Q I suggest, I suggest to you that with

both street addresses, with the combined lot 1 2 width in the permit, that any mistake in this permit is the mistake of the D.C. government? 3 4 Α No. 5 Now if you want to accuse the D.C. government of fraud --6 7 Α No, I don't. What I'm accusing Mr. 8 Farruggio and his accomplices is burdening D.C. 9 government by, by commingling addresses and then, 10 and then these poor intake specialists have to --11 they play a game on them, and it's just, it's 12 just how many hours have we spent on this, on 13 this stuff? 14 I mean, you know, you've got to tell 15 the truth on the land records. That's the way 16 this whole system works, and if he had a permit for 1065, it would say 1065 and it would say Lot 17 18 0819 and it would say Robert E. Moore, and he would have insurance for each of them, and that's 19 20 not what this says, and it comes in at 2015, 21 which makes me ask you this question. 2.2 If this is when he got them and he was 23 operating illegally all these years before, how many Tier 1 violations does this add up to? 2.4 25 0 You mentioned Courtney Williams?

1	A Yes.
2	Q Now on the screen is an email to you
3	in response to a complaint from Courtney
4	Williams.
5	A Uh-huh.
6	Q And she tells you right in that email
7	that the permit was amended on November 17th,
8	2023 to include both Lot 64 and 819?
9	A Yes.
10	Q Okay. Now so she told you that
11	Courtney Williams of Department of Transportation
12	told you the permit covered both lots, but you're
13	screaming fraud today. How do you justify that?
14	A Hold on, let me get let me get my
15	response to her. Because it is fraud. It's
16	fraud pure and simple, for the reasons I just
17	told you.
18	MR. O'BRIEN: Well Mr. Chair, I have
19	no further questions.
20	CHAIRPERSON ANDERSON: Close your
21	screen please.
22	THE WITNESS: I have to, I have to
23	answer his
24	CHAIRPERSON ANDERSON: No, Mr. Uhar.
25	

1	THE WITNESS: Here we go.
2	CHAIRPERSON ANDERSON: Mr. Uhar.
3	THE WITNESS: Yes.
4	CHAIRPERSON ANDERSON: You're being
5	questioned. There's no the attorney has
6	THE WITNESS: He asked me a question.
7	CHAIRPERSON ANDERSON: And you
8	answered your question of him. So there's no
9	pending question.
LO	THE WITNESS: No. He asked me a
L1	question and I have an answer. He asked me about
L2	the question of Williams, and I told him to wait,
L3	so I could pick up the email and
L4	CHAIRPERSON ANDERSON: You answered
L5	the question, and then you said you have an email
L6	to explain this. Sir, I'll give you an
L7	opportunity to explain yourself. Any questions
8 .	of Mr. Uhar by the Board?
L9	All right, sir. I'll give you a
20	minute if you need to provide any clarification
21	of any questions that Mr. O'Brien just asked you
22	sir.
23	REDIRECT EXAMINATION
24	THE WITNESS: Thank you. This was,
25	this was an email sent Monday, January 8th at

1 8:09 to Courtney Williams. 2 CHAIRPERSON ANDERSON: What year? 3 What year sir? This year, this year, 4 THE WITNESS: 5 2024. 6 CHAIRPERSON ANDERSON: Okay. 7 THE WITNESS: To Courtney Williams. 8 This was responding to Courtney and I had Mikea 9 Nelson and Susanna Swarez (phonetic) at EOM and, 10 you know, it is what she says. Il Canale, blah 11 blah blah. I said good morning Ms. Williams; as 12 shown in the evidence submitted to you, Mr. 13 Farruggio of Il Canale asked to have his USCFA 14 approval put on hold on 4/7/2015. 15 So your January 1 approval is not 16 valid because it lacks USCFA approval of plan submitted after 1/21/2015. But it should be 17 18 4/7/2015. You do understand this is a federal 19 offense. How can DDOT lawfully approve either 20 outdoor sidewalk cafes when the pictures clearly 21 show they're not at grade. 2.2 Please send over your inspection team 23 for immediate enforcement after speaking with Ms. Edwards. Ms. Edwards is aware of the situation 2.4

with Il Canale both in front of 1063 and 1065

31st. Marvin McFadden of her office closed down the sidewalk cafes. He also ordered the structurally complete summer garden over the public alley be torn down.

Mr. Farruggio reopened his illegal sidewalk cafes the next day. Then the Executive Office of the Mayor weighs in, and enforcement backs down all across D.C. government. I've spent a lot of time at DCRA, starting with microfiche and Open William, when those -- on hot days at 614 H N.W.

D.C. has come a long way, but it was nice to see the old records were preserved. I appreciate the honest effort most D.C. employees put into their jobs, to see that the law is applied fairly to all. D.C. DDOT, DOB and other agencies have to assume that the information being presented is as truthful as attested to run efficiently and fairly.

If it is found to be untruthful, justice must be swift. It's the least we can do to reduce the workload for an overburdened staff and ensure good government. In the interest of good government, the Il Canale case should be investigated thoroughly. I am very interested in

1 learning how Il Canale's summer garden over a 2 public alley advanced at the stage where it was 3 put on the ANC agenda. Mr. Farruggio bragged to me and my 4 5 brother about his quardian angels in D.C. 6 government. They were and are not good angels 7 and must be rooted out. I consider it my civic 8 duty and I'm happy to help. Please advise. 9 Thank you. I understand the summer garden is on 10 11 private property. At the request of Ms. Swarez 12 can get with me for that on insured liability. 13 John Uhar. And what I gave her was a statement 14 from Mr. Livingstone that now permitted the 15 sidewalk cafes, because there was a lot of things 16 going around at that time. 17 CHAIRPERSON ANDERSON: All right. 18 Anything else sir? 19 THE WITNESS: Nope. 20 CHAIRPERSON ANDERSON: All right, 21 thank you. 2.2 Mr. O'Brien, did you wish to call any 23 rebuttal witness or do you waive that right to do 2.4 so? 25 MR. O'BRIEN: No more witnesses.

1	CHAIRPERSON ANDERSON: All right,
2	thank you. So we're ready for closing. Do you
3	want to take a break or do you want to go
4	straight to closing? I think Mister, let's say -
5	-
6	MR. UHAR: I'd like to take a break.
7	Could we?
8	CHAIRPERSON ANDERSON: All right. So
9	we'll take it's 4:46. We're off the record
10	until five o'clock, and then we'll, we'll
11	we're off the record until five o'clock, and then
12	the parties will, we'll do closing and
13	specifically what it is that the parties are
14	requesting from ABCA.
15	Okay. So we're off the record until
16	five o'clock.
17	(Whereupon, the above-entitled matter
18	went off the record at 4:46 p.m. and resumed at
19	5:00 p.m.)
20	CHAIRPERSON ANDERSON: We're back in
21	the record. Mr. Uhar.
22	MR. UHAR: Yes, sir.
23	CHAIRPERSON ANDERSON: All right. So
24	we're now ready for closing, and the Applicant
25	goes first.

MR. O'BRIEN: Mr. Chair, Members of the Board, Mr. Uhar threw around the word counterfeit, describing a couple of permits and approvals. I think our cross-examination established that Mr. Uhar's definition of counterfeit is not the commonplace definition of counterfeit, just like Mr. Uhar use of the word fraud or fraudulent.

Not every innocent mistake, inadvertence or discrepancy is proof of fraud, and to illustrate that, I look at what we called Exhibit 8, which was the plat. It lists -- it depicted or described a one-story brick building on Lot 842, but the testimony is unchallenged that there's no structure on 842.

But this is -- this document was generated by the Surveyor for the District of Columbia. Did the Surveyor engage in fraud? No, I don't think so. He may have made a mistake. And then we looked at the sidewalk cafe permit dated 2018. The permit listed both street addresses 1063 and 1065. It listed the correct length of the sidewalk cafe as 71 feet, which combines the two lots. It only listed one of the two lot numbers on the permit.

1 Did the Department of Transportation 2 engage in fraud when it issued that permit? 3 don't think so. I suggest not. So I have to ask the Board to be skeptical any time Mr. Uhar 4 5 throws about the word fraud, because I don't think Mr. Uhar's definition of fraud comports 6 7 with any common definition of fraud, and it 8 certainly doesn't comport with the requirements 9 of Bennett v. Kiggins, which is the Court of Appeals' case on the elements of fraud. 10 11 The bottom line is that given every 12 opportunity on remand, in pleadings and today, 13 Mr. Uhar has not established that Mr. Farruggio 14 or any attorney or architect acting on his behalf 15 knowingly misled any government agency. That's the bottom line. 16 17 He's had the opportunity to prove 18 fraudulent misstatements on the part of the 19 licensee, and we heard not one syllable of proof 20 that Mr. Farruggio or any agents acting on his 21 behalf ever knowingly misled any government 2.2 agency. Thank you.

1 CHAIRPERSON ANDERSON: Closing please. 2 MR. UHAR: Yes. I don't -- can you 3 see me? 4 CHAIRPERSON ANDERSON: Nope, but I can 5 hear you. Okay. Well, here we are 6 MR. UHAR: 7 again, five years later, complaints still 8 unanswered, wrapped into protests, derailed by 9 legal language and start all over again. 10 O'Brien may know ABCA law, but I don't think he's 11 familiar with real estate as me, and when he 12 claims that the D.C. Surveyor signed that paper, 13 I'm pretty sure that the D.C. Surveyor makes 14 somebody go out, Mr. Maiden, go get a survey and 15 present it to him as truthful and they just take 16 it in. So the correct width and address but 17 18 not having the correct lot and square, no. 19 That's not, that's not DDOT's fraud. That's Il 20 Canale, and I don't know what kind of definition 21 of fraud Mr. O'Brien is talking about. 2.2 think that the prima facie evidence that I 23 presented was never rebutted, and it's more than 2.4 prima facie. It speaks for itself.

I mean where are we going to go when

we have people submitting false documents to government agencies, here and there and everywhere, commingling Scout records? I mean I've been an industrial real estate broker for a long time. I've put up with his threats. I've had him spit upon me and, you know, I would have loved to have solved this a long time ago.

Who wouldn't want to be a neighbor to a nice restaurant? But he's proven that he can't keep the place clean, and he will not follow the law and it's not just me. Ms. Sagalin, and he's still up to it. And the last -- and he's also -- it's, you know. As a guy that's in the land records business, to see them desecrated and commingled and mumble-jumbled up and then these excuses, it's just, it's terrible.

So I'd like to just end by reading my Protest Information Form, and so anyway, the action that I was requesting, being requested is the revocation of the liquor license for fraudulent misstatements and documents presented to D.C. administrative agencies, and I think I've presented that.

As I said, that's all prima facie. A lot's either 28 feet or it's not. A setback's

either 15 feet or it's not. You either have an occupancy permit for the second floor, or you don't. So the action being requested, the issues I will present to the Board for resolution are:

Is the Alamo Grill -- no one. The Alamo Grill of Georgetown transferred its ABCA rights to FLB DC, not Il Canale. This means anything issued claiming rights under Il Canale from the Alamo Grill is false.

Second, can the Mayor's office grant
Il Canale a sidewalk cafe without USCFA approval,
and if DCMR requires a seven member ABCA Board,
are decisions of a three member Board legal and
fair, and four, in this instance is ABCA adhering
to its mission statement or being arbitrary and
capricious?

I'd like to comment that I had to put this all together pretty quickly, because I kept hoping that we would wait to -- until we got the D.C. Court of Appeals on this backward-looking order, when crimes are still being committed. But I was rushed into this, and I have my list and once again, I made a -- I forgot to list the witness' subpoena, so I'd like to list who they were.

I wanted to call Giuseppe Farruggio, a hostile witness. ABCA must compel Mr.

Farruggio to testify, to rebut evidence of fraudulent statements and documents submitted on his behalf, on his behalf to D.C. administrative agencies and USA.

Livingstone. He's Mayor Bowser's agent, and my
testimony was a hostile witness. ABCA must
compel Mr. Livingstone to provide evidence that
the Executive Office of the Mayor complied with

The third witness I wanted to call was Meredith Moldenauer, Esquire, who was Il Canale's zoning attorney. A hostile witness. ABCA must compel Ms. Moldenauer to show the lot setbacks in her D.C. office submittal. I'm still awaiting DC OZFOA and the summer garden over the public alley questions.

The fourth I wanted to take was
William Maiden, and a hostile witness. ABCA must
compel Mr. Maiden to testify on the building
plans and documents he submitted to D.C.
administrative agencies, and the last was Robert

Lee Moore, who is Il Canale's landlord, a hostile witness. ABCA must compel Mr. Moore to testify on the structural changes Mr. Farruggio made to his building and Protestant and neighbors historical alley access.

I'd like to mention that this would be no way inclusive, except for the limitations set by D.C. I would also like to call the ANC Commissioners and the CAG, and the Executive Office of the Mayor, but something's going to dump from there.
