3 CHAIRPERSON ANDERSON: The next case on
4 our calender is Case Number 24-251-00256, Moi Moi
5 Restaurant, License Number 120466. This is a
6 Summary Suspension Hearing. This is an
7 establishment that was closed by the Chief of
8 Police. The Board voted to close the facility.

9 The licensee requested as his right an
10 expedited hearing. The Board cancelled most of
11 this afternoon's cases to accommodate the
12 licensee so we could have the hearing today.
