5 that you will be relying on at the hearing.
6 Failure by each party to exchange documents,, the
7 witnesses seven days prior to the hearing the
8 Board is empowered to prevent that side from
9 moving forward to rely on those documents and
10 witnesses unless good cause is shown.

14 Thank you.
