8 So, let me start back over. We're doing
9 the Alcohol Licensing Agenda. All right. So, on

9 approval.

10 And number six, review request to replace
11 the current vessel with a different vessel,
12 resulting in a reduction in capacity from 600 to
13 450 passengers. This is for the Inner Harbor

9 126762. The licensee did not pay the annual fees.

10 Number 15, it's the Crank Corner, License
11 No. 127573. The licensee did not pay annual fees.

12 Number 16, it's All the Buzz, License No.
13 133067. The licensee did not pay annual fees.

14 Number 17, it's Adegoke, A-D-E-G-O-K-E,
15 Holdings LLC, License No. 133578. The licensee did
16 not pay annual fees.

17 And number 18 is Lyfted Essentials,
18 License No. 129325. The licensee did not pay annual
19 fees.

20 So, therefore, I make a motion that the
21 ABC Board issues cease and desist orders for those
22 establishments.

20 calendar at 1:30 p.m.


