4 everyone, and welcome to the afternoon session of
5 the ABC Board.

6 My name is Donovan Anderson, Chairman of
7 the Board. We're joined by four other Board members
8 this afternoon. They are Mr. Silas Grant, Ms. Teri
9 Janine Quinn, Mr. David Meadows, and Mr. Ryan Jones.

10 I just want to provide some background
11 information. We have five cases scheduled this
12 afternoon. Once a case is called, I will take a
13 moment for our IT specialist to elevate the rights
14 for each party to enable their camera and
15 microphone.

16 Then, and only then, will you have the

18 not been heard, you will remain muted and your camera
19 will be disabled.


