3 CHAIRPERSON ANDERSON: The next case on
4 our calendar is a show-cause hearing status. This
5 is for Case No. 25-CC-00020, Whole Foods Market
6 Group, License No. 109870.

7 Good morning, again, Mr. Orellana. Can
8 you please elevate the Government and the Licensee
9 in this case, please?

10 MR. ORELLANA: Sure thing. I only see the
11 Government. Anthony Celo, access elevated. And
12 I'll check in the chat.

13 CHAIRPERSON ANDERSON: Thank you.

14 MR. ORELLANA: I'll also try the 202
15 number, just in case.

16 MR. CELO: There we go. Good morning.

17 CHAIRPERSON ANDERSON: I think Mr. Mixon
18 is -- is that him for this case?

19 MR. CELO: Yes, Mr. Chair.

20 CHAIRPERSON ANDERSON: Yes, Mr. Mixon.

12 Mr. Celo, are there any preliminary
13 matters in this case?

14 MR. CELO: Nothing preliminarily. I will
15 note that the parties have reached an agreement in
16 principle. We are still working out the details.

17 So, that should be before the Board before too long.

18 CHAIRPERSON ANDERSON: All right. Well,
19 thank you.

20 All right, then, with that said, this
21 matter is now settled. It is scheduled for a show
22 cause hearing on February 11th at 10:30 a.m.

23 I just want to remind the parties that if
24 this matter goes to a show cause hearing, the parties
25 are required to disclose documents and witnesses

1 seven days before the hearing.

2 Failure by either side to disclose
3 documents and witnesses seven days prior to the
4 hearing, the Board is empowered to prevent that side
5 from moving forward.

9 CHAIRPERSON ANDERSON: Thank you. Have


