CHAIRPERSON ANDERSON: We're at the end of our calendar for the day, for the morning, the end of our morning calendar. Now since we're done, we have disposed of our morning calendar, let us do our legal agenda for the day.

The first matter on our Legal Agenda for the morning is Review of Offer in Compromise in Lieu of Hearing, dated January 26, 2023, for case No. 22-CC-00023, Quality Convenience Store, License No. 083074.

The Offer in Compromise is as follows:

Charge 1, fail to ascertain legal aid, Statutory Authority DC Code Section 25783. A warning will be issued for Charge 1.

For Charge 2, sale to minor, Statutory Authority DC Code Section 25781. There will be a fine of \$2,000 payable within 30 days or the license shall be suspended indefinitely until the fine is paid.

Also part of Charge 2 is a suspension. The license will be suspended for five days. All five days stayed for one year. Also on Charge 2, all employees who serve alcoholic beverages in

1 the establishment must complete an alcohol
2 training program within three months from the
3 date of the Offer in Compromise.

4 Charge 3, no ABC manager, Statutory
5 Authority DC Code Section 25701. There is a fine
6 of \$250 payable within 30 days or the license
7 shall be suspended indefinitely or until the fine
8 has been paid.
