3 CHAIRPERSON ANDERSON: All right. The
4 next case on our calendar is Case Number
5 21-CMP-00036, Champion Kitchen, License Number
6 103055.

7 Ms. Fashbaugh, can you please elevate
8 the rights of the Licensee in this case, please?

9 MS. FASHBAUGH: ***11:03:32, Sidon
10 Yohannes is actually representing Champion
11 Kitchen, and her rights have been elevated.
12 Thank you.

13 CHAIRPERSON ANDERSON: Thank you. All
14 right, good morning. Mr. Jordan, can you please

15 CHAIRPERSON ANDERSON: All right, Mr.
16 Jordan spell and state your name for the record,
17 please?

18 MR. JORDAN: Of course, James Jordan
19 on behalf of the District. That's JAMES JORDAN.

20 CHAIRPERSON ANDERSON: Good morning,
21 Ms. Yohannes. Can you please spell and state
22 your name for the record, please?

23 MS. YOHANNES: Good morning, Sidon,
24 Yohannes on behalf of the Licensee. And that is
25 SIDON YOHANNES.

1 CHAIRPERSON ANDERSON: All right, Mr.
2 Jordan, are there any preliminary matters in this
3 case?

4 MR. JORDAN: No, Mr. Chairperson. The
5 Government does not have an OIC to present at
6 this time.

7 CHAIRPERSON ANDERSON: All right,
8 thank you.

9 When this matter is scheduled for a
10 show cause hearing on March 2nd, 2022, at 1:30
11 p.m. And I just want to remind the parties that
12 seven days before the hearing, if we're moving
13 forward with the show cause hearing, each party,
14 they are directed to exchange their documents or
15 witnesses seven days prior to the hearing.

16 If the documents and witnesses are not
17 disclosed to each side and to ABRA Legal, if a
18 motion is raised to prohibit the introduction of
19 documents and witnesses that have not been
20 disclosed, unless either side can show good
21 cause, the Board is more likely to grant the
22 motion.

23 So I just want to, again, remind
24 everyone that seven days before the hearing that
25 each side is required to exchange documents and

1 witnesses, all right.

2 MS. YOHANNES: Thank you.

3 CHAIRPERSON ANDERSON: Thank you.

4 Have a great day.

5 MS. YOHANNES: You too.
