10 follows, the respondent agrees to vacate the
11 premises and agrees that, with the exception of
12 retrieving any personal or business property from
13 the landlord, it has no right to occupy the
14 premises.

15 Number two, respondent agrees --
16 affirms to cease all unlicensed cannabis sales on
17 the premises and online.

18 Number three, respondent agrees not to
19 sell cannabis and cannabis products at the
20 premises, online, or at any other location in the
21 District of Columbia without a medical cannabis
22 retailer license.

23 Number four, respondent is not
24 precluded from proceeding with its pending
25 medical cannabis retailer license application,

1 but the summary closure may be considered by the
2 Board.

3 Number five, if respondent does not
4 issue a medical cannabis retailer license or
5 internet retailer license, the summary closure
6 shall remain in effect as to respondent.

7 I therefore make a motion that the
8 offer in compromise be accepted. Is there a
9 second?

10 MEMBER JONES: Mr. Jones, I second the
11 motion.

25 Medical Cannabis Second Addendum.

1 The first matter on our second
2 addendum is the Review of an Offer in Compromise.
3 This is for the landlord, for KAE-Green
4 Department Weed, case number 24-ULC-00055,
5 Unlicensed Establishment.

6 The offer in compromise as the
7 landlord is concerned is as follows, the landlord
8 affirms that the unlicensed establishment has
9 permanently vacated the premises.

10 Number two, the landlord affirms that
11 it has either, one, received affirmative
12 documentation from the unlicensed establishment
13 that it acknowledges the termination of its
14 lease, and has vacated the premises; or, two, has
15 evicted unlicensed establishment from the
16 premises, as evidenced by exhibit A -- attached.

17 Number three, the landlord
18 acknowledges that it is responsible for returning
19 any property owned by the unlicensed
20 establishment that remains in the premises and
21 over which the unlicensed establishment has a
22 legal right of return.

23 Number four, the landlord agrees to
24 not lease the premises to any unlicensed cannabis
25 distributors at any time in the future.

1 And number five, the landlord agrees
2 to notify ABCA when it has leased the premises to
3 a new tenant, and to provide all identifying
4 information regarding the new tenant, including
5 the name of the business and owner.

6 Number six, the cease and desist order
7 remains in effect, and continue to apply to
8 landlord.

9 Number seven, ABCA shall make the keys
10 to the premises available to landlord for pick up
11 at its offices or at another mutually agreed upon
12 time and location.

13 I therefore make a motion that the
14 offer in compromise be accepted. Is there a
15 second?

22 cancellation.

23 Number four, CVS Pharmacy number 2104,
24 license 083507. The licensee requested
25 cancellation.

1 I therefore make a motion that the ABC
2 Board cancels the licenses on the Cancellation
3 Agenda. Is there a second?

22 docket. I will review the name, the type of
23 license, the event, the date, the license number,
24 and the attendee, and I will provide a
25 recommendation. At the end of the list, I'll ask

1 that the ABC Board members approve the
2 recommendations of the Chair.

3 So, number one is a request from Lana
4 El-Zein, a One Day License Class F. This for a
5 concert, live music performance, this is on
6 February 23. The license number is 131261. One
7 hundred attendees, two security guards.

8 Number two, another request from Lana
9 El-Zein, One Day License Class F. Concert, live
10 music performance, this is February 25. The
11 license number is 131261. One hundred attendees,
12 two security guards. And of course, as number
13 one, the recommendation is approval.

14 Number three -- I am going to spell
15 this name. The first name is P-A-N-A-G-I-O-T-I-
16 S, the second name is P-A-N-A-G-I-O-T-O-P-O-U-L-
17 O-S. This is for One Day License Class F. This
18 is a Greek Festival, this is May 16 through May
19 18. The license number is 131261. Four-hundred
20 attendees, 18 security guards.

21 Number four, Carla Tatiana Teixeira,
22 One Day License Class G. A reception, this is
23 February 6. The license number is 131197. One-
24 hundred-and-twenty attendees, three security
25 guards. And approval for number three, number

1 four.

2 Number five, Ryan W-I-E-C-Z-O-R-E-K,
3 One Day License Class G. This is a theater
4 performance, this is February 20 through February
5 22. The license number is 131105. One-hundred
6 attendees, four security guards. Approval.

7 Number six, a request from Jennifer
8 Currie, One Day License Class G. Mardi Gras,
9 March 1. License number 131244. Fifteen-hundred
10 attendees, 50 security guards.

11 Number seven, Jennifer Currie, One Day
12 License Class G. Iceland at the Wharf, May 15.
13 License number 131207. Fifteen-hundred
14 attendees, 50 security guards.

15 Number eight, Jennifer Currie, One Day
16 License Class G. Bloomaroo, B-L-O-O-M-A-R-O-O,
17 at District Wharf, this is March 29. The license
18 number is 131250. Fifteen-hundred attendees, 50
19 security guards.

20 Number nine, Jennifer Currie, One Day
21 License Class G. Running of the Chihuahuas, this
22 is May 3. License number is 131251. Fifteen-
23 hundred attendees, 50 security guards.

24 Number ten, Jennifer Currie, One Day
25 License Class G. Fourth at the Wharf, this is

1 July 4. The license number is 131254. Fifteen-
2 hundred attendees, 80 -- 50 security guards.

3 Number 11 -- approval -- all of the
4 other -- all of the ones I just stated were
5 approval. Jennifer Currie, One Day License Class
6 G. Oktoberfest, October 4. License number
7 131258. Fifteen-hundred attendees, 50 security
8 guards. Approval.

9 Number 12, Jennifer Currie, One Day
10 License Class G. Dia de los Muertos, this is
11 November 1. License number 131259. Fifteen-
