4 next case on our calendar is Case Number 24-CMP-
5 00041, Half Smoke, License Number 100855. Mr.
6 Orellana, can you please elevate the Licensee in
7 this case?

8 MR. ORELLANA: Sure, Andrew McCain,
9 your access has been elevated. That is all
10 Chairman.

11 CHAIRPERSON ANDERSON: Thank you.

12 MR. McCAIN: Yes, I am here.

13 CHAIRPERSON ANDERSON: All right, Ms.
14 Brown can you identify yourself for the record,
15 please?

12 CHAIRPERSON ANDERSON: All right, do
13 you have any preliminary matters to need to bring
14 to the attention of the Board, sir?

15 MR. McCAIN: Yes, about the Order
16 itself?

17 CHAIRPERSON ANDERSON: No, not
18 substantive just preliminary, if you have any
19 preliminary issues.

20 MR. McCAIN: I do not.

21 CHAIRPERSON ANDERSON: All right, so
22 this matter is scheduled for a show cause hearing
23 on March 12th, and just want to remind the
24 parties that seven days before the hearing if the
25 parties are going to rely on documents and

1 witnesses these documents and witnesses must be
2 disclosed seven days prior to the hearing to the
3 other side and also a copy needs to be provided
4 to ABCA legal. Failure by either party to
5 provide documents and witnesses seven days prior
6 to the hearing the Board is empowered to prevent
7 that side from relying on documents and witnesses
8 that have not been disclosed. Any questions, Mr.
9 McCain?

10 MR. McCAIN: No questions.

11 CHAIRPERSON ANDERSON: All right, thank
12 you. All right, March 12th at 1:30 p.m. Have a
13 great day, thank you.
