3 CHAIRPERSON ANDERSON: Let me now to
4 our legal agenda. The first matter on our legal
5 agenda is the Review of an Offer in Compromise in
6 Lieu of Hearing, dated January 30th, 2023 for Case
7 number 22-CC-00063. It is Death Punch/Shabu Plus
8 and Shibuya Eatery, license number 114937. The
9 offer in Compromise is as follows:

10 Charge one: Made substantial changes
11 in operation without approval first primary care
12 violation. Statutory code, DC code section 24742.
13 There is a fine of \$1,000 to be paid within 30
14 days and if the fine is not paid in 30 days, the
15 license will be suspended until the fine has been
16 paid.

17 Charge two: Operated a sidewalk caf,
18 Art Summer Garden without approval such to our
19 authority DC code section 113.01C. There is a
20 fine of \$1,000 to be paid within 30 days or the
21 license shall be suspended indefinitely until the
22 fine has been paid.

23 I make a motion that the Offer in
24 Compromise be accepted at zero second.

25 MEMBER CATO: Bobby Cato seconds.

1 CHAIRPERSON ANDERSON: Mr. Cato and Ms.
2 Crockett to second the motion. We'll now have a
3 roll call to vote. Mr. Short? Mr. Cato?

4 MEMBER CATO: Bobby Cato, I agree.

5 CHAIRPERSON ANDERSON: Ms. Crockett?
6 Ms. Hansen?

7 MEMBER HANSEN: Jeni Hansen, I agree.

8 CHAIRPERSON ANDERSON: Mr. Grandis? And
9 Mr. Anderson, I agree the amend to pass 600.

10 Number two: Review of an Offer in
11 Compromise in Lieu of Hearing, dated February 6th,
12 2023. This is the case number 22-CC-0021, Capitol
13 Hill Market, license number 114937.

14 The Offer in Compromise for this case
15 is charge one, sale to minor, statutory authority
16 DC court section 25781. There's a \$3,000 fine
17 payable within 30 days or the license shall be
18 suspended indefinitely until the fine is paid.

19 Also, the license shall be suspended for 10 days
20 with four days to be served beginning February
21 18th, 2023 and six days stayed for one year.

22 Training: all employees who serve alcoholic
23 beverages in the establishment must complete an
24 alcohol training program within three months from
25 the date of the OIC which would be today.

1 I make a motion that the Offer in
2 Compromise be accepted at zero second.

3 MEMBER SHORT: Mr. Short, I second.

4 CHAIRPERSON ANDERSON: Mr. Short has
5 accepted the offer. Mr. Short has second the
6 motion. Let's have a roll call vote. Mr. Short?

7 MEMBER SHORT: Mr. Short, I agree.

8 CHAIRPERSON ANDERSON: Mr. Cato?

9 MEMBER CATO: Bob Cato, I agree.

10 CHAIRPERSON ANDERSON: Ms. Crockett? I

14 MEMBER GRANDIS: Edward Grandis, I
15 agree.

16 CHAIRPERSON ANDERSON: And Mr. Grandis,
17 I agree, the matter passed 600.

18 Number three: Review of a Settlement
19 Agreement, dated December 28th, 2022 by and
20 between Advisory Neighborhood Commission 1A and
21 KooKoo Restaurant, license number 107631. I make
22 a motion that will approve this request. Is there
23 a second?

24 MEMBER CATO: Bobby Cato seconds.

25 This is for a concert for Sixth and Eye

1 Synagogue. This is on February 14th, 2023. The
2 license number is 123921. Five hundred attendees,
3 five security guards.

4 Number two: A request from Osteria
5 Morini/Nicoletta/Morini Piccolo, P-I-C-C-O-L-O, a
6 One Day Substantial Change. The request is on -
7 the event is on February 25th, 2023. The
8 Substantial Change is a change to use license off
9 premises at 355 Water Street, North East for Ice
10 Yards events. The license number is 092083 and
11 the Substantial Change license number is 23-SC-
12 0556.

13 Number three: A request from La Famosa
14 One Day Substantial Change. This is again for an
15 Ice yards on February 25th, 2023. The nature of

23 2023. The nature of the Substantial change is the
24 change to use the license off premises at 355
25 Water Street, North East for the Ice Yards event.

1 The license number is 092094. Substantial Change
2 License is 23-SC-00553.

3 The next event is a request from
4 Maxwell for a One Day Substantial -
5 Alibi/Maxwell, a One Day Substantial Change. This
6 is again for Ice Yards on February 25th, 2023. The
7 nature of the Substantial Change is the change
8 using the license off premises at 355 Water
9 street, North East for Ice Yards events. The
10 license number is 115589. The Substantial Change
11 license is 23-SC-00559.

12 And number six: Shilling Canning
13 Company, a one day Substantial Change again for
14 the Ice Yards on February 25th, 2023. The nature
15 of the Substantial Change is the change utilizing
16 license off premises at 355 Water Street for the
17 Ice Yards event. The license number is 106038.
18 The Substantial Change license is 23-SC-00555.

19 I make a motion that we approve these
20 requests. Is there a second?

21 MEMBER CROCKETT: Rafi Crockett
22 Seconds.

23 CHAIRPERSON ANDERSON: Ms. Crockett has
24 seconded the motion. We'll now have a roll call
25 vote. Mr. Short? Mr. Cato?

1 MEMBER SHORT: Mr. Short, I agree.

2 MEMBER CATO: Agree.

3 CHAIRPERSON ANDERSON: Mr. Short
4 agrees. Mr. Cato agrees. Ms. Crockett?

5 MEMBER CROCKETT: Rafi Crockett, I
6 agree.

7 CHAIRPERSON ANDERSON: Ms. Hansen? Mr.
8 Grandis? Mr. Anderson, I agree. The matter passed
9 600.

10 Our final agenda item for the morning,
11 this is our Licensing Administrative Docket. The
12 License Administrative Docket the final phase in
13 the ABC Board Grant in issuing the license for
14 these applicants. On this docket, there are
15 thirteen applicants. I will read the name of the
16 applicants, the class category, the license
17 number, and what's been requested.

18 The first applicant is Communal
19 Restaurant license number 108392. They are a
20 Retailer C Restaurant. Trade Name Change
21 Application, the new name is Prost, P-R-O-S-T.

22 Number two: A request from Taqueria
23 Emissary license number 112163. Retailer C
24 Restaurant. Trade Name Change Application. The
25 new name is La Bicicletta Caf, and Bar which they

1 spell L-A B-I-C-I-C-L-E-T-T-A Caf, and Bar.

2 Number three: A request from Tortuga
3 Caribbean Bar and Grille license number 107131,
4 Retailer C Restaurant, Trade Name Change
5 Application. The new name is Playa Ocho Cantina.

6 Number four: A request from La Jambe.
7 Their license number is 099738. They're a
8 Retailer C Tavern, Entertainment Endorsement
9 Application.

10 Number five: A request from His and
11 Hers restaurant DC license number 120010. They
12 are a Retailer C Tavern, Entertainment
13 Endorsement Application.

14 Number six: A request from O2 Lounge,
15 license number 123267, Retailer C Tavern, New ABC
16 License Application.

17 Number seven: A request from
18 Moonlight, license number 123883, Retailer C
19 Tavern, Retailer Tavern Transfer with Sale
20 Application.

21 Number eight: Curry and Pie in
22 Georgetown, license number 123321, Retailer C
23 Restaurant, new ABC license application.

24 Number nine: Claudia's Table, license
25 number 123532, Retailer C Restaurant, new ABC

1 license application.

2 Number ten: Golden Flower, license
3 number 123563, Retailer C Tavern, new ABC license
4 application.

5 Number eleven: Happy Gyro/Happy Ice
6 Cream, license number 123447, Retailer B, new ABC
7 license application.

8 Number twelve: Chavo Enterprises LLC,
9 trade name to be determined, license number
10 123490, Retailer B Beer and Wine, new ABC license
11 application.

12 And number thirteen: Wiseguy, license
13 number 123164, they're a Retailer D restaurant,
14 transfer with sale application.

15 I therefore make a motion that ABC
16 Board approve these requests. Is there a second?

17 MEMBER SHORT: Mr. Short, I second.

18 CHAIRPERSON ANDERSON: Mr. Short has
19 seconded the motion. We'll now have a roll call
20 vote. Mr. Short?

21 MEMBER SHORT: Mr. Short, I agree.

22 CHAIRPERSON ANDERSON: Mr. Cato?

23 MEMBER CATO: Bobby Cato, I agree.

24 CHAIRPERSON ANDERSON: Ms. Crockett?

25 Ms. Crockett has indicated yes. Ms. Hansen?
