16 possible and then we will not schedule a show
17 cause hearing in this matter, but I don't have
18 the date currently for a show cause hearing for
19 this case.

20 MR. WILLIAMS: I have the notice that
21 was sent. It's March 9th at 10:30 for the shoe
22 cause.

23 CHAIRPERSON ANDERSON: All right.
24 Thank you every much, Mr. Williams. I don't have
25 that on my calendar. I apologize. You said
