4 next case is case number -- I'm going to call two
5 cases, case number 21-CMP-00060, Empire Lounge,
6 license number 110702.

7 And case number 21-CMP-00062, Empire
8 Lounge, license number 110702.

9 Ms. Fashbaugh, can you please elevate
10 the rights of the Licensee for Empire Lounge,
11 please.

12 MS. FASHBAUGH: Please stand by.

13 Richard Bianco, your rights have been
14 elevated.

15 That is all, Mr. Chair.

16 CHAIRPERSON ANDERSON: Thank you, good
17 morning.

18 Mr. Williams, can you please identify
19 yourself for the record, please?

20 MR. WILLIAMS: Good morning, Mr.
21 Chairperson, my name is Antoine Williams on
22 behalf of the District of Columbia this morning.

23 CHAIRPERSON ANDERSON: Thank you.

24 Mr. Bianco, can you please identify
25 yourself for the record, please?

1 MR. BIANCO: Yes, my name is Richard
2 Bianco, I'm here on behalf of the Licensee.

3 CHAIRPERSON ANDERSON: All right,
4 thank you.

5 So I called case number 21-CMP-0060
6 and case number 21-CMP-0062. So for case number
7 21-CMP-00060, are there any preliminary matters
8 in that case?

9 MR. WILLIAMS: Yes, Mr. Chairperson.
10 Attorney Bianco, did you receive an Offer in
11 Compromise from the District related to this
12 case?

13 MR. BIANCO: I did and here's where we
14 are specifically, and I think this will address
15 both matters, this is a noise case and there were
16 a number of noise violations written up.

17 Either four or five within a period of
18 a week, two of them are on for today and I
19 believe two of them are on for next week.

20 I've been in touch with the assigned
21 attorneys from OAG and we're going to try and
22 work out a global resolution of all matters
23 together.

24 CHAIRPERSON ANDERSON: All right,
25 fine, so what we will do then, for case number

1 21-CMP-00060, that matter is scheduled for Show
2 Cause Hearing on March 9, 2022, at 1:30 p.m..

3 And for case number 21-CMP-00062,
4 Empire Lounge, that matter is scheduled for a
5 Show Cause Hearing on March 16, 2022, at 10:30
6 a.m..

7 And if, as represented by Counsel, if
8 there's a global settlement, that can be provided
9 to the board and the board will consider.

10 And if the board considers and
11 accepted the settlement, then those hearings will
12 be cancelled along with the other cases.

13 All right? Thank you very much for
14 the representation and have a great day.
