3 CHAIRPERSON ANDERSON: Our next case  
4 is case number 21-CMP-00027, Heist, license  
5 number 107384.

6 Ms. Jeni Hansen will be recusing  
7 herself from participating in this case.

8 Ms. Fashbaugh, can you please elevate  
9 the rights of the Licensee in this case, please.

10 MS. FASHBAUGH: Please stand by.

11 Andrew Kline, your rights have been  
12 elevated.

13 That is all, Mr. Chair.

14 CHAIRPERSON ANDERSON: Thank you.

15 All right, good morning, everyone.  
16 Mr. Williams, can you please identify yourself  
17 for the record, please?

18 MR. WILLIAMS: Yes. My name is  
19 Antoine Williams on behalf of the District of  
20 Columbia this morning.

21 CHAIRPERSON ANDERSON: Good morning,  
22 Mr. Williams.

23 Mr. Kline, can you identify yourself  
24 for the record, please?

25 MR. KLINE: Yes, good morning, Mr.

1 Chairman, members of the board.

2 Andrew Kline here on behalf of the  
3 Licensee, Heist.

4 CHAIRPERSON ANDERSON: Good morning,  
5 Mr. Kline.

6 Mr. Williams, are there any  
7 preliminary matters in this case, please?

8 MR. WILLIAMS: Yes, Chairperson. I  
9 just wanted to confirm whether or not the  
10 attorney has received the Offer in Compromise  
11 that the district has sent?

12 It would have been sent by one  
13 attorney, Shanny Brown (phonetic).

14 MR. KLINE: Yes, received it. It's  
15 acceptable, had some logistical problems getting  
16 it signed, but prepared to accept the Offer in  
17 Compromise on the record.

18 CHAIRPERSON ANDERSON: All right, so,  
19 Mr. Williams, what is the Offer in Compromise,  
20 please?

21 MR. WILLIAMS: Okay, Mr. Chairperson,  
22 the charge is, fail to engage in the principle  
23 service of food while catering an event with  
24 alcohol, under DCMR 23-2000.1 the fine is \$1,000  
25 within 120 days or the Licensee shall be

1 suspended indefinitely until the fine is paid.

2 CHAIRPERSON ANDERSON: Thank you.

3 Mr. Kline, it's my understanding the  
4 Offer in Compromise is a fine of \$1,000 payable  
5 within 120 days, if the fine is not paid within  
6 120 days the license will be suspended.

7 Is this your -- is your -- is this  
8 your understanding of the Offer in Compromise?

9 MR. KLINE: Yes, Mr. Chairman, and it  
10 is acceptable to the Licensee.

11 CHAIRPERSON ANDERSON: And your client  
12 is aware that by accepting an Offer in Compromise  
13 that they're giving up their right to a hearing  
14 and that they're giving up their right to appeal  
15 this matter?

16 MR. KLINE: Yes, Mr. Chairman.

17 CHAIRPERSON ANDERSON: All right,  
18 thank you.

19 With that said, I make a motion that  
20 the Offer in Compromise be accepted, is there a  
21 second?

22 MEMBER CROCKETT: Ms. Crockett  
23 seconds.

24 CHAIRPERSON ANDERSON: Ms. Crockett  
25 has second the motion, we'll now have a roll call

1 vote on the motion.

2 Mr. Short?

3 MEMBER SHORT: Mr. Short, I agree.

4 CHAIRPERSON ANDERSON: Mr. Cato?

5 MEMBER CATO: Bobby Cato, I agree.

6 CHAIRPERSON ANDERSON: Ms. Crockett?

7 MEMBER CROCKETT: Rafi Crockett, I  
8 agree.

9 CHAIRPERSON ANDERSON: Mr. Grandis?

10 MEMBER GRANDIS: Edward Grandis  
11 agrees.

12 CHAIRPERSON ANDERSON: And Mr.  
13 Anderson, I agree. The matter passes five-zero-  
14 zero.

15 I want to thank the parties for  
16 agreeing to this Offer in Compromise, and the  
17 terms are \$1,000 paid within 120 days -- 120 days  
18 from this date, it's payable.

19 Thank you, Mr. Williams for this  
20 matter, and thank you, Mr. Kline.

21 All right.
