22 matter then is scheduled for a Show Cause Hearing
23 on March 19th at 1:30 p.m.

24 I just want to remind the parties that
25 seven days prior to the hearing, they are

1 required to disclose documents and witnesses to
2 the other side and also to the Agency. Failure
3 by either side to disclose documents and
4 witnesses seven days previous, the Board is
5 empowered to prevent that side from moving
6 forward from relying on those documents and
7 witnesses that have not been disclosed seven days
8 prior.
