3 CHAIRPERSON ANDERSON: The next case
4 on our calendar is Case No. 23-CMP-00024, DC
5 Shenanigans, License No. 88119.

6 Mr. Orellana, can you please elevate
7 the parties in this case?

8 MR. ORELLANA: Manalle Mahmoud, your
9 access has been elevated.

10 And, Christopher Southcott, your
11 access has been elevated.

23 required to exchange documents and witnesses that
24 they will rely upon.

25 Failure by either side to provide

1 these documents and/or witnesses seven days
2 before the hearing, unless good cause is shown,
3 the Board can prevent that party from relying on
4 documents and witnesses that have not been
5 disclosed.
