21 Entertainment endorsement application.

22 Number 19, a request from Wagshal's,

25 restaurant to a retailer C restaurant.

18 1:47 p.m.)

19 CHAIRPERSON ANDERSON: Good afternoon,
20 everyone, we're back on the record.

21 All right, good afternoon, everyone.
22 My name is Donovan Anderson, I'm chairman of the
23 -- welcome to the afternoon session of the ABC
24 Board. I'm Donovan Anderson, I'm chair of the
25 Board.

1 We have five other members with us
2 this afternoon, Mr. James Short, Mr. Bobby Cato,
3 Ms. Rafi Crockett, Ms. Jeni Hansen, Mr. Edward
4 Grandis. The Board has six members in attendance
5 for the conduct of business and that constitutes
6 a quorum.

7 This afternoon we have --
