3 CHAIRPERSON ANDERSON: All right, the
4 next case on our calendar is case number 21-CMP-
5 00054, Mirror Lounge, license number 111950.

6 Ms. Fashbaugh, can you please elevate
7 the rights of the Licensee in this case, please?

8 MS. FASHBAUGH: Please standby.

9 Sidon Yohannes, your rights have been
10 elevated.

11 I do not see the Licensee on the line,
12 and that is all, Mr. Chair.

13 CHAIRPERSON ANDERSON: Thank you.

14 Good morning, Ms. Yohannes, is your

5 CHAIRPERSON ANDERSON: Good morning.

7 CHAIRPERSON ANDERSON: Are there any
8 preliminary matters in this case?

9 MR. JORDAN: No, Mr. Chairman, the
10 parties do not have an OIC to present to the
11 Board at this time.

12 CHAIRPERSON ANDERSON: All right, good
13 morning. Thank you.

14 Then this matter is scheduled for a
15 show cause hearing on March 16, 2022, at 10:30
16 a.m..

17 Once again I will go on to remind the
18 parties that seven days before the hearing the
19 parties are required to exchange documents and
20 witnesses and also share those documents with the
21 agency.

22 If that's not done, in the sense that
23 documents and witnesses are not exchanged, the
24 Board might prevent the introduction of documents
25 and witnesses if good cause is not shown why the

1 documents were not exchanged seven days before
2 the hearing.

3 Are there any questions?

4 MS. YOHANNES: No questions.

5 MR. JORDAN: No questions.

6 CHAIRPERSON ANDERSON: All right,
7 then, hearing none, thank you very much, have a
8 good day.

9 MS. YOHANNES: Thank you.
