17 might prevent either side from calling witnesses  
18 and relying on documents that were not disclosed  
19 seven days prior to the hearing.

22 CHAIRPERSON ANDERSON: None from the  
23 government?

24 MR. JORDAN: No, Mr. Chairman.

25 CHAIRPERSON ANDERSON: All right.
