15	Mr. Kochevar, you filed your protest
16	as an abutting property owner. Is there any part
17	of your property that touches the property of
18	Harvard Liquors?
19	MR. KOCHEVAR: Yeah, I'm right next
20	door.
21	MS. FLETCHER: You are right next door,
22	do you share a wall?
23	MR. KOCHEVAR: There's a short like
24	access alley between us, but it's like two feet,
25	three feet wide.

1	MS. FLETCHER: And so, I'm asking
2	because my GIS system was slow today. Normally,
3	I would have already checked. So, I'm going to
4	check. I wanted to ask you anyway.
5	Based on what you are describing, it
6	sounds like there's a space between it sounds
7	like there's a space between your property and
8	that of Harvard Liquors. Am I right about that?
9	MR. KOCHEVAR: Yeah.
10	MS. FLETCHER: But, you can't get to
11	it?
12	MR. KOCHEVAR: But, they need access to
13	like the utilities and stuff.
14	MS. FLETCHER: The walls don't actually
15	touch?

19	touch, we do not consider the property to be
20	abutting property, and I'll check that in the
21	Geographic Information System. I just didn't get

23	that.
24	MR. KOCHEVAR: Okay.
25	MS. FLETCHER: That the properties do

1 not abut. 2 MR. KOCHEVAR: Okay. 3 MS. FLETCHER: So, what I'm going to do today, Mr. Kochevar, I'm going to take your word 4 5 for that, assuming that you are correct because you are in the best position to know. 6 That means 7 that your protest would have to be dismissed, 8 because the properties are not abutting. 9 actually, have to share a wall. 10 MR. KOCHEVAR: Okay. 11 MS. FLETCHER: But, I'm going to double 12 check that in the DC Geographic Information 13 system, hopefully, later this morning, and I'm 14 going to get back to you to confirm that. 15 MR. KOCHEVAR: Okay, thank you. 16 MS. FLETCHER: You are very welcome. 17 Any questions at all? 18 MR. LEE: Yeah, I got a few comments 19 for Mr. Kochevar. 20 Even though you are not an abutting 21 property owner, we already have a voluntary 2.2 agreement to the ANC, so probably you know about 23 that or not to address the issue. 2.4 So, if you want, I'll send you that
