3 CHAIRPERSON ANDERSON: All right. All
4 right, the next case on our calendar is case
5 number 25-CIT-00115, Quilox Restaurant and
6 Lounge, license number 114288. Mr. Orellana,
7 can you please elevate the rights of the
8 government and the licensee in this case?

9 MR. ORELLANA: Sure thing. Chris
10 Southcott, access elevated, and Investigator
11 Jovan Miller, access elevated. That appears to
12 be all, Chairman.

13 CHAIRPERSON ANDERSON: Thank you. Mr.
14 Southcott, were you expecting the licensee to
15 show up today?

16 MR. SOUTHCOTT: I have not been -- I
17 have not had any communication with them.
18 Despite repeated attempts, I have not heard
19 anything from them, so --

20 CHAIRPERSON ANDERSON: All right.

21 MR. SOUTHCOTT: -- I'm not expecting
22 them to be present.

23 CHAIRPERSON ANDERSON: All right, fine.
24 Can you please identify yourself for the
25 record?

1 MR. SOUTHCOTT: Good morning, members
2 of the Board. My name is Chris Southcott, first
3 name C-H-R-I-S, last name, S-O-U-T-H-C-O-T-T,
4 from D.C.'s Office of the Attorney General.

5 CHAIRPERSON ANDERSON: So, although the
6 licensee is not here, is the government prepared
7 to move forward?

8 MR. SOUTHCOTT: Yes. I would like to
9 raise a preliminary matter.

10 CHAIRPERSON ANDERSON: What's the
11 preliminary matter?

12 MR. SOUTHCOTT: So, this case concerns
13 the failure to file a quarterly statement.
14 Yesterday, I became aware of the fact that the
15 establishment, that the agency, on December 24
16 of last year, issued a letter to the
17 establishment, which then submitted an out-of-
18 business report.

19 And I believe that as of January, the
20 establishment's license is in safekeeping, and
21 so I just wanted to, you know, raise that for
22 the Board and ask whether the Board wanted to
23 continue in light of the fact that it appears
24 that the establishment's license is in
25 safekeeping.

1 CHAIRPERSON ANDERSON: If the
2 government wants to raise a motion to continue
3 this matter, then, I mean, the Board would,
4 based on the fact that the license is in
5 safekeeping, so therefore, that would -- if it's
6 in safekeeping, it would state, it would show
7 that they're not in operation, so I would be --
8 I would support granting the motion if the
9 government is asking to continue this matter.

10 MR. SOUTHCOTT: I'll make the motion to
11 continue then.

12 CHAIRPERSON ANDERSON: All right, is
13 there a second?

14 MR. SOUTHCOTT: Mr. Meadows, I second.

15 CHAIRPERSON ANDERSON: Mr. Meadows has
16 seconded the motion. We'll have a roll call
17 vote. Mr. Grant?

18 MEMBER GRANT: Mr. Grant, I agree.

19 CHAIRPERSON ANDERSON: Mr. Meadows?

20 MEMBER MEADOWS: Mr. Meadows, I agree.

21 CHAIRPERSON ANDERSON: Mr. Jones?

22 MEMBER JONES: Mr. Jones, I agree.

23 CHAIRPERSON ANDERSON: And Mr.
24 Anderson, I agree. The matter passes 4-0. So,
25 the Board has voted to continue this matter

1 based on the fact that, the representation of
2 the government that the license is in
3 safekeeping. All right, thank you very much --

4 MR. SOUTHCOTT: Thank you, Mr. Chair.

5 CHAIRPERSON ANDERSON: -- Ms. Graham
6 and Mr. Southcott. Have a great day.
