There is one calendar -- one case on the calendar today. Just for the record, there were two initial -- the first one was resolved and so I won't read that case into the record.

But the only case on the calendar today is Mechos Dominican Kitchen of Dakota Crossing, LLC, trading as Mechos Dominican Kitchen.

This is Case Number 24-PRO-00015, 2450 Market Street, Northeast, License No. ABRA 114514. This is a Retailer Class CR, a substantial change application for an entertainment endorsement inside and outside in the summer garden.

FLETCHER: Yeah, it could be 30-9 minute increments, just pretty -- any time just 10 11 between those times, Ms. Delgado. 12 MS. HICKS DELGADO: 10:30's fine for 13 me that morning. MR. COMPRES: Yeah, that works for me 14 15 too. 16 MS. FLETCHER: That works for you as 17 well, Mr. Compres? Well, then --18 MR. COMPRES: That's fine. MS. 1 days from today. And then the protest hearing 2 will be approximately 30 days from that, just to give you some idea. 3 MS. HICKS DELGADO: Okay, that's fine. 4 5 MS. FLETCHER: So we like to hold the 6 mediation prior to the status hearing, and so 7 we're doing that, so we're good on the date. 8 MR. COMPRES: Ms. Fletcher, I have a 9 question. 10 MS. FLETCHER: Yes? 11 MR. COMPRES: If we're able to solve 12 the problem in mediation on that date, on March 13 5, will we still have to have those two hearings? MS. FLETCHER: No. If this matter is 14 15 resolved in mediation on the 5th and you enter 16 into an agreement which you both sign, we will 17 cancel any future proceedings. So the status 18 hearing will be canceled. There will not be a 19 protest hearing. The Board would review the 20 agreement at -- when they approve it, if they 21 approve it -- most likely they will approve it --2.2 then that's the end of it. Then you can -- the 23 license can be issued. 2.4 MR. COMPRES: Okay, great. 25 MS. FLETCHER: And any other questions
