If within the ten days, if ANC 2B responds and gives us reasonable, they give us an explanation that the Board determines that it is reasonable why they failed to appear this morning, we will continue this case.

If not, the Board will dismiss the protest and the Board will instruct the Agency to move forward to issuing your license, sir, okay? So that's basically where we are.

So we will issue an order today dismissing the protest. The ANC will have ten days to respond, and based on the response -- and, of course, once the ANC responds, you will get a copy so you will know what it is, and we will, the Board will move forward, but as I stated before, if they fail to respond within the ten days or if the Board believes that -- determines that their reasoning for not being here this morning is not reasonable, we will officially dismiss the protest and the Agency will move forward to granting your license, okay?
