19 MR. BROWN: Good morning to the Board.  
20 Assistant Attorney General Matthew Brown, M-A-T-  
21 T-H-E-W B-R-O-W-N, here on behalf of the  
22 District.

23 CHAIRPERSON ANDERSON: Good morning,  
24 Mr. Brown.

25 I see that the licensee is not here,

1 but the licensee is not required to be at a show  
2 cause hearing status. This matter then is  
3 scheduled for a show cause hearing on March 27th  
4 at 1:30 p.m.

5 I just would like to remind you, Mr.  
6 Brown, the government that seven days before the  
7 hearing, both parties are required to provide the  
8 documents and witnesses that they will rely upon  
9 at the hearing.

10 Failure by either side to provide the  
11 documents and witnesses seven days prior, unless  
12 good cause is shown, the Board is empowered to  
13 prevent that side from relying on documents and  
14 witnesses that have not been previously  
15 disclosed.

16 Any questions, sir?

17 MR. BROWN: No, sir. Understood.

18 CHAIRPERSON ANDERSON: All right.
