14 canceled all these hearings, the board was of the  
15 belief up through last night that we were having  
16 a protest hearing on Aslin and so by having a  
17 protest hearing we believe that that protest  
18 hearing would have lasted all afternoon and  
19 probably into the night, but the board was  
20 provided overnight a settlement agreement and so  
21 therefore, this case has now been settled and so  
22 we have no afternoon calendar.

23 We could not have moved the cases that  
24 were canceled because we thought that our  
25 afternoon would have been occupied by the protest

1 hearing. So that's one of the reasons why our  
2 entire afternoon was canceled because we had  
3 anticipated that we were having a 1:30 protest  
4 hearing that would have consumed most of the  
5 afternoon and most of the evening, but as I have  
6 always stated, the board supports settlement  
7 agreement and the board commends the parties that  
8 at the 11th hour they were able to settle this  
9 matter and so, I want to publicly commend the  
10 parties for their diligence in bringing closure  
11 to this matter.
