3 MS. FLETCHER: The next case on the
4 calendar is Georgetown Supply. This is Case
5 Number 24-PRO-00017, KRS LLC, 1251 Wisconsin
6 Avenue, Northwest, License Number ABRA-126906.
7 This is a Retailer Class MC. It is a new medical
8 cannabis retailer application. The protest
9 issues are adverse impact on peace, order and
10 quiet. Is anyone present on behalf of the
11 applicant?

12 MR. MCGOWAN: Good morning, Ms.
13 Fletcher, this is John McGowan with Kinner and
14 McGowan here on behalf of the applicant.

15 MS. FLETCHER: Mr. McGowan, would you
16 spell your name for the record, please?

17 MR. MCGOWAN: Yes, ma'am. M-C-G-O-W-
18 A-N.

19 MS. FLETCHER: Anyone else with you
20 today?

21 MR. MCGOWAN: Yes, Meredith Kinner.

22 MS. FLETCHER: Ms. Kinner, oh, I see
23 you. Would you spell your name for the record,
24 please?

15 MS. FLETCHER: I'm going to recall
16 Georgetown Supply. Is anyone present from ANC 2E
17 in the matter of Georgetown Supply?

18 (No audible response.)

19 MS. FLETCHER: Okay, the protest filed
20 by ANC 2E is dismissed because there's no one
21 present today. Mr. McGowan and Ms. Kinner, there
22 will be a board order issue dismissing the
23 protest because ANC 2E is not present. If ANC 2E
24 decides to seek reinstatement of their protest,
25 you'll receive a copy of their request, and

1 you'll have an opportunity to respond. If they
2 don't seek reinstatement, you'll be kept informed
3 either way, but if they do, you'll have an
4 opportunity to respond to it.

5 MR. MCGOWAN: Great. Thank you.

6 MS. KINNER: Thank you so much, Ms.
7 Fletcher.

8 MS. FLETCHER: Okay, well, you're very
9 welcome. The roll call hearing in this matter is
10 concluded. Have a nice day.

11 MR. MCGOWAN: Thank you, you too.

12 MS. KINNER: You as well.

13 MS. FLETCHER: Okay. Anybody present
14 that I need to speak with that I have not spoken
15 with?
