19	MR. ORELLANA: Sure thing.
20	CHAIRPERSON ANDERSON: Thank you.
21	All right. Good morning again, sir.
22	Can you please spell and state your name for the
23	record?
24	MR. NEGASH: My first name is
25	Hailemaryam. My last name is Negash.

1 CHAIRPERSON ANDERSON: I need you to 2 spell it, sir -- there's a court reporter -- so 3 the person can identify you properly for the record, sir. 4 5 MR. NEGASH: H-A-I-L-E-M-A-R-Y-A-M, last name is N-E-G-A-S-H. 6 7 CHAIRPERSON ANDERSON: And what is 8 your role with this establishment, sir? 9 MR. NEGASH: I'm the owner. CHAIRPERSON ANDERSON: 10 Thank you. 11 This is an application for a renewal of the 12 license. It was protested by ANC 3E. 13 This matter was scheduled for a protest hearing status at 10:30. The case was 14 It's 10:47. And the ANC who has 15 called. 16 protested the renewal of the license is not here. 17 In order to protest a license, the 18 parties are required to show up at the roll call. 19 That is where status is granted. Both parties 20 are also required to show up at the protest 21 hearing status. 2.2 Seeing that the ANC is not here today 23 at the protest hearing status, I therefore make a motion that the ANC be dismissed -- that the 2.4

protest be dismissed.

15	give us reasonable notice why it failed to appear
16	at the protest hearing status today.
17	If the ANC fails to respond to our
18	notice or if they provide us notice that the
19	Board considers is not good cause, the protest
20	will be dismissed formally in ten days. And what
21	this means is that the Agency will be instructed
22	by the Board to move forward to renew your
23	license without any further restrictions.
24	Do you understand, sir?
25	MR. NEGASH: Yes.

3	today. Bye-bye.
