14 The next matter is the review of an
15 Offer in Compromise in Lieu of a Hearing dated
16 March 9th, 2021 in cases numbered 19-CMP-00057,
17 19-CMP-000192, 19-CIT-00648, 19-CMP-00212 and 19-
18 CIT-00245.

19 This Hiwot Ethiopian Restaurant,
20 License No. 100297, and this is the Offer in
21 Compromise that we're being asked to vote upon.

22 The Offer in Compromise for Case No.
23 19-CMP-00057 is, Charge 1, increase interior
24 occupancy, statutory authority, D.C. Official
25 Code Section 25823(a)(7) and the term of this OIC

1 is a warning.

2 The second charge in this case is
3 failure to keep the kitchen open two hours before
4 closing. The statutory authority is D.C. Code
5 Section 25113(b)(1) and the term for this charge
6 is also a warning.

7 Charge 3: substantial change,
8 expansion to the second floor, statutory
9 authority D.C. Code Section 25762(b)(3).

10 The fine is \$1,000 to be paid within
11 120 days or the license will be suspended until
12 the fine has been paid.

13 Charge No. 4: provide live
14 entertainment without endorsement, statutory
15 authority D.C. Code Section 25113(a)(b)(1). The
16 term for this charge is a warning.

17 Charge 5, allowed dancing without
18 endorsement. Statutory authority D.C. Code
19 Section 25113(a)(b)(1). The fine is \$1,000 to be
20 paid within 120 days or the license will be
21 suspended.

22 Charge 6, trade name trade. Statutory
23 authority D.C. Code Section 25762(b)15 and the
24 term for this charge is a warning and amend
25 Charge 4 in the Notice to Replace Charge 5 with

1 Charge 6.

2 For Case No. 19-CMP-00192, the charge
3 -- Charge 1: operating outside of approved
4 hours. The statutory authority is D.C. Code
5 Section 25723(b) and the term is a warning will
6 be issued for this charge.

7 For Case No. 19-CIT-00648, the charge
8 is failure to file required quarterly statements
9 third quarter of 2019, statutory authority D.C.
10 Code Section 25113(b)(2)(a). There is a fine of
11 \$750 to be paid within 120 days or the license
12 will be suspended until the fine has been paid.

13 The other term for this case is that
14 they will have to submit pending quarterly
15 statements if it has not been submitted.

16 Okay. Now, for Case No. 19-CMP-00212,
17 Charge 1, no ABC manager. Statutory authority
18 D.C. Code Section 25701 and the term for this
19 case is that a warning will be issued.

20 The next case is Case No. 19-CIT-
21 00245. The charge is failed to file the required
22 quarterly statement first quarter of 2019.

23 The statutory authority is D.C. Code
24 Section 25113(b)(2)(8). There will be a fine of
25 \$750 to be paid within 120 days or the license

1 will be suspended until the fine has been paid.

2 And the other term for this charge is
3 that they should submit pending quarterly
4 statement if it has not been submitted as yet.

5 I, therefore, make a motion that the
6 global settlement in the OIC that I just read be
7 approved.

8 Is there a second?

14 motion that the OIC be accepted.
