4 in our calendar is Case Number 25-CC-00000,  
5 Chesapeake Big Market, License Number 117463.  
6 Mr. Orellana, can you please elevate the rights  
7 of the parties in this case?

8 MR. ORELLANA: Sure thing. Betsy  
9 McMullen, access elevated, and Investigator  
10 Kindell Williams, access elevated. That's all,  
11 Chair.

12 CHAIRPERSON ANDERSON: Ms. McMullen,  
13 good morning. Can you please identify yourself  
14 for the record?

15 MS. MCMULLEN: Good morning, Mr.  
16 Chair, this is Assistant Attorney General Betsy  
17 McMullen, B-E-T-S-Y M-C-M-U-L-L-E-N, here on  
18 behalf of the District.

19 CHAIRPERSON ANDERSON: Good morning  
20 ma'am. I see that the licensee is not here  
21 today. Were you expecting the licensee to appear  
22 today?

23 MS. MCMULLEN: Yes, however, we are  
24 very close to reaching settlement. I did inform  
25 the licensee that since it hasn't been reached  
yet, they should appear, but did not receive a

1 response. But settlement terms have been  
2 accepted at this point, we're just working out  
3 dates for them to serve their license suspension.

4 CHAIRPERSON ANDERSON: So would you  
5 then want the agency to continue this case?

6 MS. MCMULLEN: Yes, Mr. Chair.

7 CHAIRPERSON ANDERSON: All right, so  
8 based on the representation made by counsel, we  
9 will continue this case to a date to be  
10 determined. Okay?

11 MS. MCMULLEN: Thank you, Mr. Chair,  
12 and if I could ask if possible, a sooner date  
13 rather than a later one in case the license --

14 CHAIRPERSON ANDERSON: Right. Do --  
15 (Simultaneous speaking.)

16 MS. MCMULLEN: So a sooner date.

17 CHAIRPERSON ANDERSON: All right, I  
18 will talk to our agencies and for them, for our  
19 agency to reschedule this case for the earliest  
20 date possible, okay? So I'll do that, okay?

21 MS. MCMULLEN: Thank you so much.


22 CHAIRPERSON ANDERSON: Thanks for
