The Alcoholic Beverage and Cannabis Board met via WebEx videoconference, Chairperson Donovan W. Anderson presiding.

CHAIRPERSON ANDERSON: The next case on our calendar is case number 23-CIT-00509, Mood Swings Food Hall, formerly Glassey, license number 117346. This is a full show cause hearing, so Mr. Orellana, good morning, can you elevate the rights of the government, the licensee, or any witnesses that are being called for this case?

MR. ORELLANA: Anthony Celo, your access has been elevated. Investigator George Garcia, your access has been elevated. And that will be all, Mr. Chairman.

CHAIRPERSON ANDERSON: Thank you.

MR. CELO: Good morning, Mr. Chair.

CHAIRPERSON ANDERSON: Good morning, sir. This matter was scheduled for a show cause hearing at 10:30, it's 11:11. Have you had any conversation with the licensee? Because it does not appear that the licensee is here to contest this case.

MR. CELO: I had initial negotiations with the licensee, but I have not had communication on this case since the initial

outreach, probably more than a month ago at this point. I would note that this licensee did continue the hearing that they had last week, so they presumably know how to continue the hearing if they're not going to attend.

CHAIRPERSON ANDERSON: All right, thank you. So, let me formally -- please identify yourself for the record, sir.

MR. CELO: Assistant Attorney General Anthony Celo on behalf of the District, A-N-T-H-O-N-Y C-E-L-O.

CHAIRPERSON ANDERSON: Thank you, good morning, sir. Is the government prepared to move forward with this hearing, although the licensee is not here?

MR. CELO: Yes, Mr. Chair.

CHAIRPERSON ANDERSON: Okay, give me one minute, sir. Pursuant to D.C. Official Code Section 25-447, the board has authority to proceed ex parte where the licensee waives the hearing, or fails to appear unless the hearing is extended for good and sufficient cause. The board's records reflect that the licensees were properly served.
