CHAIRPERSON ANDERSON: The second case I'm going to call then, is Case No. 21-CMP-00064, Victory Restaurant and Lounge, License No. 11739. This case was scheduled for a show-cause hearing this morning.

And so, prior to doing the show-cause, so let me have the parties again identify themselves for the record in the show-cause hearing case, 21-CMP-00064. Mr. Williams.

MR. WILLIAMS: Good morning,
Mr. Chairperson. My name is Antoine Williams. A-N-T-O-I-N-E, last name Williams, W-I-L-L-I-A-M-S. I'll be representing the District this morning.

CHAIRPERSON ANDERSON: Ms. Yohannes.
MS. YOHANNES: Sidon Yohannes.
S-I-D-O-N Y-O-H-A-N-N-E-S, on behalf of the licensee.

## CHAIRPERSON ANDERSON: All right,

 thank you. This is a show-cause hearing status. So, I'm putting this one as an active show-cause hearing. Are there any preliminary matters in this case?MR. WILLIAMS: Yes, Mr. Chairperson. CHAIRPERSON ANDERSON: And what's that, sir?

MR. WILLIAMS: This morning we have reached an OIC for the establishment paying fine of $\$ 2,000$ within 120 days.

CHAIRPERSON ANDERSON: All right.
Ms. Yohannes, it's my understanding in this particular case that there is an Offer-inCompromise. The Offer-in-Compromise is a fine of \$2,000, payable within 120 days. If the fine has not been paid in 120 days, the license will be suspended until the fine has been paid. Is this your understanding of the Offer-in-Compromise?

MS. YOHANNES: Yes, it is.
CHAIRPERSON ANDERSON: Is your client aware that by accepting an Offer-in-Compromise, that they're giving up their right to a hearing? MS. YOHANNES: Yes.

CHAIRPERSON ANDERSON: Is your client also aware that by accepting the Offer-inCompromise, that they're giving up their right to appeal this matter?

MS. YOHANNES: Yes.
CHAIRPERSON ANDERSON: Thank you. Any
questions by any Board members on this matter? Hearing none, $I$ make a motion that the Offer-inCompromise of a fine of $\$ 2,000$, payable within 120 days, be accepted. If the fine is not payable within 120 days, the license will be suspended until the fine has been paid. Is there a second?

CHAIRPERSON ANDERSON: Ms. Crockett has seconded the motion. We'll now have a roll call vote on the motion. Mr. Short?

MEMBER SHORT: Mr. Short. I agree.
CHAIRPERSON ANDERSON: Mr. Cato. MEMBER CATO: Bobby Cato. I agree. CHAIRPERSON ANDERSON: Ms. Crockett. MEMBER CROCKETT: Rafi Crockett. I agree.
