This case was scheduled for a show-cause hearing 6 7 this morning. 8 And so, prior to doing the show-cause, 9 so let me have the parties again identify themselves for the record in the show-cause 10 11 hearing case, 21-CMP-00064. I'll be representing the District this morning. 16 17 CHAIRPERSON ANDERSON: Ms. Yohannes. MS. YOHANNES: Sidon Yohannes. 18 19 S-I-D-O-N Y-O-H-A-N-N-E-S, on behalf of the 20 licensee. 21 CHAIRPERSON ANDERSON: All right, 2.2 thank you. This is a show-cause hearing status. 23 So, I'm putting this one as an active show-cause 24 hearing. Are there any preliminary matters in

16	CHAIRPERSON ANDERSON: Is your client
17	aware that by accepting an Offer-in-Compromise,
18	that they're giving up their right to a hearing?
19	MS. YOHANNES: Yes.
20	CHAIRPERSON ANDERSON: Is your client
21	also aware that by accepting the Offer-in-
22	Compromise, that they're giving up their right to
23	appeal this matter?
