MR. BIANCO: Richard Bianco. Last name is B-I-A-N-C-O, counsel for the respondent.

CHAIRPERSON ANDERSON: Good afternoon, Mr. Bianco. Is your client going to be here this afternoon, sir?

MR. BIANCO: No, sir.

CHAIRPERSON ANDERSON: Okay. This matter was scheduled for a summary suspension hearing that the Chief of Police, it's my understanding the Chief of Police had closed this establishment down for 96 hours. The ABC Board voted to extend the closure, and by operation of law the license had requested a hearing.

This hearing was granted within the statutory timeline. So, we are here for this hearing pursuant to statute. And so, Mr. Celo, where are we? Are there any preliminary matters in this case?

MR. CELO: Yes, Mr. Chair. The parties are in negotiations. It does look like we'll be able to resolve this matter. We have not yet resolved it, and speaking on behalf of Attorney Bianco, we are requesting a one-week continuance of this matter, to allow for resolutions for negotiation.

CHAIRPERSON ANDERSON: Thank you.

Mr. Bianco, as you're aware, your client had

requested this hearing. The Board complied with

the statutory requirement for us to have this

hearing within the two-days, I believe, after the

request was made.

And it's now my understanding that a continuance has been requested. Is this a joint continuance on your part, sir?

MR. BIANCO: Yes, it is. That's accurate. We filed the request, I believe, at some point on Monday, and we thank the Board for acting quickly, scheduling it for today.

I think that's probably what prompted us to enter into more serious settlement discussions.

And it looks like we'll be able to get this resolved within the next week. And that's certainly my hope.

CHAIRPERSON ANDERSON: And is your client aware that the suspension will remain in effect until there is an order or there is an agreement on the part of the Government that -- I mean, until an agreement has been reached to lift the suspension on preventing them from selling or

MR. BIANCO: Yes, they are. And as of last night during my investigation, the placards indicating an indefinite suspension until order of the Board, are still posted on the front of the establishment and they will remain so.

CHAIRPERSON ANDERSON: I know that a placard was posted. I just want to make sure that your client is aware that they are unable to sell or serve alcohol during -- I know that the Agency has done its part in posting the red placard. I'm sorry, not the red placard, the placard, on the establishment.

I want to make sure that the licensee is aware of what the placard means. That the licensee is aware that they cannot sell and serve alcohol until this Board has lifted those orders. I just want to make sure that your client is aware.

MR. BIANCO: They have been so advised and indicated their understanding of the instructions.

CHAIRPERSON ANDERSON: All right, thank you. Thank you for that representation, Mr. Bianco.

With that said, this matter is then continued for further hearing on March 30, 2022 at 1:30 p.m. Thank you very much. Thank you, Mr. Chair. MR. BIANCO: (Whereupon the above-entitled matter went off the record at 1:38 p.m.)
