22 behalf of the licensee. And that is S-I-D-O-N
23 Y-O-H-A-N-N-E-S.

24 CHAIRPERSON ANDERSON: All right. So
25 now, this is the case number, 21-CMP-00076.

1 Mr. Cenci, are there any preliminary matters in
2 that case?

3 MR. CENCI: There are no preliminary
4 matters at this time?

5 CHAIRPERSON ANDERSON: Then, this
6 matter is scheduled for a show-cause hearing on
7 April 27, 2022 at 10:00 a.m. I just want to
8 remind the parties that seven days prior to this
9 hearing, both parties are required to exchange
10 documents and witnesses to each side, and also to
11 the Agency.

12 If this is not done, and unless the
13 cause is shown, the Board might not allow the
14 other side to rely on documents and witnesses
15 that have not been disclosed seven days prior to
16 the hearing. All right?
