3 CHAIRPERSON ANDERSON: Good morning.

4 We're on the record. Good morning again. As
5 chairperson of the Alcoholic Beverage and
6 Cannabis Board for the District of Columbia and
7 in accordance with D.C. Code Section 2-5718.c of
8 the Open Meetings Act, OMA, I'm welcoming you to
9 the regular scheduled meeting of the Alcoholic
10 Beverage and Cannabis Board.

11 This meeting is being conducted
12 pursuant to guidance made available by the
13 District of Columbia's Office of Open Government
14 regarding electronic meetings held by public
15 bodies. Electronic meetings by the ABC Board
16 are authorized pursuant to Section 2-577.a of
17 the D.C. Code. Pursuant to the OMA
18 requirements, notice of today's meeting was
19 provided 48 hours in advance of the meeting on
20 ABCA's website and on the District's central
21 meeting calendar.

23 agenda, and call-in or log-in information for
24 public participation. This electronic meeting

20 CHAIRPERSON ANDERSON: Mr. Ryan Jones.

21 MEMBER JONES: Ryan Jones, present.

22 CHAIRPERSON ANDERSON: The Board has
23 five members in attendance for the conduct of
24 business today, and that constitutes a quorum.
25 Before we get underway with today's hearing

1 calendar, I need to make a few instructions very
2 clear so that the conduct of these hearings is
3 understood by everyone. There are nine cases
4 scheduled for today's calendar.

5 Once your case is called, I will take a
6 moment for IT specialist to elevate the rights
7 for each party to enable their camera and
8 microphone. Then and only then will you have
9 the ability to enable your equipment. If your
10 case has not been heard, you will remain mute
11 and your camera will be disabled.

12 At the conclusion of each case, the
13 parties will have the option to leave. If a
14 party chooses to stay, all cameras and

24 settlement agreement has been provided to the
25 Board for its review and consideration.
