3 CHAIRPERSON ANDERSON: The next case in  
4 our calendar is Case No. 26-PRO-00018, Dirty  
5 Water, License No. 125771. Good morning, Mr.  
6 Orellana. Can you please elevate the rights of  
7 the parties in this case?

8 MR. ORELLANA: Good morning. Luke  
9 Casey, access elevated. And Jeff Giertz, access  
10 elevated. That is all, Chairman.

11 CHAIRPERSON ANDERSON: Thank you.

12 MR. GIERTZ: Good morning. Can you  
13 hear me?

14 CHAIRPERSON ANDERSON: Hold on one  
15 minute, please. Yes. Good morning. Mr. Casey,  
16 can you please spell and state your name for the  
17 record, sir? You're on mute, Mr. Casey.

18 MR. CASEY: I'm sorry. Luke Casey, L-  
19 U-K-E C-A-S-E-Y.

20 CHAIRPERSON ANDERSON: And your right,  
21 sir?

22 MR. CASEY: The owner.

23 CHAIRPERSON ANDERSON: Good morning.  
24 Mr. Giertz, I probably did a horrible job. But  
25 if you'll instruct me, please spell and state

1 your name for the record, sir.

2 MR. GIERTZ: Yeah, no problem. Jeff,  
3 J-E-F-F. Last name is Giertz, G-I-E-R-T-Z. It  
4 was an admirable effort. No problem.

5 (Simultaneous speaking.)

6 MR. GIERTZ: I represent -- I'm the  
7 chair of ANC 6A's Alcoholic Beverage and  
8 Cannabis Committee. I'm representing the ANC.

9 CHAIRPERSON ANDERSON: Good morning,  
10 Mr. Giertz. Good morning. All right. Mr. --

11 MR. CASEY: I think this should be able  
12 to be settled in a settlement agreement. I got  
13 up this morning and everything looks okay. I  
14 just haven't had a chance to send it back over  
15 to you.

16 CHAIRPERSON ANDERSON: All right. Then  
17 Mr. Giertz, go ahead, sir.

18 MR. GIERTZ: Yeah, I just want to  
19 corroborate what Luke said. We've all but  
20 reached a settlement agreement in this matter.  
21 We just have to finish the paperwork and submit  
22 it to ABCA. So we're very close, and I would  
23 not expect to see this matter before the Board  
24 again.

25 CHAIRPERSON ANDERSON: Thank you for

1 the representation. So provide that settlement  
2 agreement to -- the representation is that --  
3 are the parties -- I'm not going to cancel the  
4 hearing because unless you tell me to cancel it.

5 So this matter if not settled is scheduled for  
6 a protest hearing on the 29th at 1:30 p.m.

7 But based on the representation of the  
8 parties, it is not apparent that this matter  
9 will actually go to a protest hearing. But I  
10 like when we have these matters to hear the  
11 parties inform -- instruct the Agency that they  
12 believe that this case is going to be settled.  
13 So thank you and great communication that the  
14 parties have had.

15 And as stated, I will not see you on  
16 the 29th. But just send us the settlement  
17 agreement as soon as possible. All right.  
18 Thank you. Have a great day.
