8	This is a Retailer Class A license			
9	transfer, to transfer from 175 R Street, NE, to			
10	4400 Jenifer Street, NW. That's Jenifer spelled			
11	J-E-N-I-F-E-R.			
12	The protest issues are adverse impact,			
13	peace order and quiet, and residential parking,			
14	and vehicular and pedestrian safety.			
15	My name is LaVerne Fletcher,			
16	conducting the roll call hearing at the Board's			
17	agent. Is anyone present on behalf of the

19	MR. BIANCO: Good morning,			
20	Ms. Fletcher, Richard Bianco. I represent the			
21	applicant in this case.			
22	MS. FLETCHER: Good morning,			
23	Mr. Bianco.			
24	MR. BIANCO: How are you?			
25	MS. FLETCHER: Oh, I'm doing good,			

1 thank you. Would you spell your name for the 2 record, please? 3 MR. BIANCO: Sure. First name is 4 Richard, R-I-C-H-A-R-D. Last name is Bianco, 5 B-I-A-N-C-O. MS. FLETCHER: Thank you. I'll note 6 7 for the record that ANC3E is the protestant in 8 this matter. Although ANC3E is not present 9 today, they're going to be granted standing today 10 because Jonathan Bender -- I'll spell that for 11 the court reporter. That's spelled 12 J-O-N-A-T-H-A-N, Bender, B-E-N-D-E-R. Mr. Bender is the Chair of ANC3E and 13 14 he would have been present today, but he informed 15 ABRA on March 24 of a family emergency that 16 required him to leave immediately. 17 And so, in that case, we will not 18 dismiss ANC3E as a protestant. And based on 19 communication that I received from Mr. Bianco, 20 Mr. Bianco, you're not opposed to that? 21 MR. BIANCO: That's correct. The 22 applicant consents. 23 Okay. Thank you, MS. FLETCHER: 24 Mr. Bianco. ANC3E is granted standing. 25 Mr. Bianco, I'll go ahead and give the dates, and

then I'll provide them to Mr. Bender later. 1 2 MR. BIANCO: Great. 3 MS. FLETCHER: Let's see here. I'11 4 give you the date for the status hearing first. 5 The status hearing is set for May 4, 2022 at 10:30 a.m. The protest hearing is set for 6 June 8, 2022 at 1:30. 7 8 Mr. Bianco, I'm going to go ahead and 9 run some dates by you. And if there's any one 10 that works for you, I'm going to run that by 11 Mr. Bender. If it doesn't work for him, then 12 I'll send out some more dates. 13 MR. BIANCO: That's perfectly fine. 14 MS. FLETCHER: The next available day 15 for mediation is actually Tuesday, April 12. 16 Tuesday April, any time between 9:00 a.m. and 17 1:30. I am available. Could we 18 MR. BIANCO: 19 say 11:30, tentatively? And then, if Mr. Bender 20 needs to change, I can be flexible. 21 MS. FLETCHER: Okay. Right ahead, 22 mediation bound for 11:30 on Tuesday, April 12. And I'll check with Mr. Bender. I'll email him 23 24 and copy you, Mr. Bianco. 25 MR. BIANCO: Great.
