8	the ANC, and the licensee in this case please?
9	MR. ORELLANA: Dean Hunter, your
10	access has been elevated. Sabel Harris, your
11	access has been elevated. Jovan Miller, your
12	access has been elevated. That is all, Chairman.
13	CHAIRPERSON ANDERSON: All right,
14	thank you. All right, Mr. Hunter, do you have a
15	camera you can turn on, sir?
16	MR. HUNTER: I was trying okay,
17	there we go. Sorry about that, I thought I had
18	started it. There we are, how are you, sir?
19	CHAIRPERSON ANDERSON: I see you, good
20	afternoon. All right, so let me have you, can you
21	please identify yourself for the record by
22	spelling, and stating your name please?
23	MR. HUNTER: Dean Hunter, D-E-A-N H-U-
24	N-T-E-R on behalf of the licensee, Red Lounge
25	Hookah Lounge.

1	CHAIRPERSON ANDERSON: Is the licensee
2	joining us this afternoon, sir?
3	MR. HUNTER: No, we're doing a joint
4	motion to continue, we've reached a settlement
5	agreement, the ANC just has to vote on it.
6	CHAIRPERSON ANDERSON: All right, so
7	Ms. Harris, can you please spell, and state your
8	name for the record please?
9	MS. HARRIS: Hi, this is Sabel Harris,
LO	S-A-B as in boy E-L H-A-R-R-I-S, and I represent
1	ANC1B.
L2	CHAIRPERSON ANDERSON: Thank you. Mr.
L3	Miller, can you please identify yourself for the

L7	CHAIRPERSON ANDERSON: And who are
L8	you, sir?
L9	MR. MILLER: Investigator for ABCA.
20	CHAIRPERSON ANDERSON: Thank you, sir,
21	good afternoon. All right, so are there any
22	preliminary matters in this case?
23	MR. HUNTER: Yes, as we stated, the
24	parties have reached a settlement agreement.
25	However, in order for it to take effect, and be

official, the ANC has to vote to approve it. I believe that the ANC has filed a motion to continue, which we consent to. Or, and on the alternative would be for the board to dismiss the matter pending the approval of the ANC.

CHAIRPERSON ANDERSON: Well, if the parties said that there's a settlement agreement, and the agency is basically stating that it needs to be taken to the meeting for it to be approved, then I wouldn't have a problem granting the continuance for that matter. But I'm not going to entertain a continuance if this matter is not settled.

MS. HARRIS: We did reach a settlement agreement, we just don't have our monthly ANC meeting until next Thursday, Mr. Chairman. So, that's why I did request a continuance via email, yesterday, but that wasn't granted.

CHAIRPERSON ANDERSON: I think the issue is that it's my understanding that it wasn't served on the other side. And so, normally when you are filing asking for a continuance, then you can either file a joint motion to say that both parties are requesting a continuance, or if the other side is not included

1 in the motion, then you needed to -- then the 2 other side needs to respond. 3 So, since we were not aware that the 4 licensee was copied on your continuance, or 5 consented to it, so the board was not in a position to grant the motion until we've had an 6 7 opportunity to hear from the licensee. So, since 8 the licensee has now consented to the 9 continuance, I'm making a motion that we continue 10 this matter until April 12th, at 1:30 p.m. to 11 allow the parties to provide the agency with a 12 signed settlement agreement. Is there a second? 13 MEMBER SHORT: Mr. Short, I second. 14 CHAIRPERSON ANDERSON: Mr. Short has 15 seconded the motion, we'll now have a roll call 16 Mr. Short? vote. 17 MEMBER SHORT: Mr. Short, I agree. 18 CHAIRPERSON ANDERSON: Mr. Cato? 19 MEMBER CATO: Bobby Cato, I agree. 20 CHAIRPERSON ANDERSON: Ms. Hensen? MEMBER HANSEN: 21 Agree. 2.2 CHAIRPERSON ANDERSON: Mr. Grandis? 23 MEMBER GRANDIS: Edward Grandis, I 2.4 agree. 25 CHAIRPERSON ANDERSON: And Mr.

Anderson, I agree, the matter passes five, zero, zero. And the board is granting a continuance of this matter until April 12th, 2023 at 1:30 p.m. But it is clear to the board that this is just a placeholder for the ANC to sign off on the settlement agreement, is that correct?

I see you shaking your head miss, but the court reporter is not seeing you shake your head Ms. Harris, and Mr. Hunter?

MS. HARRIS: Yes.

MR. HUNTER: Yeah, we've reached an agreement.

CHAIRPERSON ANDERSON: Everything that we do is transcribed by a court reporter, so that's one of the reasons why I ask people to speak, so the court reporter can capture what's being said. All right, thank you very much everyone. As I said, the board has granted a continuance until -- a short continuance until April 12th, 2023 at 1:30 p.m., and that is with the understanding that the ANC will sign off on the settlement agreement, and that this matter will be withdrawn, okay? All right, thank you. Have a great day.
