3 CHAIRPERSON ANDERSON: Now that we have
4 dispensed with our morning calendar, let us now
5 do our Legal Agenda.

6 The first matter on our Legal Agenda
7 is the review of an Offer in Compromise in Lieu
8 of a Hearing dated March 27, 2024.

9 The Case Number 23-CMP-00105600T,
10 License Number 100515. The Offer in Compromise
11 is as follows.

12 Charge 1, increase interior occupancy
13 without approval, D.C. Official Code Section
14 25762(b)(1).

15 There is a \$2,000 fine payable within
16 30 days or the license shall be suspended
17 indefinitely until the fine has been paid.

18 Charge 2, offered entertainment after
19 approved hours, D.C. Official Code Section
20 25113.01(b)(1).

21 Excuse me, there is a fine of \$250
22 payable within 30 days or the license shall be
23 suspended indefinitely until the fine has been
24 paid.

25 Charge 3, transferred ownership

1 without approval, D.C. Official Code Section
2 25405. For this case there is a warning.

3 I make a motion that the Offer in
4 Compromise be accepted. Is there a second?

5 MEMBER GRANT: Mr. Grant, I second the
6 motion.

7 CHAIRPERSON ANDERSON: Mr. Grant has
8 second the motion, we will have a roll call vote.

19 Village, License Number 122806.

20 The Offer in Compromise for this case,
21 there is one charge, no ABC manager on duty,
22 statutory authority D.C. Code Section 25701.

23 There is a \$250 fine payable within 30
24 days or the license will be suspended
25 indefinitely until the fine has been paid.

1 Is there a second?

16 For Charge 1, increase occupancy without
17 approval, statutory authority D.C. Code Section
18 25762(b)(1).

19 There is a written warning.

20 Charge 2, expansion of this operation
21 into a space not licensed. Statutory authority
22 D.C. Code Section 25762(b)(3).

23 This charge is dismissed.

24 Charge 3, transferred ownership
25 without approval, statutory authority D.C. Code

1 Section 25405.

2 There is a warning issued for this
3 case.

4 Charge 4, no ABC manager, statutory
5 authority D.C. Code Section 25701. There is a
6 \$500 fine payable within 30 days of the Board
7 accepting the Offer in Compromise.

8 If payment is not made within 30 days,
9 the license shall be suspended indefinitely until
10 the fine has been paid.

11 I therefore make a motion that the
12 Offer in Compromise be accepted. Is there a
13 second?
