The Alcoholic Beverage Control Board
met via WebEx videoconference, LaVerne Fletcher,
Board's Agent, presiding.

3 MS. FLETCHER: Okay, so, let's get
4 started.

5 Good morning, everyone. My name is
6 Laverne Fletcher conducting the roll call
7 hearings as the Board's Agent in accordance with
8 the D.C. Open Meetings Act.

9 There are two cases on the calendar
10 today.

11 The first case is Slice and Pie/Lucy,
12 Case number 23-PRO-00033, Big Chief DC, LLC, 2221
13 14th Street, Northwest, License Number ABRA-
14 118631.

15 This is a Retailer Class C CT for a
16 substantial change for an entertainment for live
17 entertainment inside the premises.

18 The protest issues are adverse impact
19 on peace, order, and quiet.

20 My name is Laverne Fletcher conducting
21 the roll call hearing as the Board's Agent.

22 Is anyone present on behalf of the
23 establishment?

24 MS. MANALLE: Hi, good morning, Ms.
25 Fletcher, this is Manalle Mahmoud with Mallios,

1 O'Brien and Sandground, M-A-N-A-L-L-E-M-A-H-M-O-
2 U-D.

3 MS. FLETCHER: Thank you very much,
4 Ms. Mahmoud.

5 Is anyone present on behalf of ANC 1B?

6 MR. LAKATOS: Santiago Lakatos, S-A-N-
7 T-I-A-G-O, Lakatos, L-A-K-A-T-O-S, present on
8 behalf of ANC 1B.

9 MS. FLETCHER: Thank you, Mr. Lakatos.

10 Let me ask you something, are you
11 going to be the designated representative going
12 forward?

13 MR. LAKATOS: Yes, I will be. This is
14 my district.

15 MS. FLETCHER: Can you give me your
16 email address?

17 MR. LAKATOS: Sure, my email address
18 is the number one, the letter B as in boy, 04 at
19 ANC dot D.C. dot G-O-V (1b04@anc.dc.gov).

20 MS. FLETCHER: Thank you very much.
21 That's one B 04 at ANC dot D.C. dot gov
22 (1b04@anc.dc.gov)?

23 MR. LAKATOS: Correct.

24 MS. FLETCHER: And Mr. Lakatos, do you
25 have a telephone number that you can provide me

1 with, please?

2 MR. LAKATOS: One moment, let me send
3 you my -- 202-599-7562.

4 MS. FLETCHER: 202-599-7562?

5 MR. LAKATOS: Correct.

6 MS. FLETCHER: Thank you very much.

7 ANC 1B does have standing as a
8 protestant.

9 We need to set a date for a status
10 hearing, protest hearing, and a mediation.

11 I'll give you the dates for the status
12 and protest hearing first.

13 The status hearing is scheduled for
14 May the 3rd, May 3, 2023 at 10:30 a.m.

15 The protest hearing is set for June
16 28, June 28 at 1:30.

17 I will give you the next available
18 date for mediation.

19 The next available day is Tuesday,
20 April the 18th, anytime between 10:00 a.m. and
21 1:30. That's Tuesday, April 18.

22 MS. MANALLE: Ms. Fletcher, is it okay
23 if we push it out one week? We're hopeful that
24 we can enter into a settlement agreement.

25 MS. FLETCHER: Okay, then, how about,

1 let's see, this hearing is May -- status hearing
2 is May 3. What about the 25th of April?

3 MS. MANALLE: That's great with us if
4 it works with the ANC.

5 MS. FLETCHER: Is that good?

6 MR. LAKATOS: Unfortunately for that
7 time slot, I would not be able to get out of a
8 recurring work conflict at that hour. Is there
9 any other time of day that week that would be
10 possible, Ms. Fletcher?

11 MS. FLETCHER: Yes, we could do it on
12 Wednesday the 26th or any time between 10:00 and
13 1:30 or we could do it on, actually, we could do
14 it on Monday, April 24 at 11:30.

15 So, we can do it that Monday at

16 MR. LAKATOS: Monday would work for me
17 if that is -- works with the Applicant.

18 MS. MANALLE: Absolutely.

19 MS. FLETCHER: Is 11:30 good?

20 MS. MANALLE: That's great.

21 MR. LAKATOS: Yes, perfect, thank you.

22 MS. FLETCHER: Mediation is scheduled
23 for Monday, April 24 at 11:30 a.m.

24 And if it's resolved before then, you
25 can let me know and I'll cancel the mediation.

1 MS. MANALLE: Thank you so much.

2 MS. FLETCHER: I'll send out the WebEx
3 invites.

4 You're very welcome.

5 Okay, the matter of Slice and Pie is
6 concluded.

7 See you soon, maybe.

8 MS. MANALLE: Thank you.

9 MS. FLETCHER: Mr. Lakatos, are you
10 going to be here for the next roll call hearing
11 as well?

12 MR. LAKATOS: Yes, I will.

13 MS. FLETCHER: Okay, so, you're going
14 to stay on the line?

15 MR. LAKATOS: Mm-hmm.

16 MS. FLETCHER: Okay, thank you.
