3	CHAIRPERSON ANDERSON: The next case
4	on our calendar is case number 20-CMP-00017,
5	Churreria Madrid Restaurant, license number
6	60806. Ms. Andrews, can you please elevate the
7	rights of the licensee and the investigator in
8	this case, please?
9	MS. ANDREWS: Sure, stand by.
10	CHAIRPERSON ANDERSON: Thank you.
11	MS. ANDREWS: Mr. Lui, your rights
12	have been elevated. Mr. Ruiz, your rights have
13	been elevated. Mr. Giron, your rights have been
14	elevated. That's all, Mr. Chair.
15	CHAIRPERSON ANDERSON: Thank you. All
16	right, good afternoon, everyone. This is case
17	number 20-CMP-00017, Churreria Madrid Restaurant,
18	license number 60806. Lets have the parties
19	introduce themselves for the record. Lets start
20	with the Government, please.
21	MR. LUI: Good afternoon, Mr.
22	Chairperson. Jon Lui on behalf of the Government
23	or District of Columbia, that's J-O-N L-U-I.
24	CHAIRPERSON ANDERSON: Good afternoon,
25	Mr. Lui. Mr., I'm sorry, sir, I forgot your

The licensee. 1 name. 2 MR. GIRON: Ernesto Giron. 3 CHAIRPERSON ANDERSON: Can you spell your first and last name, sir? 4 MR. GIRON: Sure, first name, E-R-N-E-5 Last name is Giron, G-I-R-O-N. 6 S-T-0. 7 CHAIRPERSON ANDERSON: Good afternoon, 8 Mr. Giron. It appears that you are in a moving 9 vehicle, sir. Is that correct? 10 MR. GIRON: Yes, I'm not driving, I'm 11 the passenger. I was hoping to get over by this 12 time, but I wasn't able. 13 CHAIRPERSON ANDERSON: Well I think 14 by -15 MR. GIRON: And --16 (Simultaneous speaking.) 17 CHAIRPERSON ANDERSON: But part of the 18 problem, sir, is that you're in a moving vehicle 19 and so I'm not quite sure, how much longer will 20 it be before you get to your location, sir? 21 MR. GIRON: It's going to be about 22 eight, 10 minutes. 23 CHAIRPERSON ANDERSON: I would prefer, 24 sir, that we postpone that -- we pause this hearing 25 until you get to your location. Although you've

stated that you are a passenger in a vehicle, I 1 don't believe that it is safe. I mean I think 2 3 part of the problem is that I'm not sure if the 4 internet connection will be, so it's 1:53 p.m. 5 and about what time do you believe that you will get to your location, sir? 6 7 MR. GIRON: Just slightly after 2. 8 CHAIRPERSON ANDERSON: I'm sorry, what 9 did you say, sir? 10 MR. GIRON: Slightly after 2, like 11 2:03, 10 minutes. 12 CHAIRPERSON ANDERSON: All right, so 13 it's 1:53, we're going to go off the record until 14 2:15. So, we'll be off the record until 2:15 and 15 so you can call back in, sir, at 2:15. 16 (Whereupon, the above-entitled matter 17 went off the record at 1:53 p.m. and resumed at 18 2:46 p.m.) 19 CHAIRPERSON ANDERSON: Okay. Let's 20 recall Case #20-CMP-00017, Churreria Madrid 21 Restaurant, License #60806. 22 Ms. Andrews, can you please elevate 23 the right of the Government and also the Licensee 24 in this case, too, please. 25 MS. ANDREWS: Sure. Stand by.

1	CHAIRPERSON ANDERSON: Thank you.
2	MS. ANDREWS: Mr. Lui, you've been
3	elevated.
4	Mr. Ruiz, your rights have been
5	elevated.
6	Mr. Giron have been elevated.
7	That's all, Mr. Chair.
8	CHAIRPERSON ANDERSON: Thank you.
9	All right. Mr. Giron, now I feel safe
10	that we can do this hearing. It's safely back on
11	to me. And so I want to make sure. I would not
12	want to be, although you were a passenger in a
13	vehicle, sir, but I would not want to be on it on
14	our You Tube channel and see something happen in
15	front of our eyes and so that's one of the
16	reasons why I insisted that you're at a
17	stationary position to do this hearing.
18	MR. GIRON: Okay.
19	CHAIRPERSON ANDERSON: All right.
20	Thank you.
21	All right. Mr. Lui, can you identify
22	yourself for the record, please.
23	MR. LUI: Yes. Good afternoon, Mr.
24	Chairperson and board members. My name is John
25	Lui on behalf of the District of Columbia.

1 CHAIRPERSON ANDERSON: Mr. Giron, can 2 you please spell and state your name for the 3 record, please. MR. GIRON: Yes. Ernesto Giron, 4 E-R-N-E-S-T-O last name G-I-R-O-N. 5 CHAIRPERSON ANDERSON: Thank you. 6 And 7 what's your relationship to the establishment? 8 MR. GIRON: I'm the owner, Vice 9 President of the corporation. 10 CHAIRPERSON ANDERSON: Thank you. All 11 right. 12 This is a Show Cause Hearing. Are 13 there any preliminary matters here, Mr. Lui? 14 MR. LUI: No, there are not. 15 CHAIRPERSON ANDERSON: All right. So, 16 is the Government ready to move forward in this 17 case? 18 MR. LUI: yes, Mr. Chairperson. 19 CHAIRPERSON ANDERSON: Mr. Giron, this 20 is a Show Cause Hearing and so basically I'm not 21 sure if you have participated in a Show Cause 22 Hearing before. The Government will -- both 23 sides will provide an opening statement to say 24 what the case is, what interest that they have, 25 what they intend to prove.

1	The Government will call its witness
2	and the Government will question its witness.
3	You will then have an opportunity to
4	cross-examine the witness by the Government.
5	After the Government has rested its case, then
6	you will have an opportunity to call witness. I
7	don't know, are you bringing witnesses, sir, or
8	are the only one who is testifying.
9	MR. GIRON: I'm the only one testifying
10	today.
11	CHAIRPERSON ANDERSON: All right. And
12	so then I will swear you in. You will testify.
13	Mr. Lui will cross-examine you. And the board
14	then will ask questions of you. After you're
15	done I'll ask both sides to make closing
16	arguments and then the case will be over.
17	So, closing arguments basically is
18	that you're saying to the board what it is that
19	you've proven or the Government has proven. The
20	Government will say to us what is it that
21	specifically what it is that they want the board
22	whether or not the Government has met its
23	burden of proof that the violation that you were
24	charged with and you will do your closing and
25	then you'll say that the Government, if that's

your desire, that the Government has not met its 1 2 burden, what is it that your case proves and what 3 it is that you want the case -- what it is that 4 you're asking the agency to do. 5 Do you have any questions you want to ask, sir? 6 7 MR. GIRON: Not at the moment. I'm 8 going to wait for the opening statement. 9 CHAIRPERSON ANDERSON: All right. Okay, fine. 10 11 Okay. So, Mr. Lui, you wish to do an 12 opening statement? 13 MR. LUI: Yes, very briefly. 14 CHAIRPERSON ANDERSON: Yes. 15 MR. LUI: Good afternoon, board 16 members. We are here today in the Show Cause 17 matter of MST Enterprises, Inc., trading as Churreria. 18 19 CHAIRPERSON ANDERSON: Hold on. Mr. 20 Giron, can you put your phone on mute, please, if 21 you have not done so. 22 MR. GIRON: I'm sorry, say it again. 23 CHAIRPERSON ANDERSON: Can your mute 24 your microphone, please. 25 MR. GIRON: Okay.

1	CHAIRPERSON ANDERSON: Yes, that's
2	where the background was coming from.
3	Go ahead, Mr. Lui.
4	MR. LUI: We are here today in the Show
5	Cause matter of MST Enterprises, Inc., trading as
6	Churreria Madrid Restaurant located at 2505
7	Champlain Street, Northwest.
8	The Show Cause notice issued in this
9	matter concerns the sole charge that the Licensee
10	provided live entertainment in the form of a disc
11	jockey without an entertainment endorsement in
12	violation of D.C. Code Section 25-113AB1.
13	The evidence will show that on
14	Wednesday, January 1st, 2020, at approximately
15	2:55 a.m. Alcoholic Beverage Regulation
16	Administration, investigators Mark Ruiz and
17	Anthony Delosantos were monitoring and heard
18	amplified music emanating from the establishment.
19	The investigators entered and observed a disc
20	jockey providing live entertainment by
21	manipulating a turntable in mixing music.
22	Ernesto Giron, the owner, provided the
23	establishment's ABC License to Investigator Ruiz
24	that showed that it lacked an entertainment
25	endorsement.

1	That's it.
2	CHAIRPERSON ANDERSON: Thank you.
3	Mr. Giron, do you wish to make an
4	opening statement now or you can make it when you
5	present your case? You need to unmute your
6	phone, sir.
7	MR. GIRON: I can make a statement.
8	CHAIRPERSON ANDERSON: Yes, sir, go
9	ahead.
10	MR. GIRON: Yes. I do not dispute that
11	we had a DJ that one night. Unfortunately, the
12	reason why the investigator came into the
13	restaurant is not it's omitted from the report
14	and that's what I'm going to show why he actually
15	came into a restaurant on New Year's Eve.
16	CHAIRPERSON ANDERSON: Let me ask a
17	question. Is there agreement okay. The
18	charge in this case hold on, what is the
19	charge?
20	The charge in this case is to provide
21	Entertainment Without an Entertainment
22	Endorsement. That's the charge, is that correct?
23	MR. GIRON: Yes.
24	CHAIRPERSON ANDERSON: And so, Mr.
25	Giron, are you stating that that is correct?

1 MR. GIRON: Yes. 2 CHAIRPERSON ANDERSON: You don't have 3 to say that, you can say no. what I'm trying to say if you're saying that it's true and then you 4 5 have an explanation -- and then you have explanation then we just argue about explanation 6 7 and then you could say that -- that I shouldn't 8 be punished for this so whatever we can make the 9 argument. But are you disputing that it wasn't 10 that you provided entertainment without an entertainment endorsement. And that's what I'm 11 12 just asking. If you are disputing that then we 13 can go -- we can go to the hearing. But if 14 you're say that, yes, that's correct, but I have 15 an explanation then we can agree that, yes, the 16 charge is correct and then you try to explain it 17 So, that's what -- I'm not trying to away. 18 influence on it. I'm just trying to get some 19 clarification. 20 MR. GIRON: Yes. I'm not disputing 21 that we had a disc jockey that one night, no. 22 CHAIRPERSON ANDERSON: All right. 23 Okay. 24 So, if the parties agree then -- well, 25 I'm not sure in this particular case. You know

what, let me -- let me have you do your case, Mr. 1 2 Lui, because I think that although Mr. Giron is 3 saying that he's not disputing it I think he has 4 a different explanation about why the 5 investigator was there. So, let's -- okay. So, I'll have you -- I'll have you --6 7 Mr. Giron, you always have to put 8 your phone on mute. And you have to remember to 9 unmute yourself. There's some feedback, that's 10 why I always remind you. And my screen tells me 11 who is speaking and whose phone, whose phone is 12 unmuted. 13 All right. So, I'll have you present 14 your case, Mr. Liu, and then we just make a 15 decision. Do you have a witness you wish to 16 call? 17 MR. LUI: Yes, Mr. Chairperson, thank The Government would like to call 18 you. 19 Investigator Mark Ruiz. 20 CHAIRPERSON ANDERSON: Mr. Ruiz, can 21 you raise your right hand, please. 22 Do you swear or affirm to tell the 23 truth and nothing but the truth? 24 INVESTIGATOR RUIZ: I do. 25 CHAIRPERSON ANDERSON: Thank you. Your

witness, Mr. Lui. 1 2 MR. LUI: Thank you. 3 DIRECT EXAMINATION 4 MR. LUI: Could you please state and spell your first and last name for the record? 5 INVESTIGATOR RUIZ: Yes. First name is 6 7 Mark, M-A-R-K last name is Ruiz, R-U-I-Z. 8 MR. LUI: Mr. Ruiz, where are you currently employed? 9 INVESTIGATOR RUIZ: Alcoholic Beverage 10 11 Regulation Administration. 12 MR. LUI: And what is your position at 13 the Alcoholic Beverage Regulation Administration? 14 INVESTIGATOR RUIZ: Investigator. 15 MR. LUI: And how long have you been an 16 investigator? 17 INVESTIGATOR RUIZ: Just over two years 18 now. MR. LUI: And what are your duties and 19 20 responsibilities as an investigator? 21 INVESTIGATOR RUIZ: To inspect and 22 investigate ABRA licensed establishments in the 23 District of Columbia. 24 MR. LUI: Are you familiar with 25 Churreria Madrid Restaurant?

INVESTIGATOR RUIZ: I am.
MR. LUI: How are you familiar with
this establishment?
INVESTIGATOR RUIZ: I visited it for
inspections on numerous occasions.
MR. LUI: Focusing on what happened on
January 1st, 2020. What happened that evening?
INVESTIGATOR RUIZ: On that evening
while I'm monitoring establishments within the
city visited Churreria Madrid during that evening
after observing loud music.
MR. LUI: And what happened after that
after you heard the loud music?
INVESTIGATOR RUIZ: I entered the
establishment, made my way up the steps and
located the source of the music which was a DJ.
MR. LUI: And were you accompanied by
another investigator?
INVESTIGATOR RUIZ: Yes.
MR. LUI: And who?
INVESTIGATOR RUIZ: Investigator
Delosantos and Investigator Platos and Quente
were present as well. We were walking together.
MR. LUI: And what happened after you
walked up the steps?

INVESTIGATOR RUIZ: Noticed the DJ and 1 2 then verified whether they had an entertainment 3 endorsement. 4 MR. LUI: Could you describe the DJ? The DJ which was located in 5 MR. RUIZ: the front, the second level, front of the 6 7 establishment by the window equipped with a 8 laptop and mixing board. Was actively mixing 9 these playing music. 10 MR. LUI: Well, what happened after you 11 observed the disc jockey manipulating music and 12 the turntable? INVESTIGATOR RUIZ: I verified the 13 14 license again for the entertainment endorsement, 15 discovered that there was no entertainment endorsement attached to the license for that 16 17 evening. 18 MR. LUI: Okay. And who provided you 19 the ABC license? 20 INVESTIGATOR RUIZ: The owner, Mr. 21 Giron. 22 MR. LUI: I'm going to show you a 23 document marked as Government 1 for 24 identification. 25 (Whereupon, the above-referred to

1	document was marked as Government Exhibit 1 for
2	identification.)
3	MR. LUI: Ms. Andrews if you can
4	elevate my rights to share a document.
5	MS. ANDREWS: Sure. Stay on the line.
6	MR. LUI: Thank you.
7	MS. ANDREWS: Okay, Mr. Lui, it is now.
8	MR. LUI: Thank you. Investigator
9	Ruiz, could you identify this document?
10	INVESTIGATOR RUIZ: Yes. That is the
11	case report that I drafted for this case.
12	MR. LUI: What is the case number?
13	INVESTIGATOR RUIZ: 20-CMP-00017.
14	MR. LUI: All right. And what is the
15	when is the date of occurrence?
16	INVESTIGATOR RUIZ: January 1st, 2020.
17	MR. LUI: And did you sign t his
18	report?
19	INVESTIGATOR RUIZ: I did.
20	MR. LUI: And you drafted this report?
21	INVESTIGATOR RUIZ: Yes.
22	MR. LUI: And this is a fair and
23	accurate representation of the case report that
24	you drafted and prepared Case Number 20-CMP-0017
25	for the incident occurring on January 1st, 2020?

1	INVESTIGATOR RUIZ: Yes.
2	MR. LUI: Mr. Chairperson, at this time
3	the Government would like to move Government
4	Exhibit 1 into evidence.
5	CHAIRPERSON ANDERSON: It's so moved
6	but you don't have to necessarily move it into
7	evidence, Mr. Lui. It's operated by statute, it
8	is a part of the evidence it's a part of the
9	record but it's so moved.
10	MR. LUI: Thank you, Mr. Chairperson.
11	Investigator Ruiz, just directing your
12	attention to Exhibit 1 of the case report, can
13	you see this document?
14	INVESTIGATOR RUIZ: Yes.
15	MR. LUI: What is it?
16	INVESTIGATOR RUIZ: This is a photo of
17	the DJ actively mixing music.
18	MR. LUI: What else appears in this
19	picture?
20	INVESTIGATOR RUIZ: A laptop and a DJ
21	mixing board.
22	MR. LUI: I'm directing your attention
23	toit's blurry but Exhibit 4 of the case
24	report. What is this document?
25	INVESTIGATOR RUIZ: That is a photo of

the alcohol license. 1 MR. LUI: What is observed -- what can 2 3 you observe on the ABC license? 4 INVESTIGATOR RUIZ: The name of the 5 establishment, the license number as well as endorsements which only allows them the holiday 6 7 extension. 8 MR. LUI: What is lacking from the 9 license? INVESTIGATOR RUIZ: An entertainment 10 11 endorsement. 12 MR. LUI: I have no further questions 13 for this witness, Mr. Chairperson. Thank you. 14 CHAIRPERSON ANDERSON: Thank you. 15 Mr. Giron, do you have any questions 16 for Mr. Ruiz? 17 MR. GIRON: I do. I have two 18 questions. 19 CHAIRPERSON ANDERSON: Well, ask him, sir. 20 21 CROSS-EXAMINATION 22 MR. GIRON: Okay. Mr. Ruiz, when you 23 came into the restaurant did you remember what 24 you were actually asking about when you came in 25 and you started saying about how we were in

violation --

3	INVESTIGATOR RUIZ: I don't recall.
4	MR. GIRON: And then do you remember
5	when the other investigator the female
6	investigator showed up and told you that we had
7	the endorsement to be on the extended hours and I
8	was trying to explain that to you and you needed
9	proof and I forgot that it was on the license
10	until she showed you. Do you remember that?
11	INVESTIGATOR RUIZ: I do now, yes.
12	MR. GIRON: Yes. That was the reason
13	(Simultaneous speaking.)
14	INVESTIGATOR RUIZ: the extension
15	and you have it on your license.
16	MR. GIRON: Yes. The reason why you
17	came in that day, do you remember it was because
18	you thought we were in violation of the hours.
19	INVESTIGATOR RUIZ: That's correct.
20	MR. GIRON: Yes.
21	INVESTIGATOR RUIZ: That was part of
22	the reason as well, yes.
23	MR. GIRON: That was the main reason.
24	And that's it. That's it. That's all I got.
25	CHAIRPERSON ANDERSON: Do you have any
I	

1 other questions, sir? 2 MR. GIRON: No. 3 CHAIRPERSON ANDERSON: Let me, Mr. Ruiz, as an investigator when you were -- what 4 5 were you looking for when -- when you go out what is it that you look for when you go to -- I mean, 6 7 what was the purpose of going out there? 8 INVESTIGATOR RUIZ: Well, that night 9 was New Year's Eve holiday, New Year's Day. So, we were monitoring ABRA establishments and 10 11 insuring that (1) they were following the holiday 12 extension -- they had a holiday extension and 13 were following the regulations for that evening 14 as well as capacities of the restaurants as well. 15 CHAIRPERSON ANDERSON: I'm sorry. 16 Specifically, when you go out, when you were out that night what were you looking for when you 17 visited different establishments? Tell me what 18 19 is it you're looking for as part of your -- as 20 part of your duties that night? 21 INVESTIGATOR RUIZ: That they're 22 operating according to the law. That they have 23 an ABRA manager on duty. They are operating 24 within their license hours as well as having 25 proper endorsements for live entertainment as

1 well as a cover charge. 2 CHAIRPERSON ANDERSON: Any other 3 questions by the board members? 4 Mr. Giron, any questions of Mr. Ruiz based on the questions that I asked? 5 MR. GIRON: No, sir. 6 7 Mr. Lui, CHAIRPERSON ANDERSON: No. 8 any questions of Mr. -- and follow-up questions 9 of Mr. Ruiz? 10 MR. LUI: No, Mr. Chairperson. Thank 11 you. 12 CHAIRPERSON ANDERSON: All right. Mr. 13 Ruiz, thank you very much for your testimony. 14 You can -- you are released. 15 Mr. Lui, do you have another witness? 16 MR. LUI: No, Mr. Chairperson. 17 CHAIRPERSON ANDERSON: Do you rest? 18 MR. LUI: Yes. The Government rests. 19 CHAIRPERSON ANDERSON: All right. Thanks. 20 21 Mr. Giron, can you raise your right 22 hand, please. 23 Do you swear or affirm that -- move 24 your hand up. 25 Do you swear or affirm to tell the

truth and nothing but the truth? 1 2 MR. GIRON: Yes, I do. 3 CHAIRPERSON ANDERSON: All right. Go 4 ahead, sir. 5 MR. GIRON: Okay, the statement, is that what --6 7 CHAIRPERSON ANDERSON: I'm sorry, say 8 what, sir? 9 MR. GIRON: I don't know. Is John Lui 10 going to ask me questions or --11 CHAIRPERSON ANDERSON: No. You are --12 you are to explain your case, sir. But you're 13 now putting your case on so since I swear you in, 14 you tell me your position, what happened that 15 night and then once you're done Mr. Lui will ask 16 you questions on cross-examination. I will ask 17 question on cross and then the board might ask 18 questions of you. But, just remember once you 19 state your position then Mr. Lui is going to 20 cross-examine you, sir. Okay. Go ahead. 21 MR. GIRON: Yes. That one night it was 22 New Year's Eve. We had just a few people. It 23 wasn't a packed house at all. And we decided to 24 have a DJ just to bring more people hopefully, 25 you know, to spend money. Then around, right

before 3:00 a.m., like 2:55 the investigator came 1 2 in and he came in running, started explaining me, 3 you are in violation, you're in violation. You still serving drinks. It's almost 3:00 a.m. 4 And 5 he ran upstairs and he went down. His other partner came in and he told them, take photos 6 7 It's almost 3:00 because they're in violation. 8 they should be closed. And I told him, look, we 9 have an extension for the extended hours. We 10 have endorsement. He said, show me proof. And I 11 didn't even know that it was written on the -- I 12 license itself. Because the year before we had a 13 letter that was proof ABRA sent a letter to all 14 the businesses were in the extended hour program. 15 And I didn't have that letter anymore and he 16 said, well, you can't prove it to me I'm going to write you up and, you know, that you are in 17 18 violation of your hours. And I kept telling him, 19 look, we are part of the extended hours program. 20 And he wouldn't have it. 21 Then a female investigator came in and 22 she asked him what's going on and he explained to her, they're in violation. They're still serving 23

drinks, they should be closed. And she said,

show me the license. And I showed her the

license and she pointed out they have -- they can 1 2 be open until 4:00 because they're part of the 3 extended program, extended hours program. And 4 she left. That was all she said. She was like, 5 let's go. And he just stood there. I guess he was embarrassed and he was just looking - - and, 6 7 yes, I had a DJ, I know I shouldn't have. Ι 8 didn't know that I could apply for an extension 9 for one day. But we never had a DJ and I 10 thought, it's New Year's and I need money, 11 probably going to, you know, bring more people 12 like that. And he went upstairs and he took 13 photos and he said I'm going to write you up for 14 the DJ since I can't write you up for the 15 extended hours. And that's it. And he did. 16 CHAIRPERSON ANDERSON: Is there 17 anything else you want to say? 18 MR. GIRON: No, that was it. 19 CHAIRPERSON ANDERSON: All right. Mr. 20 Lui, do you have any questions of Mr. Giron? 21 MR. LUI: Yes, just a few. 22 CROSS-EXAMINATION 23 MR. LUI: Mr. Giron, how long have you 24 been a business owner or how long have you owned 25 Churreria Madrid?

MR. GIRON: Almost 15 years. 1 2 MR. LUI: And are you familiar with the 3 ABC laws and regulations? MR. GIRON: Yes, some, yes. Not all of 4 5 them. MR. LUI: And are you familiar about 6 7 with how to apply for endorsements? 8 MR. GIRON: Yes, I applied for the 9 extended hour endorsement myself. MR. LUI: What about the entertainment 10 11 endorsement? 12 MR. GIRON: I did apply for it but the 13 ANC in my area voted against it because they 14 didn't want -- they thought that it was going to 15 bring criminals to the area. So, they voted 16 against us getting the entertainment endorsement. 17 MR. LUI: Okay. And on the evening of 18 January 1st, 2020, you didn't have an entertainment endorsement, did you? 19 20 MR. GIRON: No, I didn't. 21 MR. LUI: I have no further questions, 22 Mr. Giron, thank you. REDIRECT EXAMINATION 23 24 CHAIRPERSON ANDERSON: Let me ask you 25 a question, Mr. Giron.

In your mind what is an entertainment 1 2 endorsement? Why did you apply for an 3 entertainment endorsement before? MR. GIRON: Well, because we were 4 5 planning on having a band play and I was told that I needed to have the endorsement because it 6 7 was a pretty popular band in the area local and 8 it was going to bring a lot of people from 9 Honduras. And they told me that I had to have 10 one because it was going to be probably too many 11 people. And I apply and it was -- it was denied. 12 And then on the day of the hearing I was told by 13 one of the investigators that was there like if I 14 wanted to have probably like a computer playing 15 that was going to be okay hooked up on the 16 bluetooth. And that was it, I mean, that one day 17 out of the whole year we had a DJ. 18 CHAIRPERSON ANDERSON: I'm sorry, you 19 had what? 20 MR. GIRON: After the, you know, we 21 were denied the endorsement. 22 CHAIRPERSON ANDERSON: Right. 23 MR. GIRON: One day I decided to have 24 a DJ and that was it. 25 CHAIRPERSON ANDERSON: So, were you

aware that if you have a DJ you need to have an 1 entertainment endorsement? 2 3 MR. GIRON: Yes, I was and I am. CHAIRPERSON ANDERSON: So, okay. 4 If 5 you apply you can have a band. You applied for an entertainment endorsement and it was denied. 6 7 But then you decide to have a DJ and knowing that 8 you need to have an entertainment endorsement you 9 still had a DJ. 10 MR. GIRON: Right, yeah. When I apply 11 it was - forget the year, but it was -- it was 12 about one or two years before the incident when I 13 apply for the endorsement. And I didn't have a 14 band. I didn't have no DJ or live entertainment 15 at all throughout that one -- throughout that 16 whole time until that one day. One day and it 17 was New Year's Eve. 18 CHAIRPERSON ANDERSON: So, this 19 happened in January of 2020, so have you applied 20 to the agency to have a entertainment 21 endorsement? 22 MR. GIRON: No, I haven't. And at this 23 point I probably won't because the ANC in the 24 area wants to have a neighborhood agreement. But 25 if I have the neighborhood agreement I cannot be

part of the extended hours program. And we kind
of like doing the extended when we were able to.
So, that's why we decided not to.

And plus anyway right now we do everything on bluetooth. We put a, you know, an application and we just play music. We have a sound system for that. So, there is no DJ needed now.

9 CHAIRPERSON ANDERSON: Okay. I'm not 10 -- I'm not -- it's not my job to give legal advice but I would suggest that you come in --11 12 you have a conversation with the agency about vour activities. I don't know whether or not 13 14 it's legal or not, just to make sure that you are 15 complying with the law based on the understanding 16 that you talk to the agency about your business 17 model to make sure that you're in compliance with 18 the law, sir, that's all I'm saying. Okay. 19 That's all I'm saying.

Based on what you just presented I would hope that you come into the agency and talk to them about what it is that you're doing and what is the best to comply with the law.

All right. Any questions by any ofthe board members?

19	give you an opportunity to close and then you can
20	tell us what you want us to do. But you're still
21	testifying so I'm just saying based on the
22	questions that was asked did you have anything
23	else you want to clarify? Is there anything that
24	you want to say because we wrap us your case
25	because Mr. Lui is going to wrap up his case and

2	MR. GIRON: Okay. Yes, just that, you
3	know, I'll wait for the closing statement, that's
4	fine.
5	CHAIRPERSON ANDERSON: Okay, fine. So,
6	you rest now.
7	Mr. Lui, do you wish to make a
8	closing?
9	MR. LUI: Yes, briefly.
10	CHAIRPERSON ANDERSON: All right.
11	MR. LUI: The Government has proven by
12	a preponderance of the evidence that Licensee
13	provided entertainment in the form of a disc
14	jockey without the proper endorsement.
15	We heard from Investigator Ruiz that
16	on Wednesday, January 1st, 2020, at approximately
17	2:55 a.m. who was monitoring and hear amplified
18	music emanating from the establishment.
19	Investigator Ruiz entered and observed the disc
20	jockey providing live entertainment by
21	manipulating a turntable and mixing music.
22	Ernesto Giron, the owner, provided the
23	establishment's ABC license to Investigator Ruiz
24	that showed that it lacked an entertainment
25	endorsement.

1	We also heard from Mr. Giron who
2	admitted that a disc jockey was present that
3	evening providing entertainment, that the
4	establishment still does not have an
5	entertainment endorsement.
6	The Government has therefore proven
7	this charge and the Notice to Show Cause and the
8	Government recommends that the board apply a
9	penalty consistent with DC Code Section 25-830.
10	Thank you.
11	CHAIRPERSON ANDERSON: Thank you, Mr.
12	Lui.
13	Mr. Giron, now you can wrap up your
14	case and now you can tell me tell the board
15	what it is you want the board to do, sir.
16	MR. GIRON: Yes, thank you.
17	Just the case to me is the way that
18	the investigators approached the whole situation
19	was wrong and the way that they omitted all the
20	information from the report only what was
21	convenient to them, it's wrong as well.
22	The DJ was there one day, one night
23	for New Year's Eve. The investigators they just
24	didn't want to they didn't approach the whole
25	situation properly. And I think that if I should

I

be punished for having a DJ one day out of the 1 2 whole years, probably two years from the moment 3 that I apply for an endorsement license and was 4 denied for one year -- for one day, I'm sorry. Ι 5 don't know, I think I should get a warning 6 because it has never happened after that. When 7 he showed up a couple of days later to 8 investigate there was no music. There was no DJ, 9 there was nothing there. And he -- it's in the 10 record as well on his report that he showed up 11 and he just told me that to sign it and that's 12 That's all I got to say. it. 13 CHAIRPERSON ANDERSON: All right. 14 Thank you, sir. 15 The record is now closed. Do the 16 parties wish to file Proposed Findings of Fact 17 and Conclusions of Law waive their right to do 18 so? 19 So, your purpose, Mr. Giron, do you just want the board to make a determination on 20 21 the evidence that was presented today? 22 MR. GIRON: Yes. 23 CHAIRPERSON ANDERSON: All right. Mr. 24 Lui. 25 MR. GIRON: The Government waives.


